# REVISED BUDGET ESTIMATES OF THE INTERNATIONAL TRIBUNAL FOR THE LAW OF THE SEA FOR 1996-1997

#### Prepared by the Tribunal

- 1. The Meeting of States Parties, at its Fourth Meeting, by its decision of 8 March 1996, approved and appropriated the amount of \$6,170,900 for the International Tribunal for the Law of the Sea for the period from 1 August 1996 to 31 December 1997 (SPLOS/L.1).
- 2. The present report contains the budget performance report for the period from 1 August 1996 to 31 December 1997. Details are provided in annex I to the present estimates and show total expenditures and obligations in the amount of \$6,527,764, exceeding the appropriation mentioned in paragraph 1 above by \$356,864.
- 3. The budget appropriations for 1996-1997 included a contingency for expenses in connection with a case that might be submitted to the Tribunal in 1997. Subsequently, the Meeting of States Parties at its Seventh Meeting, on 23 May 1997, recorded its approval of the utilization of the contingency fund for expenses related to convening and holding a fourth session of the Tribunal in October 1997 (SPLOS/L.7, para. 2).
- 4. The expenses of the fourth session of the Tribunal are reflected in note 1 of annex II to the present estimates.
- 5. On 13 November 1997, a case was submitted under article 292 of the Convention and the Tribunal was urgently convened, in accordance with its Statute and Rules. As required of it, the Tribunal immediately fixed a hearing. Deliberations had to be commenced and the case concluded within a period of three weeks from the date of submission of the application. This meant that the case had to be concluded in 1997. The expenses and obligations of the case (Case No. 1) are reflected in note 2 to annex II.

- 6. No financial appropriation or reserve was available in 1997 to meet the costs incurred for the above case. Consequently the expenditures and obligations in respect of the Fourth Session, Case No. 1, and other costs exceeded the approved appropriations in the sum of \$356,864.
- 7. The action proposed is the approval of the revised estimates and the appropriation of the additional sum of \$356,864 for the budget of the International Tribunal for the Law of the Sea for 1996-1997.
