Agenda item 128**Financing of the United Nations Operation in Somalia****Report of the Secretary-General***Summary*

The United Nations Operation in Somalia (UNOSOM) was established by the Security Council by its resolution 751 (1992) of 24 April 1992. By its resolution 954 (1994) of 4 November 1994, the Council extended the mandate of the Operation for a final period until 31 March 1995. The present report provides updated information on the disposition of the assets of UNOSOM contained in the report of the Secretary-General of 17 July 1995 (A/49/563/Add.4). The adjusted inventory value of the Operation's assets as at 11 May 1995 amounted to some \$132.7 million. The disposition of assets has been guided by the principles endorsed by the General Assembly in section VII of its resolution 49/233 A of 23 December 1994. The action to be taken by the General Assembly, as set out in paragraph 10, is to take note of the report on the disposition of the assets of UNOSOM and to approve, as a matter of principle, the donation of assets to the Somali district councils, as indicated in annex IV to the present report.

I. Introduction

1. The United Nations Operation in Somalia (UNOSOM) was established by the Security Council by its resolution 751 (1992) of 24 April 1992. By its resolution 954 (1994) of 4 November 1994, the Council extended the mandate of the Operation for a final period until 31 March 1995.
2. Initial proposals for the disposition of UNOSOM property were submitted to the General Assembly in the Secretary-General's report of 17 July 1995 (A/49/563/Add.4, annexes IV, V and VI). The present report provides updated information on the subject.

II. Classification and disposition of the assets of the United Nations Operation in Somalia

3. The disposition of the assets of peacekeeping operations is guided by the proposals of the Secretary-General contained in his report of 25 May 1994 (A/48/945 and Corr.1, para. 110) and the recommendations of the Advisory Committee on Administrative and Budgetary Questions in its report of 18 November 1994 (A/49/664 and Add.1). Those proposals were endorsed by the General Assembly in section VII of its resolution 49/233 A of 23 December 1994 as follows:

(a) Equipment in good condition that conforms to established standardization or is considered compatible with existing equipment will be redeployed to other United Nations operations elsewhere in the world or will be placed in reserve to form the start-up kits for use by future missions;

(b) Equipment not required by other peacekeeping missions but which may be useful for operations of other United Nations agencies, international organizations or non-governmental organizations and which it is not feasible to keep in reserve will be sold to relevant agencies or organizations;

(c) Any equipment or property not required or which it is not feasible to dispose of in the above manner or which is in poor condition will be subject to commercial disposal within the country, following standard United Nations regulations and procedures;

(d) Any surplus mission assets remaining after disposition under the terms referred to under paragraphs (a) to (c) above, and/or any assets which, if dismantled, would in fact set back the rehabilitation process of the country, will be contributed to the duly recognized Government of the respective country. This refers in particular to airfield installations and equipment, bridges and mine-clearing equipment. All efforts should be made to obtain from the Government its agreement to compensate the United Nations in a mutually acceptable form (contributions, services, tax exemption, etc.) for the residual value of any surplus mission assets installed in the country that could not be otherwise disposed of. The General Assembly should, as a matter of principle, be requested to approve any such disposition of mission assets that would provide for free-of-charge contribution to the Government.

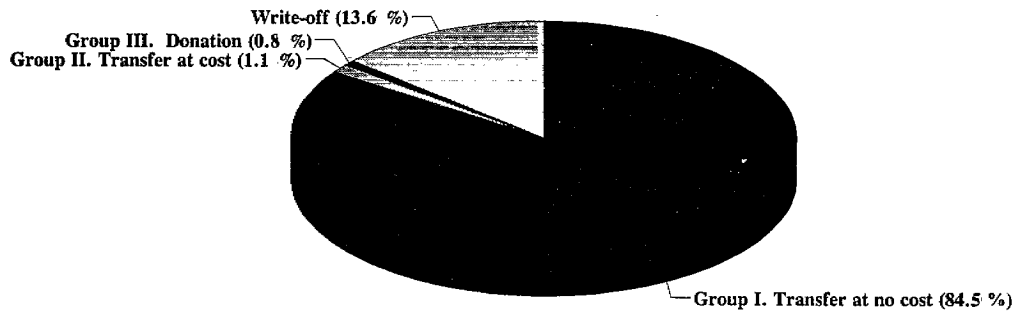


Figure 2. Distribution of assets by equipment category

4. The inventory value of all UNOSOM assets as at 11 May 1995, as indicated in the preliminary report on the disposition of the Operation's assets contained in the report of the Secretary-General of 17 July 1995 (A/49/563/Add.4), was estimated at approximately \$132.4 million. Upon verification and reconciliation of the UNOSOM property records and original purchase prices, the total value of the Operation's property shown in annex I to the present report, column 15, has been adjusted to \$132.7 million. The variations in the original asset values shown in column 17 of annex I are attributable to the reconciliation adjustments

and corrections due to the reclassification of assets for the purpose of their placement under the appropriate equipment category. Charts showing the distribution of the assets of UNOSOM by disposal action and equipment category are presented in figures 1 and 2, respectively, of annex VI to the present report.

5. In accordance with the previous report (A/49/563/Add.4), the Operation's assets have been placed into 12 general categories covering accommodation, air support and communications equipment, containers, defence stores, electronic data-processing equipment, fuel and water supply equipment, generators, hospital equipment, office equipment, prefabricated buildings and transportation and vehicular equipment.

6. In accordance with principles recalled in paragraph 3 above, the assets of UNOSOM have been classified into three groups, as shown in summarized form in annex I and described in detail in annexes II to IV:

(a) Group I shown in annex II, with an inventory value of \$112.1 million (84.5 per cent of all assets), comprises assets transferred, at no cost, to the United Nations peacekeeping operations, the United Nations Logistics Base at Brindisi, Italy, or to activities financed under the United Nations regular budget;

(b) Group II shown in annex III includes assets valued at \$1.5 million (1.1 per cent of the UNOSOM total asset value), which were transferred at cost to the United Nations agencies and programmes and to the Somali police and justice programme funded from the Trust Fund for Somalia;

(c) Group III presented in annex IV, with an inventory value of \$1.1 million (0.8 per cent), consists of equipment vital for the support of local communities (accommodation structures and generators), which was donated to the Somali district councils certified by UNOSOM.

7. Owing to the prevailing security situation in Somalia at the time of the withdrawal of UNOSOM, no assets were disposed of commercially. Information on the UNOSOM assets with an inventory value of \$18 million (13.6 per cent of the total assets value), which were written off owing to normal wear and tear, theft, abandoned because of acts of war and hostilities or lost (accidents, assets unaccounted for) is provided in annex V.

8. Based on the observation made by the Advisory Committee on Administrative and Budgetary Questions in paragraph 18 of its report of 7 April 1997 (A/51/861) on the financing of the United Nations Mission in Haiti (UNMIH) that the final disposition of assets should be reported by classifying assets in the same categories and in the same detail as when they were budgeted and approved, the present report provides, to the extent possible, the itemized information on the equipment procured for UNOSOM since its inception.

9. In accordance with the methodology for the accounting of assets set out in the report of the Secretary-General on the management of peacekeeping assets of 29 May 1996 (A/50/965), assets transferred to other peacekeeping operations, the United Nations Logistics Base and to activities financed under the United Nations regular budget are stated at their original values (see annex II). UNOSOM property transferred to the United Nations agencies and programmes that are not funded from assessed contributions (annex III) and assets donated and written off (annexes IV and V, respectively) are stated both at the original and depreciated values.

III. Action to be taken by the General Assembly at its fifty-second session

10. The action to be taken by the General Assembly at its fifty-second session is to take note of the report on the final disposition of the assets of UNOSOM and to approve donation of assets to the Somali district councils.

Figure 1. Distribution of assets by disposal action
