## INTRODUCTION

1. The present index to information circulars lists in alphanumeric order by symbol, together with date and subject matter, all circulars at United Nations Headquarters that have been issued since November 1996. The index is issued annually.\*

(b) Information circulars, by alphanumeric symbol, issued in 1997;

(c) Information circulars listed according to subject matter.

3. This index should be read in conjunction with the index to the administrative issuances (ST/IC/1998/1), which contains issuances issued under the ST/SGB/- series and the ST/AI/- series.

4. Copies of the index are available through official distribution. The index is also archived in the optical disk system.
