SECURITY COUNCIL COMMITTEE ESTABLISHED PURSUANT TO RESOLUTION 864 (1993) CONCERNING THE SITUATION IN ANGOLA

NOTE VERBALE DATED 22 JULY 1998 FROM THE PERMANENT MISSION OF SWEDEN TO THE UNITED NATIONS ADDRESSED TO THE CHAIRMAN OF THE COMMITTEE

The Permanent Mission of Sweden to the United Nations presents its compliments to the Chairman of the Security Council Committee established pursuant to resolution 864 (1993) concerning the situation in Angola and has the honour to inform the Chairman of the measures that Swedish authorities have taken with regard to paragraphs 11 and 12 of resolution 1173 (1998), as requested by paragraph 4 of resolution 1176 (1998).

Report pursuant to United Nations Security Council Resolution 1173 (1998) with regard to certain measures against Angola/UNITA:

The European Union has adopted a Common Position on restrictive measures against the União Nacional para a Independência Total de Angola (UNITA) (98/425/CFSP of 3 July 1998). This Position includes i.a. restrictive measures in accordance with Security Council resolution 1173 (1998), as indicated below:

<u>Paragraph 11 of Security Council resolution 1173</u> (freezing of funds and financial resources attributable to UNITA and its senior officials or adult members of their immediate families).

<u>Paragraph 12 (b) of Security Council resolution 1173</u> (prohibition of import of diamonds which are not accompanied by a certificate of origin of the Government of Unity and National Reconciliation).

<u>Paragraph 12 (c) of Security Council resolution 1173</u> (prohibition of sale or supply of equipment used in mining or mining services to persons or entities in areas of Angola to which State administration has not been extended).

The Common Position will be implemented through a European Union Regulation concerning the restrictive measures against the União Nacional para a Independência Total de Angola (UNITA). This Regulation will be binding in its entirety and directly applicable in Sweden.

Paragraph 12 (a) of Security Council resolution 1173 (prohibition of official contacts with UNITA leadership in areas of Angola to which State administration has not been extended except for those by representatives of the Government of Unity and National Reconciliation, of the United Nations and of the Observer States to the Lusaka Protocol):

National implementation:

Swedish governmental authorities will be notified of the prohibition of official contacts with UNITA leadership as indicated in the resolution.

Additional provisions concerning penalties to be imposed in the event of breach of the provisions of the Regulation are found under the Swedish Act (1996:95) on Certain International Sanctions.
