Communiqué on the situation in Angola issued on 24 July 1998 by the Central Organ of the Organization of African Unity Mechanism for Conflict Prevention, Management and Resolution

The Central Organ of the Organization of African Unity Mechanism for Conflict Prevention, Management and Resolution met today, 24 July 1998, in an extraordinary session in Addis Ababa, at ambassadorial level, to consider the situation in Angola. The session was presided over by H.E. Smail Chergui, the Ambassador of Algeria to Ethiopia and Permanent Representative to the Organization of African Unity.

At the end of its deliberations, the Central Organ:

- 1. <u>Took note</u> of the information provided by the representative of the Government of Angola on the deteriorating situation in his country;
- 2. <u>Holds</u> the leadership of the National Union for the Total Independence of Angola (UNITA), and specifically Mr. Jonas Savimbi, personally accountable for the resumption of hostilities and the deteriorating security situation in Angola, as evidenced by their persistent refusal to conform to the relevant decisions of the United Nations Security Council regarding the implementation of the military and political aspects of the Lusaka Protocol, particularly the demobilization and disarmament of its troops, as well as the extension of State administration;
- 3. <u>Strongly condemned</u> UNITA for its acts of armed aggression and reoccupation of the territory already handed over to the State administration, thus creating an unfortunate outflow of refugees to the neighbouring and displaced persons;
- 4. <u>Called once again</u> on the leaders of UNITA to undertake the total and unconditional demobilization of their troops in accordance with the provisions of the Lusaka Protocol;
- 5. <u>Appealed</u> to the United Nations Security Council to assume its full responsibility for the maintenance of international peace and security and to take all necessary measures to assist the long suffering people of Angola, restore peace and stability to their war-torn country;
- 6. <u>Called on</u> all OAU Member States to apply, firmly and resolutely, the measures adopted by the United Nations Security Council, especially, within the context of Security Council resolutions 1135 (1997) and 1173 (1998);
- 7. Expressed concern at the low level of support for humanitarian assistance in Angola and <u>renewed</u> the OAU's appeal to the international community to provide the necessary humanitarian and economic assistance for the reconstruction of Angola, particularly the rehabilitation of demining operations;

- 8. Expressed its deep concern over the outflow of refugees and displaced persons, resulting in the deterioration of the humanitarian situation and $\underline{\text{called}}$ $\underline{\text{on}}$ the OAU Commission of Refugees and displaced persons;
- 9. <u>Condemned</u> the widespread harassment of humanitarian aid workers, leading to their withdrawal from parts of Angola, and the loss of property and supplies of humanitarian agencies. It <u>appealed</u> for the protection of all humanitarian aid workers in Angola;
- 10. <u>Expressed</u> its appreciation to the Government of Unity and National Reconciliation for its statesmanship in the management of the peace process in Angola and the current crisis in particular.
