THE MALTESE RESPONSE TO THE QUESTIONNAIRE ON THE HUMAN RIGHTS OF MIGRANTS

1. The latest known figures of total population, including non-nationals by country of birth, are those obtainable from the latest Census held in 1995, which are as follows:

The number of migrants by country of residence and returned migrants by country of last permanent residence for the years 1931/32 up to 1996, are shown in attached Appendix A.

The number of non-nationals authorised to work in Malta as on the 11 May 1998 was 2100.

During 1997 there were a total of 385 foreigners who overstayed, landed without permit/sufficient means, used forged or false travel documents or were found working without necessary permit. The countries of origin and the relative number of these foreigners were as follows:

2. On the 27 May 1971, Malta acceded to the Convention on the Elimination of All Forms of Racial Discrimination. As can be seen from the demographic information supplied in reply to question 1, there is no significant ethnic minority which warrants any fear as to the safeguarding of any ethnic minority's rights. It is for this reason that the need is not felt to enact ad hoc legislation in this respect. Indeed it is felt that the existing legal provisions guarantee a social life which excludes racial discrimination. The setting up of the Office of the Ombudsman in 1995, with the function to investigate administrative actions taken by or on behalf

of Government Departments, Local Councils and other public authorities ensures the protection of the individual, irrespective of his/her nationality, against any abuse and will see that the administration is just and fair in its decisions. This promotes freedom and justice in an effective and efficient manner.

Campaigns are undertaken from time to time in the media to raise the public awareness against racial discrimination. The concept of racial tolerance and understanding is included in the compulsory social studies component of the national curriculum. Students are encouraged to correspond with children in other countries and efforts are continuously made to increase the number of foreign students studying in Malta. The number of foreign students studying English in Malta is ever on the increase with a number of these students being hosted by Maltese families. All these measures are encouraged and are seen as a means of preventing problems related to racism and discrimination.

3. No manifestations referred to in the question have been experienced.
