"1. SCOPE

This Regulation covers new pneumatic tyres designed primarily, but not only, for vehicles in categories M, M_3 , N and O_3 and O_4 . $\star/$ However, it does not apply to tyre types identified by speed category symbols corresponding to speeds below 80 km/h.

Subsequent numbers to the Agreement Concerning the Adoption of Uniform Technical Prescriptions for Wheeled Vehicles, Equipment and Parts which can be Fitted and/or be Used on Wheeled Vehicles and the Conditions for Reciprocal Recognition of Approvals Granted on the Basis of these Prescriptions," E/ECE/324 E/ECE/TRANS/5054 Rev.1/Add.53/Rev.1/Amend.1 Regulation No. 54 page 3

Paragraphs 8. and 8.1., amend to read:

"8. CONFORMITY OF PRODUCTION

The conformity of production procedures shall comply with those set out in the Agreement, Appendix 2 (E/ECE/324-E/ECE/TRANS/505/Rev. 2), with the following requirements:

8.1. Tyres approved under this Regulation shall be so manufactured as to conform to the type approved, by meeting the requirements set forth in paragraph 6. above."

Paragraphs 8.2. to 8.4.4., should be deleted.

Paragraph 8.4.5., renumber as paragraph 8.2. and amend to read:

"8.2. The authority which has granted type approval may at any time verify the conformity control methods applied in each production facility. For each production facility, the normal frequency of these verifications shall be once every two years."

Annex 1, item 1, amend to read:

"1. Manufacturer's name or trade mark(s) on the tyre type:"

Annex 5, Part II, table D, amend the title of the table to read:
