- 1. The CHAIRMAN invited members to consider the remaining sections of the draft annual report, namely, chapter III.B (Norway) (CCPR/C/XIII/CRP.1/Add.8) and annex VIII (General comments) (CCPR/C/XIII/CRP.1/Add.16).
- 2. Chapter III.B (Norway) and annex VIII of the draft report were approved with a number of additions and amendments.
- 3. The CHAIRMAN said that, if there was no objection, he would take it that the Committee wished to approve document CCPR/C/XIII/CRP.1/Add.17, which was not yet available and consisted merely of a list of communications.
- 4. It was so decided.
- 5. Mr. MOVCHAN pointed out that the Russian translation of the report was not in line with the English original, and suggested that the necessary technical assistance might be provided by members of the Division of Human Rights whose working language was Russian.
- 6. The report of the Human Rights Committee (CCPR/C/XIII/CRP.1 and Add.1-17) was adopted.
