STATES PARTIES TO THE CONVENTION ON THE RIGHTS OF THE CHILD AND STATUS OF THE SUBMISSION OF REPORTS UNDER ARTICLE 44 OF THE CONVENTION

Note by the Secretary-General

1. The Convention on the Rights of the Child was adopted by the General Assembly in resolution 44/25 of 20 November 1989, and entered into force on 2 September 1990, on the thirtieth day after the date of the deposit with the Secretary-General of the United Nations of the twentieth instrument of ratification or accession.

2. As at 1 July 1998 the Convention had been ratified or acceded to by 191 States. A list of States parties, as well as information on the status of the submission of reports by States parties, is to be found in the annex to the present document. Reports of States parties are due two years after the date of the entry into force of the Convention in the State party, and thereafter every five years.
