> IMPLEMENTATION OF GENERAL ASSEMBLY RESOLUTION 35/143 CONCERNING THE SIGNATURE AND RATIFICATION OF ADDITIONAL PROTOCOL I OF THE TREATY FOR THE PROHIBITION OF NUCLEAR WEAPONS IN LATIN AMERICA (TREATY OF TLATELOLCO)

Report of the First Committee

I. INTRODUCTION

1. The item entitled "Implementation of General Assembly resolution 35/143 concerning the signature and ratification of Additional Protocol I of the Treaty for the Prohibition of Nuclear Weapons in Latin America (Treaty of Tlatelolco)" was included in the provisional agenda of the thirty-sixth session in accordance with General Assembly resolution 35/143 of 12 December 1980.

2. At its 4th plenary meeting, on 18 September 1981, the General Assembly, on the recommendation of the General Committee, decided to include the item in its agenda and to allocate it to the First Committee.

3. At its 2nd meeting, on 7 October, the First Committee decided to hold a combined general debate on the items allocated to it relating to disarmament, namely, items 39 to 56, 128 and 135. The general debate on these items took place at the 3rd to 26th meetings, from 19 October to 4 November (see A/C.1/36/PV.3-26).

4. In connexion with item 41, the First Committee had before it a letter dated 30 September 1981 from the Permanent Representative of Cuba to the United Nations addressed to the Secretary-General, transmitting the communiqué of the Meeting of the Ministers of Foreign Affairs and Heads of Delegations of the Non-Aligned Countries, held in New York on 25 and 28 September 1981, to the thirty-sixth session of the General Assembly (A/36/566-S/14713).

II. CONSIDERATION OF DRAFT RESOLUTION A/C.1/36/L.41 AND Rev.1 AND 2

5. On 16 November, the Bahamas, Barbados, Bolivia, Colombia, Costa Rica, the Dominican Republic, Ecuador, Grenada, Guatemala, Haiti, Honduras, Jamaica, Mexico, Micaragua, Panama, Paraguay, Peru, Suriname, Trinidad and Tobago, Uruguay and Venezuela submitted a draft resolution (A/C.1/36/L.41), which read as follows:

"The General Assembly,

"<u>Recalling</u> its resolutions 2286 (XXII) of 5 December 1967, 3262 (XXIX) of 9 December 1974, 3473 (XXX) of 11 December 1975, 32/76 of 12 December 1977, S-10/2 of 30 June 1978, 33/58 of 14 December 1978, 34/71 of 11 December 1979 and 35/143 of 12 December 1980 concerning the signature and ratification of Additional Protocol I of the Treaty for the Prohibition of Nuclear Weapons in Latin America (Treaty of Tlatelolco),

"Taking into account that within the zone of application of that Treaty, to which 22 sovereign States are already parties, there are some territories which, in spite of not being sovereign political entities, are nevertheless in a position to receive the benefits deriving from the Treaty through its Additional Protocol I, to which the States that <u>de jure</u> or <u>de facto</u> are internationally responsible for those territories may become parties,

"Recalling with satisfaction that the United Kingdom of Great Britain and Northern Ireland and the Kingdom of the Metherlands became parties to Additional Protocol I in 1969 and 1971, respectively,

"<u>Noting also with satisfaction</u> that the United States of America has announced that there are well-founded reasons to expect that its ratification of the Protocol will take place in the very near future,

⁵¹. <u>Regrets</u> that the signature of Additional Protocol I by France, which took place on 2 March 1979, has not yet been followed by the corresponding ratification, notwithstanding the time already elapsed and the pressing invitations addressed by the Assembly and which it reiterates with special urgency in the present resolution;

"2. <u>Decides</u> to include in the provisional agenda of its thirty-seventh session an item entitled "Implementation of General Assembly resolution concerning the signature and ratification of Additional Protocol I of the Treaty for the Prohibition of Muclear Weapons in Latin America (Treaty of Tlatelolco)."

6. At the 35th meeting on 19 November, the representative of Mexico introduced a revised draft resolution (A/C.1/36/L.41/Rev.1), in which the fourth preambular paragraph had been revised to read:

"Noting also with satisfaction that the United States of America has announced that it will ratify the Protocol in the very near future,".

7. Subsequently, another revised draft resolution (A/C.1/36/L.41/Rev.2) was submitted changing the same preambular paragraph to read as follows:

"<u>Noting also with satisfaction</u> that the United States of America likewise became a party to Additional Protocol I on 23 November 1981, when its instrument of ratification was deposited,".

8. At its 44th meeting, on 25 November, the Committee adopted the draft resolution by a recorded vote of 121 to none, with 3 abstentions (see para. 9). The voting was as follows:

In favour: Afghanistan, Algeria, Angola, Argentina, Australia, Austria, Bahamas, Bahrain, Bangladesh, Barbados, Belgium, Benin, Bhutan, Bolivia, Brazil, Bulgaria, Burma, Burundi, Byelorussian Soviet Socialist Republic, Canada, Chile, China, Congo, Cyprus, Czechoslovakia, Democratic Kampuchea, Democratic Yemen, Denmark, Djibouti, Ecuador, Egypt, Ethiopia, Fiji, Finland, Gabon, German Democratic Republic, Germany, Federal Republic of, Ghana, Greece, Guatemala, Guinea, Guinea-Bissau, Haiti, Honduras, Hungary, Iceland, India, Indonesia, Iran, Iraq, Ireland, Israel, Italy, Ivory Coast, Jamaica, Japan, Jordan, Kenya, Kuwait, Lao People's Democratic Republic, Lebanon, Libyan Arab Jamahiriya, Madagascar, Malaysia, Maldives, Mali, Malta, Mauritania, Mexico, Mongolia, Morocco, Mozambique, Nepal, Netherlands, New Zealand, Nicaragua, Niger, Nigeria, Norway, Oman, Pakistan, Panama, Papua New Guinea, Paraguay, Philippines, Poland, Portugal, Qatar, Romania, Rwanda, Sao Tome and Principe, Saudi Arabia, Senegal, Sierra Leone, Singapore, Somalia, Spain, Sri Lanka, Sudan, Suriname, Swaziland, Sweden, Syrian Arab Republic, Thailand, Togo, Trinidad and Tobago, Tunisia, Turkey, Uganda, Ukrainian Soviet Socialist Republic, Union of Soviet Socialist Republics, United Arab Emirates, United Kingdom of Great Britain and Northern Ireland, United Republic of Cameroon, United States of America, Uruguay, Venezuela, Viet Nam, Yemen, Yugoslavia, Zaire.

Against: None.

Abstaining: Cuba, France, Guyana.

III. RECOMMENDATION OF THE FIRST COMMITTEE

9. The First Committee recommends to the General Assembly the adoption of the following draft resolution:

Implementation of General Assembly resolution 35/143 concerning the signature and ratification of Additional Protocol I of the Treaty for the Prohibition of Nuclear Weapons in Latin America (Treaty of Tlatelolco)

The General Assembly,

Recalling its resolutions 2286 (XXII) of 5 December 1967, 3262 (XXIX) of 9 December 1974, 3473 (XXX) of 11 December 1975, 32/76 of 12 December 1977, S-10/2 of 30 June 1978, 33/58 of 14 December 1978, 34/71 of 11 December 1979 and 35/143 of 12 December 1980 concerning the signature and ratification of Additional Protocol I of the Treaty for the Prohibition of Nuclear Weapons in Latin America (Treaty of Tlatelolco),
