> PROHIBITION OF THE DEVELOPMENT AND MANUFACTURE OF NEW TYPES OF WEAPONS OF MASS DESTRUCTION AND NEW SYSTEMS OF SUCH WEAPONS

Report of the First Committee

I. INTRODUCTION

1. The item entitled "Prohibition of the development and manufacture of new types of weapons of mass destruction and new systems of such weapons: report of the Committee on Disarmament" was included in the provisional agenda of the thirty-sixth session in accordance with General Assembly resolution 35/149 of 12 December 1980.

2. At its 4th plenary meeting, on 18 September 1981, the General Assembly, on the recommendation of the General Committee, decided to include the item in its agenda and to allocate it to the First Committee.

3. At its 2nd meeting, on 7 October, the First Committee decided to hold a combined general debate on the items allocated to it relating to disarmament, namely, items 39 to 56, 128 and 135. The general debate on these items took place at the 3rd to 26th meetings, from 19 October to 4 November (see A/C.1/36/PV.3-26).

(b) Letter dated 18 September 1981 from the Permanent Representative of Romania to the United Nations addressed to the Secretary-General (A/36/528 and Corr.1);

(c) Letter dated 30 September 1981 from the Permanent Representative of Cuba to the United Nations addressed to the Secretary-General transmitting the communiqué of the Meeting of the Ministers of Foreign Affairs and Heads of Delegations of the Non-Aligned Countries, held in New York on 25 and 28 September 1981, to the thirty-sixth session of the General Assembly (A/36/566-S/14713);

(d) Letter dated 5 October 1981 from the Permanent Representative of Cuba to the United Nations addressed to the Secretary-General, transmitting the resolutions adopted by the 68th Inter-Parliamentary Conference, held in Havana from 15 to 23 September 1981 (A/36/584).

II. CONSIDERATION OF DRAFT RESOLUTION A/C.1/36/L.13

5. On 12 November, Afghanistan, Benin, Bulgaria, Burundi, the Byelorussian Soviet Socialist Republic, the Congo, Cuba, Czechoslovakia, Democratic Yemen, Ethiopia, the German Democratic Republic, Guinea, Hungary, the Lao People's Democratic Republic, Madagascar, Mongolia, Mozambique, Poland, Romania, the Syrian Arab Republic, the Ukrainian Soviet Socialist Republic, the Union of Soviet Socialist Republics, Viet Nam and Yemen submitted a draft resolution (A/C.1/36/L.13), which was subsequently also sponsored by Angola, Jordan, the Niger, and Sao Tome and Principe. The draft resolution was introduced by the representative of the Byelorussian Soviet Socialist Republic at the 35th meeting, on 19 November.

6. At its 40th meeting, on 23 November, the Committee adopted draft resolution A/C.1/36/L.13 by a recorded vote of 95 to none, with 27 abstentions (see para. 7). The voting was as follows:

III. RECOMMENDATION OF THE FIRST COMMITTEE

7. The First Committee recommends to the General Assembly the adoption of the following draft resolution:

PROHIBITION OF THE DEVELOPMENT AND MANUFACTURE OF NEW TYPES OF WEAPONS OF MASS DESTRUCTION AND NEW SYSTEMS OF SUCH WEAPONS

The General Assembly,

Recalling its resolutions 3479 (XXX) of 11 December 1975, 31/74 of 10 December 1976, 32/84 of 12 December 1977, 33/66 B of 14 December 1978, 34/79 of 11 December 1979 and 35/149 of 12 December 1980 concerning the prohibition of new types of weapons of mass destruction,

Bearing in mind the provisions of paragraph 39 of the Final Document of the Tenth Special Session of the General Assembly, 2/ according to which qualitative and quantitative disarmament measures are both important for halting the arms race and efforts to that end must include negotiations on the limitation and cessation of the qualitative improvement of armaments, especially weapons of mass destruction, and the development of new means of warfare,

Recalling the decision contained in paragraph 77 of the Final Document to the effect that, in order to help prevent a qualitative arms race and so that scientific and technological achievements might ultimately be used solely for peaceful purposes, effective measures should be taken to prevent the emergence of new types of weapons of mass destruction based on new scientific principles and achievements, and that efforts aiming at the prohibition of such new types and new systems of weapons of mass destruction should be appropriately pursued,

Expressing once again its firm belief, in the light of the decisions adopted at the tenth special session, in the importance of concluding an agreement or agreements to prevent the use of scientific and technological progress for the development of new types of weapons of mass destruction and new systems of such weapons,

Noting that, in the course of its session held in 1981, the Committee on Disarmament considered the item entitled "New types of weapons of mass destruction and new systems of such weapons: radiological weapons",

Noting with satisfaction that, in the course of its session held in 1981, the Committee on Disarmament held informal meetings with the participation of qualified governmental experts on this item,

<u>Convinced</u> that all ways and means should be utilized to prevent the development and manufacture of new types of weapons of mass destruction and new systems of such weapons,

Taking into consideration the part of the report of the Committee on Disarmament relating to this question, 3/

1. <u>Requests</u> the Committee on Disarmament, in the light of its existing priorities, to intensify negotiations, with the assistance of qualified governmental experts, with a view to preparing a draft comprehensive agreement on the prohibition of the development and manufacture of new types of weapons of mass destruction and new systems of such weapons, and to draft possible agreements on particular types of such weapons;

2. <u>Once again urges</u> all States to refrain from any action which could adversely affect the talks aimed at working out an agreement or agreements to prevent the emergence of new types of weapons of mass destruction and new systems of such weapons;

3. <u>Calls upon</u> the States permanent members of the Security Council, as well as upon other militarily significant States, to make declarations, identical in substance, concerning the refusal to create new types of weapons of mass destruction and new systems of such weapons, as a first step towards the conclusion of a comprehensive agreement on this subject, bearing in mind that such declarations would be approved thereafter by a decision of the Security Council;

4. <u>Requests</u> the Secretary-General to transmit to the Committee on Disarmament all documents relating to the consideration of this item by the General Assembly at its thirty-sixth session;

5. <u>Requests</u> the Committee on Disarmament to submit a report on the results achieved to the General Assembly for consideration at its thirty-seventh session;

6. <u>Decides</u> to include in the provisional agenda of its thirty-seventh session the item entitled "Prohibition of the development and manufacture of new types of weapons of mass destruction and new systems of such weapons: report of the Committee on Disarmament".
