2. WORK OF THE SUB-COMMITTEE OF EXPERTS ON THE TRANSPORT OF DANGEROUS GOODS ON ITS THIRTEENTH, FOURTEENTH AND FIFTEENTH SESSIONS AND RECOMMENDATIONS MADE BY IT, TOGETHER WITH SUBSEQUENT PROPOSALS ARISING THEREFROM; ESPECIALLY FROM INTERNATIONAL ORGANIZATIONS CONCERNED WITH REGULATIONS OR RECOMMENDATIONS ON THE TRANSPORT OF DANGEROUS GOODS AT AN INTERNATIONAL LEVEL

(a) Multimodal portable tank transport

Despite the progress made on tanks for gases with critical temperatures below 65 °C (see ST/SG/AC.10/C.3/30/Add.1), the Sub-Committee at its last session was of the opinion that it would not be possible to reach a final conclusion at the Committee's session because ISO work on standards for gas cylinders had not yet been completed. The Sub-Committee asked the Committee to continue the work during the next biennium (see ST/SG/AC.10/C.3/30, para. 18, and item 5 of this agenda). The Sub-Committee developed guidelines for assigning portable tanks requirements to substances of Classes 3 to 9 and revised the tank coding system and the assignment of tank codes accordingly.

3. ACTIVITIES RELATED TO THE IMPLEMENTATION OF AGENDA 21**(a) Global harmonization of systems of classification and labelling of chemicals****(i) General**

The Inter-Organization Programme for Management of Chemicals (IOMC) Coordinating Group for the Harmonization of Chemical Classification Systems (CG/HCCS) has prepared a proposal to establish a mechanism for the implementation and follow-up of the Globally Harmonized System (GHS). This would consist of the reconfiguration of the Committee of Experts on the Transport of Dangerous Goods into a new United Nations Committee on the Transport of Dangerous Goods and the Globally Harmonized System with two sub-committees, one a Sub-Committee of Experts on the Transport of Dangerous Goods and the other a Sub-Committee of Experts on the Globally Harmonized System. This issue has already been preliminarily discussed by the Sub-Committee (ST/SG/AC.10/C.3/30, paras. 182 to 221). New documents have been transmitted as follows:

(iv) Labelling and hazard communication systems

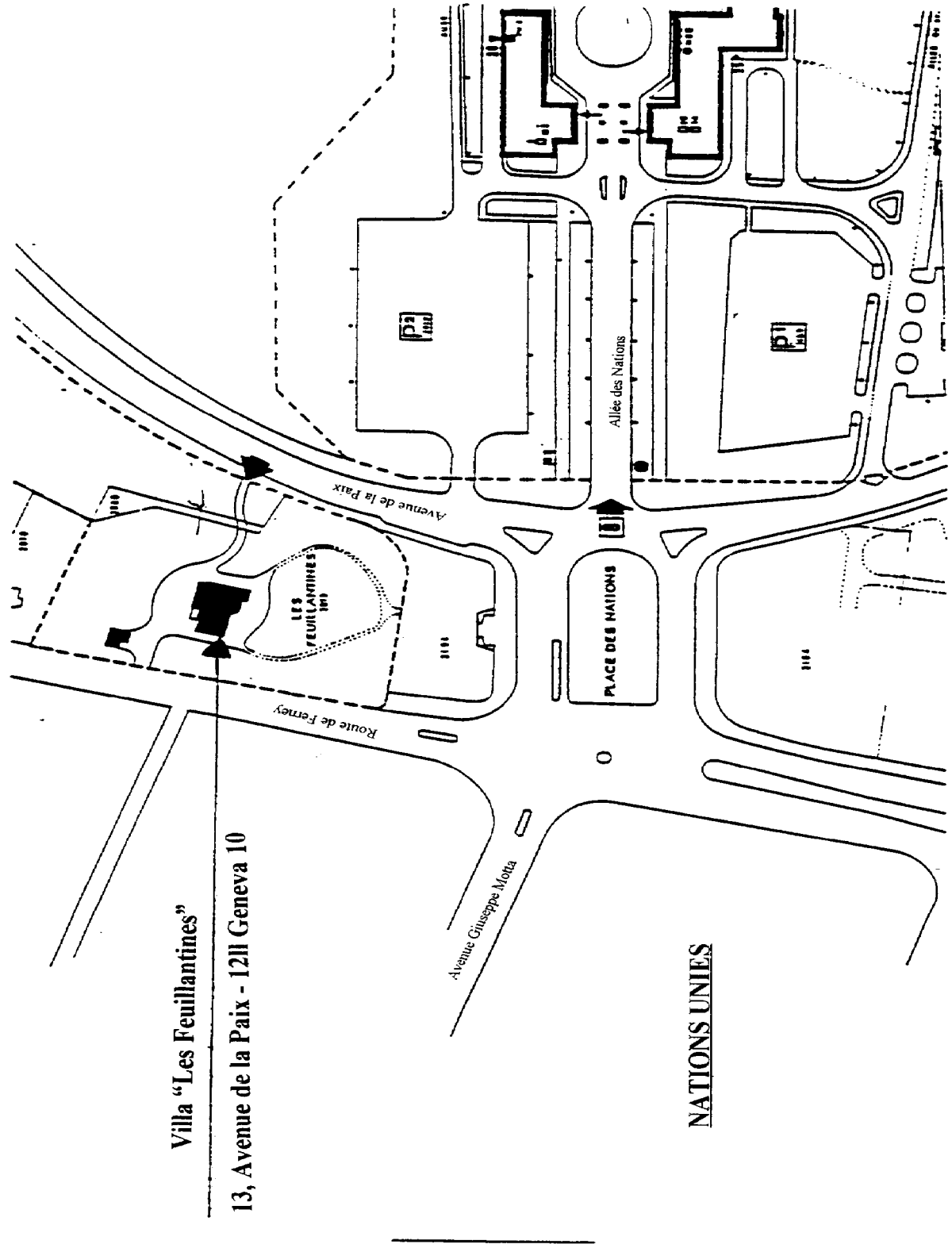
