Mr. Pavel Dolenc was born in Pijava at Gorica, Ljubljana, on 11 January 1942. He lives in Ljubljana, Župančičeva 7. He is employed at the Supreme Court as a supreme court judge. He is married and has two daughters.

Education

He graduated from the Faculty of Law, University of Ljubljana, with a degree paper in criminal law on the New Social Defence movement in criminology. After a two-year traineeship at the Court and in the Public Prosecutor's Office in 1970, he passed the bar exam required for practising as a judge, a prosecutor, a barrister or a notary.

Prior to that he had completed five-year elementary school, junior high school and Teachers' Training College.

Professional experience

After having completed military service and traineeship, he was appointed Assistant and then Deputy Municipal Public Prosecutor in Koper. From 1973 to 1978, he served as Deputy District Public Prosecutor in the Basic Public Prosecutor's Office in Koper from 1979 to 1981. At that point he was appointed Deputy Senior Public Prosecutor in Ljubljana. From June 1985 to July 1988, he worked as Head of the Market Inspectorate of the former Socialist Federal Republic of Yugoslavia in Belgrade and later as Public Prosecutor, or Head of the Higher Public Prosecutor's or State Prosecutor's Office in Ljubljana and as Senior State Prosecutor in Ljubljana. Since 1 August 1997, he has been a supreme court judge in the Criminal Department of the Supreme Court of the Republic of Slovenia.

A paper on the legal possibilities of the prosecution of war criminals from the standpoint of the criminal law of Slovenia was published in the international legal journal Criminal Law Forum, published by Rutgers, the State University, New Jersey, United States of America.
