Gian Luigi Valenza

Ambassador Valenza is currently serving a three-year term on the Advisory Committee on Administrative and Budgetary Questions.

For four successive bienniums (1988–1989, 1990–1991, 1992–1993 and 1994–1995), he held the post of Deputy Chairman of the Finance Committee of the Food and Agriculture Organization of the United Nations (FAO). This nine-member Committee advises the Board of FAO and the World Food Programme (WFP) on matters pertaining to budget, external auditing, pensions and other administrative or financial questions.

He has also held the post of Deputy Chairman of the seven-member Juridical and Legal Committee of FAO, which is often called on to examine financial and administrative questions.

In 1994, in the framework of Italy's chairmanship of the Conference on Security and Cooperation in Europe (CSCE), Ambassador Valenza was entrusted with the economic basket and the chairmanship of the Second Economic Forum of Prague (April 1994). He participated in the first part of the recent CSCE Review Conference held in Budapest.

From 1991 to 1994, he held the post of Chairman of the External Audit Committee of the International Fund for Agricultural Development (IFAD) and, during the same period, he was the Head of the Italian delegation for the Third Replenishment of IFAD.

He was a member of the Italian delegation to the 1993 and 1994 sessions of the General Assembly. During that time, he was also Chief of the Italian delegation for the entire fivesession cycle of the International Committee for Negotiation on Desertification (Nairobi, Geneva, New York, Geneva, Paris).

From 1988 to 1993, he was Permanent Representative of Italy, with the title and rank of Ambassador, to FAO, IFAD and WFP in Rome. From 1983 to 1988, he was Permanent Representative of Italy, also with the title and rank of Ambassador, to the United Nations Environment Programme (UNEP) and to Habitat in Nairobi.

From 1978 to 1983, he was an international officer in the Organisation for Economic Cooperation and Development (OECD) as Assistant Secretary General, where his duties included relations with international organizations (United Nations, Common Market, European Free Trade Agreement, etc.). From 1973 to 1974, he was a member of the Italian delegation to the General Assembly.

From 1973 to 1975, he was the Head of the International Organizations Desk at the General Department of Political Affairs at the Ministry of Foreign Affairs, which is also concerned with financial matters at the United Nations (Fifth Committee and the Advisory Committee on Administrative and Budgetary Questions).

During his diplomatic career, Ambassador Valenza has also held posts in France (twice), Pakistan, Czechoslovakia, Poland and Kenya.
