Addendum

1. As regards the chairmanship and vice-chairmanship of the International Civil Service Commission, it is recalled that article 2 of the Commission's statute provides that:

"The Commission shall consist of fifteen members appointed by the General Assembly, of whom two, who shall be designated Chairman and Vice-Chairman, respectively, shall serve full-time."

- 2. The vacancies for Chairman and Vice-Chairman of the International Civil Service Commission will occur on 1 January 1999.
- 3. The Government of Tunisia has put forth a candidate for the position of Chairman of the International Civil Service Commission. The Government of Argentina has put forth a candidate for the position of Vice-Chairman.
