I. Introduction

1. In its resolution 52/70 B of 10 December 1997, the General Assembly requested "the Secretary-General to report to the Committee on Information at its twentieth session and to the General Assembly at its fifty-third session on United Nations public information activities and on the implementation of the measures regarding information and communications approved by the Assembly".

2. Two reports were submitted to the Committee on Information at its twentieth session, held from 4 to 15 May 1998:

(a) Report of the Secretary-General on implementation of the measures regarding information and communications (A/AC.198/1998/2); and

(b) Report of the Secretary-General on the activities of the Joint United Nations Information Committee (A/AC.198/1998/3 and Corr.1).

In addition, at the request of the Committee on Information, the Secretary-General prepared a report on the development of United Nations international broadcasting capacity (A/AC.198/1998/4), for consideration by the Committee at a resumed meeting scheduled to take place in late October 1998.

3. The Under-Secretary-General for Communications and Public Information provided additional substantive information in his opening statement to the Committee.

4. The deliberations of the Committee on Information at its twentieth session are reflected in its report to the General Assembly. The present report responds to resolution 52/70 B and updates the information previously provided, avoiding, as much as possible, duplication of the material contained in the reports submitted to the Committee.

II. Overview

5. Since the previous report on questions relating to information (A/52/455), consultations on the reorientation of the work of the Department of Public Information contributed to the identification of the major strategic objectives and functional priorities that would characterize the new orientation of the Organization's communications and information policies and programmes. The necessary conceptual framework for such policies was elaborated in the report of the Secretary-General on the implementation of the measures regarding information and communications (A/AC.198/1998/2) submitted to the Committee on

Information for consideration at its twentieth session (4 to 15 May 1998). The main elements of this framework, which bear repetition in this report, are as follows:

(a) To place the communications and information functions at the heart of the strategic management of the Organization, given their central role in building public and political support for the United Nations;

(b) To help develop a culture of communications throughout the Organization, in order to communicate, in cooperation with the programmes, funds and specialized agencies, the direct relevance of every aspect of United Nations work to the daily lives and concerns of people everywhere;

(c) To project the Organization as an open, transparent and public institution which has the capacity to meet the principal peace, development and human rights objectives enshrined in the Charter of the United Nations;

(d) To strengthen the Organization's ability to communicate at the country and regional levels – the levels at which public opinion is created – and to ensure that the global messages of the United Nations both reflect and are tailored to national orientations;

(e) To continue to strengthen the Organization's capacity to use the latest information technologies to reach audiences around the globe;

(f) To follow closely the strategic guidance and direction of the General Assembly on the implementation of mandates, while accepting much greater responsibility for formulation of specific programmes designed to meet mandated goals;

(g) To develop and strengthen the capacity to deploy given resources flexibly to meet exigent challenges, while maintaining the commitment to mandated priorities;

(h) To strengthen further the Department's capacity to work together with other parts of the Organization to design and implement communications and information strategies for their substantive and thematic objectives.

6. Only the vigorous implementation of the compelling communications priorities listed above will ensure the kind of global public support that is indispensable to the long-term survival of the Organization. To translate these priorities into an operational framework, the actions listed below, developed with full participation of the staff of the Department, are being undertaken or will be undertaken shortly.

A. Policy and strategic direction

7. Communications policy and strategy will be continuously reviewed, to ensure that it reflects the goals and priorities enunciated by the General Assembly and the Secretary-General; the programmes and outputs of all departmental units will also take their lead from these agreed priorities. A Strategic Communications Planning Group, as described in the Secretary-General's report to the Committee on Information (A/AC.198/1998/2), has already begun functioning. The Group helps to formulate, refine and, as needed, shift departmental goals and strategies and ensure that all parts of the Department are working synergetically towards achieving agreed results. The Group also formulates campaigns on priority concerns and ensures interdivisional coordination and execution of all high-priority operations.

B. The Internet

Technological progress has perhaps had its most 8. profound impact in the communications and information field, with the Internet leading the information revolution. The United Nations must therefore take full advantage of this new "fourth" medium – along with the three traditional media – print, radio and television. The Department of Public Information has been in the forefront in this context and will continue to strengthen its role in managing and coordinating the United Nations website, especially its public information content. Moreover, as coordinator of the Interdepartmental Working Group, which it chairs, the Department is continuing to enhance its assistance on Internet matters to other parts of the Secretariat. As part of the reorientation measures, the Internet operation has been located in the Office of the Under-Secretary-General for Communications and Public Information, and in pursuit of the indication given to the Committee on Information last May, a Director-level official has been placed in charge of the Information Technology Section, which also reports directly to the Under-Secretary-General.

9. A new "media" segment on the United Nations website will provide information materials created expressly for the Internet and presented in a manner that the media can readily utilize. The Department plans to significantly increase the volume of its posting of multimedia material, including regular radio news and updates, and will also introduce and host online chats with United Nations experts on various issues. It is also continuing work towards the expansion of the United Nations website to include all official languages of the Organization.

C. Reaching the media

10. Ultimately, effective communication of the United Nations message, and its relevance, will depend significantly upon how well the message is projected to the media. It must be inserted consistently into the global news cycle and news pool. In pursuit of this objective, a lively, responsive media capacity is being developed, centred around a strengthened news disseminating capacity sharply tuned to media needs and to building closer media contacts.

11. Given the centrality of timeliness for news media access – information arriving even an hour late for a newscast or newspaper is often no longer news – the Internet and other forms of electronic communications will be developed into the principal vehicle for enhancing access.

D. Media Response Group

12. In order to improve its capacity to react quickly to media reports about the Organization and its activities, a Media Response Group has been assembled within the Department. The Group reviews such media reports and provides appropriate and timely advice to the Under-Secretary-General for Communications and Public Information. The Group is also responsible for updating the Department's fact sheets in the series "Setting the record straight".

E. Writers' Group

13. A central Writers' Group, capable of responding quickly to the need for clear, coherent information material on breaking stories, will further strengthen the Department's news dissemination operation. Working closely with existing news operations, including the Office of the Spokesman for the Secretary-General, the Group will generate customized scripts which can be used for live radio broadcasts or for posting on the Internet, and short news stories written in a form that the news media can directly utilize. It will also be responsible for postings on the "media" segment of the United Nations website.

F. Building global partnerships

14. Building global partnerships for the Organization will be a key task for the Department. Partnerships with civil society, which often looks actively to the United Nations for support and leadership, provide an unprecedented opportunity to make people everywhere recognize the Organization as an indispensable global institution for the maintenance of peace and also for addressing the everyday concerns of people in all societies: human rights, development, environment, employment, health, education, crime, drugs, etc.

15. In pursuit of this objective, the Department will continue to develop stronger working links with non-governmental organizations and other civil society groups such as academia, the business community and youth. Working through United Nations associations, both at Headquarters and in the field, links will be established with national figures supportive of the Organization who can be its advocates and come to its defence when it is being unjustly criticized.

16. Educational institutions continue to be increasingly important partners for the Department and its channel to the younger generations. The Department's programmes for students and teachers have been updated very substantially and will be given a high priority as part of the new orientation of communications policies.

G. Partnerships within the Secretariat

17. The information media, as our most important partners in disseminating information about the Organization's activities, continue to be a major focus within the new orientation. Media representatives expect a continuous flow of accurate and newsworthy information from the Organization. To further facilitate such a flow will be the principal objective of the Department. In this context, the Department's close partnership built with the corps of resident correspondents will be further strengthened.

18. The Department is committed to the creation of a true culture of communications within the Organization. It will work closely with all substantive offices to prepare and implement individually tailored strategies and help identify and promote the many positive, news-making aspects of their activities.

H. Communications at the field level

19. Since public opinion is essentially created at the national and regional levels, the United Nations information centres worldwide have been a vital medium of both outreach and information for the Organization and will become even more crucial as the United Nations system in the field comes together in the proposed "United Nations houses". All

centres, including the integrated United Nations Development Programme (UNDP) field offices, will present a uniform United Nations message at the national level, ensuring the effective implementation of the public information mandates established by the General Assembly. Measures are being considered to rectify the difficulties experienced by a number of integrated centres in this context.

I. Direct radio broadcasting capacity

20. In a congested global media environment where the United Nations message can easily be marginalized, the development of a United Nations international radio broadcasting capacity for direct communication with the public is an important project for the Department of Public Information. It would allow for direct and cost-effective information delivery for the entire United Nations system, particularly at times of crisis and in support of the public information needs of peacekeeping and humanitarian emergency operations. A feasibility study on the resumption of direct radio broadcasting by the United Nations is being conducted by the Committee on Information, which will submit its recommendations to the General Assembly.

J. Total quality management

21. The Department has adopted a "total quality management" approach to its outputs, each of which will be carefully reviewed to ensure that it meets a priority goal, that there is a real demand for it, and that it is being produced and disseminated in the most speedy, cost-effective and efficient manner.

III. Electronic communication and use of the Internet

22. The Department will continue to strengthen its coordinating, managing and policy guidance role on content matters for the Secretariat's Internet activities. Every section and unit of the Department is encouraged to incorporate this technology into its day-to-day functions and thus develop closer cooperation with other Secretariat departments.

23. Since the beginning of the year, the Department has launched a United Nations home page in Russian and begun to create home pages in Arabic and Chinese. It has added a number of departmental home pages and links to the United Nations website and provided coverage of several

conferences in multiple languages. The number of accesses went from 5,304,772 in January 1998 to 6,601,490 in August 1998. The numbers of queries and of feedback have also increased. At present, the United Nations home page is available in English, French, Spanish and Russian.

24. All press releases issued by the Department are now posted on the Internet, in English and French, as are comprehensive summaries of daily briefings by the Spokesman for the Secretary-General and texts of the Secretary-General's statements, for immediate access by the news media and the public at large.

25. The Department has expanded its outreach and response capacity to the community of non-governmental organizations through a link on the United Nations website. Beginning in 1998, the Department started coordinating and regularly updating a system-wide calendar of special events and observances at Headquarters which is available on the United Nations website.

26. The United Nations CyberSchoolBus, the Department's online education project, continues to be successful, drawing a record number of accesses and reaching out to thousands of schools around the world. Schools and students in over 80 countries have received educational materials on global issues and the work of the United Nations, and over 800 schools have been actively involved in carrying out peace, human rights and environmental projects initiated through the CyberSchoolBus.

27. Electronic communications played an important role in boosting the dissemination capabilities of a number of United Nations information centres. In Africa, Asia, Europe and Latin America, 14 centres developed Internet websites in local languages, and an additional 13 sites are under preparation.

IV. Public information programme activities

28. In accordance with the mandate set out in General Assembly resolution 52/70 B and in order to meet the objectives set by the Secretary-General, the activities of the Department in elaborating, coordinating, and harmonizing United Nations policies and activities in the field of information continue to be strengthened and improved.

29. The Office of the Spokesman for the Secretary-General has broadened the scope of the daily briefing for correspondents to include the work of all organizations of the United Nations system. An effort has also been made to

include information on the humanitarian, human rights and development work of the Organization, in addition to the political, while respecting the need to focus on the newsworthy. Members of the Spokesman's staff have assignments like those of a journalist, and develop topical and regional specialities on which they can speak with authority. The overall objective is for the Office to be a reliable source of information not just on the Secretary-General but on the system as a whole. Also, the Office attempts to treat all media organizations equally and does not provide specialized briefings to selected journalists.

As part of its new orientation, the Department is putting 30. hard news at the core of its operations in radio, television and print. The radio production and dissemination operations have embarked on a new course of modernization and programme restructuring. The new programming orientation is designed to expand the focus of thematic production to incorporate new and pressing issues mandated by intergovernmental bodies, integrate programme output into the daily news cycle, and enhance programme delivery. Daily radio news bulletins in English, French, Spanish and Portuguese are relayed via telephone lines and the Internet to hundreds of broadcasters in Africa and Latin America. Also, news bulletins in English, French and Spanish are posted regularly and updated on the audio-visual site of the home page for use by the general public. The Daily Highlights bulletin is currently being modified with a news service format, using the Internet for instantaneous dissemination.

31. Before the end of the year, the Department will introduce a direct radio broadcasting pilot project in selected regions of the world, initially in English and French, to test market interest and production capacity. As stated above in paragraph 20, a feasibility study on an international broadcasting capacity is being conducted by the Committee on Information.

32. As part of its efforts to strengthen relationships with media institutions, in November 1997 the Department organized the second United Nations World Television Forum, in co-sponsorship with the Ministry of Foreign Affairs of Italy, Radiotelevisione Italiana and Mediaset. The Forum, held on the theme "Television in the new multi-media environment", provided a venue for an ongoing professional dialogue between the United Nations and the television industry. The Department is also expanding its cooperation with outside broadcasters. With Deutsche Welle, BBC World Service and Insight News Television, among others, it has organized television news feature coverage missions to several United Nations peacekeeping and humanitarian missions. The Department has also increased its cooperation with such United Nations agencies as the United Nations Population Fund, the United Nations Children's Fund (UNICEF), UNDP, the International Labour Organization (ILO) and the Office of the United Nations High Commissioner for Refugees (UNHCR). The sale of documentaries, such as "Secrets in the Sand", is part of the Department's effort to provide products that are competitive with those of mainstream production sources and relevant to the needs of news editors and programme buyers.

33. The trial plan to provide no-cost television production facilities to resident correspondents was a success and has been made permanent. Recent major events covered by United Nations Television include the special session of the General Assembly on the world drug problem and the International Conference of Plenipotentiaries on the Establishment of an International Criminal Court. The 1997 United Nations Day Concert was produced as a television programme by the Department and broadcast live in Portugal and Brazil. The "stakeout" coverage by United Nations Television is now also done live, and consequently, the coverage is often broadcast live on the various cable news television channels.

34. Digital photography is regularly used to transmit photo coverage from the field to Headquarters and to news agencies, resulting in far more rapid distribution and posting on the Internet. Using this technology, for example, photo coverage of the Secretary-General's mission to Iraq earlier this year was available to the media almost instantaneously.

35. A feasibility study on the integration of the Department's media archives was recently completed. This integration, coupled with the advantages of strategic technology, will result in increased efficiency and the elimination of duplication. Audio-visual products will be easily and effectively stored, searched, retrieved, shared and distributed in a variety of environments.

36. The Department continues to strengthen links with a growing number of national and international non-governmental organizations. The fifty-first Annual Conference of the Department of Public Information for Non-Governmental Organizations was held at Headquarters (14 to 16 September 1998) on the theme "The fiftieth anniversary of the Universal Declaration of Human Rights: from words to deeds". Over 2,500 non-governmental organizations from many countries registered to attend the Conference.

37. Nearly half a million visitors take the Department's guided tour of Headquarters each year, and the numbers are rising. A new reservations and scheduling system has been introduced, to improve efficiency. Efforts are under way to improve the tour route using extrabudgetary resources.

38. Throughout the past year, increasing attention has been paid to outreach activities for students and educators. Whether through workshops for teachers, to encourage and equip them to bring the United Nations into the classroom, or "Students' days at the United Nations", highlighting observances such as Human Rights Day and World Environment Day, or through general interest and reference publications intended for school use, the Department seeks both to broaden interest in the work of the Organization and deepen understanding of its role and relevance.

39. The Department continues to help plan and coordinate a number of special events and programmes. An observance of World Press Freedom Day, organized by the Department in cooperation with the United Nations Educational, Scientific and Cultural Organization (UNESCO), the United Nations Correspondents Association, and the World Press Freedom Committee, was held on 4 May 1998. To mark the fiftieth anniversary of the adoption of the Universal Declaration of Human Rights, the observance featured a panel discussion on article 19 of the Declaration, in which a number of distinguished broadcasters and journalists participated.

40. The Department also organized a forum entitled "Public relations and the United Nations: working together for change", in co-sponsorship with the International Public Relations Association (IPRA). The event was held on 2 June 1998 in conjunction with the presentation of the United Nations Award for excellence in public relations campaigns addressing priority issues of the United Nations, part of IPRA's Golden World Awards.

41. A photographic exhibit to commemorate the Universal Declaration of Human Rights was displayed at Headquarters from December 1997 to March 1998. The exhibit then travelled to Geneva and Ottawa and will proceed to Washington, D.C. and Ramapo College in New Jersey, before returning to Headquarters on 10 December 1998. A public television service announcement based on the photographs will be aired worldwide later this year. The Department is also designing billboards on the Universal Declaration for display at the New York City and San Francisco airports. In cooperation with the United Nations International Drug Control Programme (UNDCP) the Department co-sponsored several exhibits for the special session of the General Assembly on the world drug problem. The Department also designed and produced a special exhibit on 50 years of peacekeeping which opened on 6 October.

V. Implementation of specific information programmes

42. The Department continues to carry out the task of developing thematically integrated information programmes on priority issues for the United Nations. The focus is on implementing information strategies, promotional activities and public services that highlight, among others, the Organization's role in furthering sustainable development, peace and security, democracy, human rights, humanitarian assistance, and social and economic development.

43. Development Update, a publication on United Nations economic and social initiatives, has changed its format to include feature-style articles, while expanding its readership among corporate executives, journalists, academics and organizations of civil society. Articles from the publication, currently covering the development activities and viewpoints of the United Nations on a system-wide basis, are reprinted or cited by other publications with increasing frequency.

44. The Department has worked closely with the Office of the High Commissioner for Human Rights to develop a comprehensive strategy for the observance of the fiftieth anniversary of the adoption of the Universal Declaration of Human Rights. The year-long observance was launched on Human Rights Day 1997 with a number of events organized by the Department at different venues. The Department has also been in contact with a number of airlines to publicize the fiftieth anniversary through pro-bono public service announcements in their in-flight magazines. On issues related to the fiftieth anniversary, the Department also organized events this year to mark International Women's Day (8 March), World Press Freedom Day (3 May), the International Day in Support of Victims of Torture (26 June), and the International Day of Indigenous People (9 August).

45. An important focus of the Department's activities in 1998 was the special session of the General Assembly on the world drug problem and international conferences on the establishment of an international criminal court and on youth. In cooperation with the United Nations International Drug Control Programme, the Department completed a range of information materials for inclusion in the media kit widely disseminated for the special session. An extensive media campaign, developed with the Office of Legal Affairs, including multi-media products, a media kit and poster, preceded the United Nations Diplomatic Conference of Plenipotentiaries on the Establishment of an International Criminal Court. The special publications and activities, planned in conjunction with the Department for Economic and Social Affairs, United Nations Secretariat, the Portuguese Youth Council and Portuguese authorities, helped set the stage for the Third World Youth Forum of the United Nations

system and the first World Conference of Ministers Responsible for Youth, both held in Portugal in August. These events were widely promoted through local and national activities organized by United Nations information centres and services around the world.

46. Outreach to the business community and to the financial media has been a key part of the Department's publicity on sustainable development, reflecting the aim of the Commission for Sustainable Development to strengthen partnerships with the business community. Resulting media coverage included, among others, the BBC World Business Report and World Service, and the *Financial Times*. Also, the Department issued a fact sheet, "Business and the United Nations", and an article highlighting examples of private-sector cooperation with organizations of the United Nations system. These were used at several events for business audiences organized by the Executive Office of the Secretary-General, as part of the media outreach by the Department; they resulted in extensive media coverage.

47. Reflecting the heightened media outreach orientation of the Department, among recent innovations is a systematic global effort to place in the major international and national media articles on priority issues for the Organization written by the Secretary-General. In recent months, articles have been written on the need for United Nations involvement in constructing a response to the pressures and opportunities of globalization; on the rationale and necessity for an international criminal court; on intensifying the search for a political settlement which would address the humanitarian crisis in southern Sudan; and on building international and African support for mechanisms to reduce conflict and promote sustainable development in Africa.

48. In this vein, the Department was also able to foster widespread media coverage in virtually all Member States for two important United Nations items which might not otherwise have received the level of international notice they did: the first verdict of genocide by an international court, the International Criminal Tribunal for Rwanda in September; and the report of the Secretary-General on the causes of conflicts and promotion of durable peace and sustainable development in Africa. The media outreach on the latter marked the first use by the Department of the Internet and electronic mail for the dissemination of significant public information materials.

49. The Department has expanded its circle of media outlets that regularly report the United Nations viewpoint on economic issues to include the major financial and business wire services, the Cable News Network (CNN) Financial Network, the Economist Intelligence Unit and influential publications such as the *Financial Times*, *Journal of Commerce* and *Business Investor's Daily*. Informative, attractively laid-out summaries of the *State of the World Economy at the Start of 1998* and of *World Economic and Social Survey 1998* and previews of the special high-level meeting of the Economic and Social Council with the Bretton Woods institutions, of the high-level segment of the Council and of the report of the Committee on Development Planning were prepared and distributed by the Department, which also promoted major annual reports on trade and development, world investment and the least developed countries issued by the United Nations Conference on Trade and Development (UNCTAD).

50. The communications strategy and the programme of activities for the International Year of Older Persons in 1999 have moved ahead, in consultation with the Department of Economic and Social Affairs and the NGO Committee on Ageing. The International Year was launched on 1 October by the Secretary-General at a special all-day event at Headquarters.

51. In support of the Organization's efforts to promote and maintain international peace and security, the Department has concentrated on three main areas: activities marking 50 years of United Nations peacekeeping; support for information components of field missions; and preparation and updating of products for posting on the Internet. As part of its support for information components of peacekeeping and other field missions, the Department continues to participate in early planning for those missions and maintains and updates its roster of potential candidates for field positions, with a view to making appropriate recommendations to the Department of Peace-keeping Operations, United Nations Secretariat as the need arises.

52. In connection with the deployment of the United Nations Mission in Central African Republic (MINURCA) in April 1998, the Department provided relevant information materials designed to raise the visibility of the mission in the country. It also facilitated contacts between the Government of Denmark and the Department of Peace-keeping Operations regarding the Government's donation of an FM and shortwave radio facility to the United Nations for use in field missions, initially in MINURCA.

53. The Department published a number of feature articles highlighting United Nations peacekeeping activities. Most of the printed products on peacekeeping are also adapted for publication on the Internet. In addition, the Department maintains and frequently updates a series of Internet pages providing background information and basic facts on each peacekeeping mission, in English and in French.

54. The commemoration of 50 years of United Nations peacekeeping in 1998 provided the Department with an opportunity to work closely with the Department of Peace-keeping Operations in undertaking a number of public information activities and producing information materials designed to underscore the Organization's role in conflict prevention and to honour those who have served in such operations.

55. The Department has continued to publicize United Nations activities in the field of arms limitation and disarmament. In cooperation with the Department for Disarmament Affairs and the Provisional Technical Secretariat of the Preparatory Commission for the Comprehensive Nuclear Test-Ban Treaty Organization, it is preparing a brochure on the Comprehensive Nuclear Test-Ban Treaty, using a grant from the Government of Finland. In anticipation of the signing ceremony of the International Treaty on the Ban of Landmines, a three-element press kit on the landmine issue and the role of the United Nations was published and made available at the conference site during the signing ceremony and was also posted on the United Nations website.

56. The Department continued its ongoing special information programme on the question of Palestine. It organized media seminars for the Asian and European regions, at New Delhi and Prague, respectively, under the theme "Prospects for Peace". The seminars brought together senior journalists representing prominent media organizations from the two regions with specialists from Israel, the Palestinian National Authority, and the neighbouring countries as well as from Europe and the United States of America. This fall, the Department is holding its fourth fourweek Palestinian Media Practitioners Training Programme at Headquarters. Ten journalists are scheduled to attend the programme.

57. The 1998 Training Programme for Broadcasters and Journalists from Developing Countries, which is taking place from 14 September to 22 October, will include participants from Argentina, Bangladesh, Bosnia and Herzegovina, Brazil, Cambodia, China, Congo, El Salvador, Fiji, Georgia, Guatemala, Haiti, Iran (Islamic Republic of), Liberia, Malaysia, Namibia, Syrian Arab Republic and Zambia. Four of the participants in the 1998 programme will be sponsored by the Friedrich Ebert Foundation of Germany. Since 1980, nearly 300 journalists from almost 150 countries have participated in the programme.

VI. Library services

58. Recognizing that electronic formats reduce geographical and physical barriers and facilitate the provision of value-added and cost-effective information services, the Dag Hammarskjöld Library has this year significantly expanded the following three major activities: the electronic "UN in the News Service" which offers daily, desktop delivery of major news stories concerning the Organization; the Dag Hammarskjöld Library's training programme in electronic information retrieval; and the electronic dissemination of time/mission-critical information via cc:Mail to permanent missions and staff at Headquarters and abroad.

59. With the aim of reducing expenditures throughout the United Nations system, the Library set up a consortium to access electronic information and now serves as its coordinating agency. Participating organizations share the cost of site licenses for electronic services of transorganizational interest which can be delivered through the Internet. Currently there are over 20 members in the United Nations system taking advantage of these volume-driven subscription rates. As a further result of the consortium, the Library is now able to provide the permanent missions at Headquarters, at no cost to them, with equal access to the electronic information previously available only to the Secretariat staff.

60. The Library's Internet site has been expanded to include "Maps", a site containing up-to-date maps of current peacekeeping operations, available in both English and French, and a complete listing of electronic resources available in the Library, including its branch libraries. UN-I-QUE, a searchable database that provides access to the symbols and sales numbers of a broad range of United Nations documents from 1946 to the present and the human rights chapter of the United Nations documentation research guide (www.un.org/Depts/dhl/resguide) both received awards in 1998. The Library has continued to expand its training programme in retrieval and downloading of United Nations documentation and other information resources from the Internet. Over 2,000 individuals were trained in 1997 and 1998.

61. As of September 1998, there were 365 United Nations depository libraries in 141 countries. Their numbers by region are as follows: Asia and the Pacific (82); Western Asia (17); Africa (53); Europe (114, with 30 in Eastern and 84 in Western Europe); Latin America and the Caribbean (46); and North America (53, with 41 in the United States of America and 12 in Canada). Through workshops and other training seminars, the Library has continued to expand its training

opportunities for United Nations depository librarians. Since 1997, nine workshops have been held to cover various regions. A joint inter-agency visits programme, which was recently launched, should facilitate the oversight of those libraries.

62. Recognizing that an increasing amount of information requires a cartographic medium for transport and exchange, during the past year the Department has taken several steps to assist with such a service. Windows-based workstations with the capability to operate the Geographic Information Systems software were acquired. When available, digital files of maps were also made available system-wide for use by other agencies. The maps of all peacekeeping operations were posted on the Internet and are being updated, as appropriate. It is expected that maps of all field operations will be added soon. The Department's cartographic services have proved particularly useful to the consultations of the Security Council, and several thousand copies of colour maps were distributed at meetings over the past year. A digital map display system was also introduced and is being operated on a daily basis.

VII.

United Nations Publications Board and marketing of United Nations publications

63. Through the monthly meetings of its Working Committee, the Publications Board coordinated and monitored the 1998–1999 consolidated publications programme of the United Nations and gave high priority to enhancing the creation of an electronic United Nations through increased use of the Internet to widen the outreach of the Organization. Its Working Group on Electronic Publishing is currently preparing guidelines for Internet publishing to advise author departments, as appropriate, and further enhance and coordinate the United Nations website.

64. Sales of publications generated an excess of income over expenditure of US\$ 1.77 million for the 1996–1997 biennium. Throughout the year, the Department continued to develop cooperative sales activities with other organizations of the United Nations system and reached an agreement with UNICEF for the sale of its publications. Also, a programme for agencies to pool resources in order to have more effective marketing impact was introduced, leading to combined United Nations system exhibits at several important book fairs.

65. The United Nations publications home page provides regular updates on publications and has been highly

commended by users. Complementing direct sale of publications, the Department expanded the development of co-published projects. Through these externally produced publications, with both commercial and not-for-profit entities, the Organization has been able to further disseminate its products, especially through locally produced language editions of its publications.

VIII. Publishing activities

66. The print medium remains one of the principal means of influencing public opinion around the world. Over the past year, the Department has worked to ensure that its publications promote the work of the United Nations system as a whole and emphasize the complementary ways in which the different parts of the system make a significant impact on the daily lives of people everywhere. Advances in desktop publishing, coupled with training in new design technologies, have enabled the Department overall to greatly enhance the design and marketability of the entire range of its print outputs and those of the Secretariat as a whole.

67. Promoting the centrality of the work of the United Nations system is the aim and purpose of *The United Nations in our Daily Lives*, a publication that the Department helped to produce and disseminate in early 1998. Likewise, a new section in the latest edition of *Basic Facts about the United Nations* provides essential information on all United Nations offices, programmes, funds and specialized agencies. *UN Chronicle* is increasingly becoming a news- and feature-oriented publication which appeals as much to the lay reader as to scholars and specialists. Regular sections have been added on health, development, reform and the environment.

68. The intense efforts by the United Nations system as a whole to assist Africa in realizing its economic and social objectives have been a particular focus of *Africa Recovery*. One entire issue of the magazine was devoted to the United Nations System-wide Special Initiative on Africa. A special briefing paper, "Women in Africa's development", was produced in conjunction with a major conference on this issue organized by the Economic Commission for Africa.

69. The Department's publications continue to be adapted in light of the results of the 1997 readership survey on its recurrent publications, which confirmed their usefulness to key target audiences. The survey also confirmed the high interest in the issue of United Nations reform which continues to be covered extensively in various publications by the Department. New editions of *Image & Reality* and *UN in Brief* emphasize the reform measures, while providing an increased profile to system-wide priorities. Human rights was the theme of the second in the *UN Briefing Papers* series, "Human rights today: a United Nations priority", produced with the participation of the Office of the High Commissioner for Human Rights. The special session of the General Assembly on the world drug problem was the focus of a wellreceived issue of *UN Chronicle*, produced with the assistance of UNDCP.

70. In an example of the strong cooperation between the Department and substantive offices and agencies, in May this year the Department and the World Bank signed a new agreement concerning Development Business, the Department's international procurement publication. The agreement includes the joint development of an Internet version of the publication and broadens the cooperation between the two organizations in this area. The new website, is to be called "Development Business Online". Effective use of modern technology will also be instrumental in facilitating the production of the Yearbook of the United Nations. Work on the last of the backlog editions (1990) and on the 1996 edition has continued, and both are expected to be issued in the near future. Plans to produce a CD-ROM covering all 50 volumes of the Yearbook (1946-1996) are also under way. The site is expected to become a significant new source of revenue for this self-financing publication.

IX. United Nations information centres

71. During the past year, United Nations information centres took strategic steps to enhance their effectiveness in communicating information about the work of the Organization and presenting a unified message to constituents at the local level. They continued to forge dynamic partnerships with the private sector, established coalitions of non-governmental organizations, organized teams of student lecturers, and formed local coordinating committees on information, involving all United Nations system partners in the field. The provision of upgraded computer equipment and staff training advanced efforts by the centres to broaden their information outreach to local constituents, particularly schools and educational institutions. Several centres applied desktop publishing capabilities to the production of locally relevant information materials, many of which were transmitted electronically to larger audiences. The information centres translated and disseminated more than 150 United Nations publications, documents and information products of the Department, covering the whole range of United Nations issues, including reform. Many produced their own radio and television programmes on the issues, for broadcast free of charge by local stations. Throughout the year, information centres also actively supported the work of United Nations programmes, funds and specialized agencies by publicizing their in-country projects and major reports.

72. Information centres helped attract high-visibility coverage for the fiftieth anniversary of the Universal Declaration of Human Rights, reaching large audiences through television and radio programmes, newspaper supplements, press conferences, seminars, lectures, competitions, information fairs and rallies. Fifty information centres cooperated with the Office of the High Commissioner for Human Rights and local governmental and civic organizations to promote the observance of Human Rights Day 1997 and the launch of the fiftieth anniversary of the Universal Declaration. Over the years information centres have produced more than 200 local-language versions of the Universal Declaration. This year, they produced some 45 local-language versions and disseminated thousands of copies in rural and remote communities around the world. The United Nations Information Centre in Madrid produced the first Braille version.

73. The Secretary-General's report to the Security Council on the causes of conflict and the promotion of durable peace and sustainable development in Africa sparked a variety of activities by information centres, which cooperated with local partners to organize briefings and press conferences and to translate and widely disseminate the report. An op-ed article, "The Africa that Africa deserves", written by the Secretary-General, was translated, disseminated, and placed in major newspapers by a number of centres.

Some 47 information centres launched campaigns to 74. publicize the special session of the General Assembly on the world drug problem, bringing together high-level governmental officials, non-governmental organizations, health-care professionals and members of the judicial system in a public debate on illicit drug use and trafficking and the United Nations role in reducing production and demand. Information products of the Department on this subject were translated and widely disseminated by information centres into 14 languages: Arabic, Azeri, Bahasa Indonesia, Bangla, Czech, Dutch, Farsi, German, Greek, Japanese, Polish, Portuguese, Russian and Spanish. In some instances, centres also posted materials on their Internet home pages, published special editions of their monthly newsletters highlighting the special session, and prepared special brochures and press kits, often in cooperation with local partners. High-visibility broadcast time slots projecting the United Nations message on drug control, including UNDCP public service announcements, were secured on local and regional television networks in some 20 countries.
