Review of the efficiency of the administrative and financial functioning of the United Nations

Administrative arrangements for the International Trade Centre UNCTAD/WTO

Note by the Secretary-General

1. General Assembly decision 53/410 of 26 October 1998 on the administrative arrangements for the International Trade Centre UNCTAD/WTO reads as follows:

"The General Assembly:

- "(a) Requests the Trade and Development Board of the United Nations Conference on Trade and Development and the Joint Advisory Group on the International Trade Centre UNCTAD/WTO to consider the proposals on new administrative arrangements for the International Trade Centre UNCTAD/WTO contained in the report of the Advisory Committee on Administrative and Budgetary Questions;¹
- "(b) Further requests those bodies to submit their comments, as a matter of priority, for its consideration."
- 2. The proposals of the Advisory Committee on Administrative and Budgetary Questions on the new administrative arrangements for the International Trade Centre were submitted to the Bureau of the Trade and Development Board of the United Nations Conference on Trade and Development and the Joint Advisory Group on the International Trade Centre earlier this month. Both the Board and the Group endorsed the proposals of the Advisory Committee and the President of the Board and the Chairman of the Group at its thirty-first session have advised the Chairman of the Fifth Committee accordingly. The communications from the President of the Board and the Chairman of the Group to the Chairman of the Fifth Committee are reproduced in annexes I and II to the present note.
- 3. The General Assembly may wish to take a decision on the administrative arrangements for the International Trade Centre UNCTAD/WTO, in the light of the endorsement of the proposals of the Advisory Committee (A/53/7/Add.3, para. 11) by the Trade and Development Board and the Joint Advisory Group.
