PROPOSED PROGRAMME BUDGET FOR THE BIENNIUM 1982-1983

International Computing Centre - 1982 budget estimates

Revised estimates under section 28G. Electronic Data Processing and Information Systems Division - International Computing

Centre, Geneva (United Nations share)

Report of the Secretary-General

I. International Computing Centre - 1982 budget estimates

- 1. The 1982 budget estimates of the International Computing Centre (ICC), Geneva, are summarized herein for review and approval by the General Assembly, in accordance with the procedure decided upon by the General Assembly in its resolution 31/208, section III. These estimates, amounting to \$5,343,100, are based on an exchange rate of SwF 1.85 to the dollar.
- ICC is a multiagency co-operative established in 1971 to serve all those organizations of the United Nations system wishing to participate in its activities. At the present time, the following organizations have become fully rarticipant members of ICC: United Nations, the World Health Organization, and the United Nations Development Fund (1971); the United Nations Children's Fund and the International Labour Organisation (1972); the World Meteorological Organization and the United Nations Research Institute for Social Development (1973); the United Nations Environment Programme and the General Agreement on Tariffs and Trade (1974); the World Intellectual Property Organization (1975); the International Bureau of Education of the United Nations Education, Scientific and Cultural Organization (1976); the International Trade Centre (1978) and the United Nations High Commissioner for Refugees (1981). The central computer facility, situated in Geneva, provides services to these organizations in Switzerland over leased lines. In addition, there is a communications link to the United Nations computer facility in New York, a telex link to Kenya and a dial-up link to the telex network worldwide.

- 3. ICC is funded from the data-processing element in the budgets of these organizations as approved by their governing bodies to finance the various projects in their work programmes. The acquisition of the resources required to implement the individual projects is co-ordinated by ICC, and their costs are consolidated into the present budget document.
- 4. Each year the organizations participating in ICC provide the Centre with an estimate of their probable usage of each of the above types of services costed at the rates agreed by the ICC Management Committee. Their estimates are broken down by ICC into the physical resources required to meet these demands and then, by grouping expenditure on similar resources, the Centre's budget by purpose of expenditure is developed.
- 5. Table 1 indicates the allocation of the 1982 budget, by purpose of expenditure, to organizational units and type of service. The entries in the body of this table represent the cost of each particular "resource group" needed to provide the service by a specific organizational unit of ICC.
- 6. Table 2 shows a summary of the budget estimates by purpose of expenditure and, for comparative purposes, the equivalent budget allocation for 1981.
- 7. Table 3 shows the funding of the ICC budget. It should be noted that some of the estimates have been received and included in a provisional form, being subject to the final review of agency governing bodies. The work of the participants ranges through a spectrum from well-articulated projects to more tentative undertakings in respect of which it is not possible to give precise estimates of the resources required. If the pattern evolved in previous years is repeated, then, as participants' work programmes become more specific during the course of the year, they will amend their funding of the various activities as the money they have allocated to individual services is used up or becomes unnecessary.
- 8. Table 4 presents the 1982 budget of ICC in a format similar to that of the United Nations.

Interagency review

- 9. In conjunction with the fifty-fifth session of the Consultative Committee on Administrative Questions (CCAQ) on financial and budgetary questions the proposed ICC budget estimates were reviewed by a panel composed of CCAQ participants from the organizations using the services of ICC, in accordance with the arrangements agreed upon by the Administrative Committee on Co-ordination (ACC) in October 1977 and April 1978.
- 10. During the financial review of the 1982 budget estimates, the Director of ICC noted that there was a movement away from the use of central computer facilities towards mini-computers and micro-computers. The Director commented on the Centre's requirements for 1982 and pointed out that as regards staff and related costs, the transition in 1981 from the traditional organization to one based on network services had resulted in the funding of nine Professional posts, of which three remained to be filled in 1982. A further drop in the demand for data entry

services had led to the funding of only two posts for such services. For 1982, 5 posts would be vacant and 10 would not be funded. Supplies and software expenditures varied from year to year since bulk purchasing agreements created a cyclical pattern. 1982 would be a high year for purchases of paper, particularly for use in remote printers and word processing equipment situated on the participants' premises. Increased provisions had also to be made for the rental and maintenance of generalized software packages, given the trend towards the use of commercial rather than custom written application software. The increased proposed for equipment rental and related costs resulted eventually from the expansion of the number of terminals installed, the direct access storage capacity, the telecommunications control unit and associated material.

- 11. The United Nations usage of ICC for 1982 based on an exchange rate of SwF 1.85 to \$US 1.00 is estimated at \$1,700,000, as indicated in table 4. The proposed programme budget for the biennium 1982-1983 1/ included a provisional amount of \$3,403,300 in respect of the United Nations share of the cost of operation of ICC -\$1,660,100 for 1982 and \$1,743,200 for 1983. At the rate of exchange assumed for the proposed programme budget for the biennium 1982-1983, i.e. SwF 1.71 to \$US 1.00, the estimated United Nations usage would be \$1,839,000, or \$179,000 above the amount included for 1982 in the proposed programme budget. No additional appropriation is however being requested at this stage. A programme of work consisting of the re-arrangement into a more compact form on magnetic tape of historical trade data collected by the Statistical Office is in the process of being completed. This programme, once established, is expected to lead to economies in storage and subsequent access to the data. In the context of the submission of the ICC budget estimates for 1983 at the thirty-seventh session of the General Assembly, the United Nations share of the cost of operations of ICC for 1982 and 1983 will be reviewed, on the basis of which it will be determined whether additional resources should be requested.
