Appointment of six members of the Committee on Contributions

Note by the Secretary-General

1. As indicated in document A/36/162 of 6 April 1981, it will be necessary for the General Assembly, during its current session, to appoint six persons to fill the vacancies in the Committee on Contributions as a result of the expiration, on 31 December 1981, of the terms of office of Mr. Amjad Ali, Mr. Denis Bauchard, Mr. Anatoly Semënovich Chistyakov, Mr. Miguel Angel Dávila Mendoza, Mr. Wilfried Koschorreck and Mr. Sung Hsin-chung.
2. The following persons have been nominated by their respective Governments for appointment or reappointment:

 - Mr. Anatoly Semënovich Chistyakov (Union of Soviet Socialist Republics)

 - Mr. Yang Hushan (China)
 - Mr. Philippe Zeller (France)
3. The candidates' curricula vitae follow:

AMJAD ALI

Syed Amjad Ali obtained his B.A. Honours Degree from Government College, Lahore, in 1927. He attended the Round Table Conference in London in 1931-32 as Honorary Secretary of the Muslim delegation. He also acted as Joint Secretary of the Indian delegation to the Joint Select Committee of the Parliament on Indian reforms in 1933. In 1937, he was elected member of the Punjab Legislative Assembly and appointed Parliamentary Private Secretary to the Chief Minister of the Province. In 1938, he attended the Commonwealth Relations Conference in Sydney. He was appointed Chief Whip of the Government's party in the Punjab Assembly in 1942.

In 1946, he was elected member of the Constituent Assembly of India. In 1950 he was appointed Minister of Economic Affairs in the Embassy of Pakistan in Washington D.C. and alternate Governor of the International Monetary Fund. The same year, he led the Pakistan delegation to the International Cotton Committee, and to the tenth session of the United Nations Economic and Social Council. In 1951, he led the Pakistan delegation to the annual meeting of the World Bank and IMF. In 1952, he was elected President of the Economic and Social Council, and Chairman of the General Assembly's Third Committee. The same year he led Pakistan's delegation to the World Bank and to the International Monetary Fund's annual meeting at Mexico City. He was named member of the Committee of Nine Experts by the Secretary-General of the United Nations to draw up plans for an international fund. In August 1953, appointed Pakistan's Ambassador to the United States. In September 1955, appointed Minister of Finance and Economic Affairs in the Government of Pakistan. He continued in that capacity until October 1958. Became Chairman of the Investment Promotion Bureau in September 1961.

In 1963, he was appointed by the Secretary-General of the United Nations a member of the Group of Experts to examine the progress of industrialization in developing countries. In February 1964, appointed Permanent Representative of Pakistan to the United Nations, and Deputy Leader of the Pakistan delegation to the United Nations Trade and Development Conference held at Geneva from March to July 1964. Elected Chairman of the Group of 75 developing countries at the United Nations Trade and Development Conference, Geneva. He was a Member of the Special Committee on Conciliation set up on the recommendation of the United Nations Conference on Trade and Development.

Chairman, United Nations Cocoa Conference, 1966. Leader of the Pakistan delegation to the Trade and Development Conference, fourth session, September 1966.

Member and Chairman of Committee on Contributions since 1967.

Leader, Pakistan delegation to UNCTAD Conference held at Lima in October 1971.

ANATOLY SEMĚNOVICH CHISTYAKOV

Anatoly SemĚnovich Chistyakov (born 1908) has the rank of Ambassador Extraordinary and Plenipotentiary. He is a graduate of the Moscow Institute of Economics, where he specialized in economic theory.

From 1938 to 1947 he was Deputy Chairman of the Board of Directors of the State Bank of the USSR. From 1947 to 1956 he held a responsible post on the central staff of the Ministry of Foreign Affairs of the USSR. From 1956 to 1962 he was Permanent Representative of the USSR to the European Office of the United Nations at Geneva. From 1962 to 1965 he was Chief of the South-East Asia Division of the USSR Ministry of Foreign Affairs. From 1965 to 1968 he was Chief of the International Economic Organizations Division of the USSR Ministry of Foreign Affairs. From 1968 to 1973 he was Ambassador of the USSR to Switzerland. From 1973 to the present date he has held a responsible post on the central staff of the USSR Ministry of Foreign Affairs. Since 1975 he has been a member of the International Civil Service Commission, and since 1976 a member of the Committee on Contributions.

WILFRIED KOSCHORRECK

Born in Kiel in 1935.

Studied economics and law at Innsbruck and Kiel Universities. Graduated from the Faculty of Law, Kiel University, in 1959.

1960-1964: preparatory legal service at the Higher Regional Court of Schleswig-Holstein; concurrently Assistant Professor at Kiel University Faculty of Law, and Adviser to the Legal Department of the Office of the United Nations High Commissioner for Refugees in Geneva.

Entered the Federal Ministry of Economics in Bonn in 1963. Served in the division concerned with customs policy specifically within the European Economic Community, and assisted in the development of a General System of Preferences (GSP) in favour of developing countries.

Charged with special tasks in the field of banking and tax policy in 1967.

1968-1969: assigned to the Permanent Mission of the Federal Republic of Germany to the European Economic Community in Brussels; activities in the field of the foreign relations of the Community, with particular emphasis on questions of association policy.

Transferred back to the Federal Ministry of Economics in 1969.

1970-1971: charged with tax reform questions.

Entered Federal Ministry of Finance in 1971, in charge of Public Relations Section.

Since 1974, Chief of International Finance Section, dealing, inter alia, with:
financial and bugetary questions of the United Nations system;
financial and budgetary questions of OECD and of its special activities;
financial questions arising from international commodity agreements;

fundamental issues of financing development assistance;

the Development Committee of IBRD/IMF;

the Conference for International Economic Co-operation (CIEC) in Paris.

Various publications on tariff and trade policy, political and legal questions of the United Nations, tax and banking law, press and public relations, and development assistance.

Member, in a personal capacity, of the Committee on Contributions since 1 January 1977.

YANG HUSHAN

Mr. Yang Hushan completed his education at Peking University in 1951 and joined the Foreign Service of the People's Republic of China in 1954.

He served successively in the Departments of International Affairs, European and American Affairs and International Organizations, Conferences, Law and Treaties of the Ministry of Foreign Affairs and held the posts of Deputy Chief and then Chief of Division.

Mr. Yang participated in numerous international conferences including the twenty-seventh, twenty-eighth and thirty-second sessions of the General Assembly of the United Nations as adviser to the Chinese delegation.

He served as an adviser to the Chinese delegation to the first special session of the General Assembly devoted to disarmament and subsequently participated in the work of the Disarmament Commission of 1979 as alternate representative of China. He was appointed Chinese representative to the Committee on Disarmament in 1980 and was Chinese member of the Group of Governmental Experts to Study the Institutional Arrangements Relating to the Process of Disarmament.

Mr. Yang participated in the recently concluded International Conference on Kampuchea and is currently Counsellor of the Permanent Mission of the People's Republic of China to the United Nations and alternate representative of China on the Security Council.

PHILIPPE ZELLER

Born on 3 October 1952 in Lyon (France).

Graduated from the Ecole des hautes études commerciales (Paris, 1974).

Former student of the Ecole nationale d'administration (Paris, 1978).

Present functions:

Secretary, Foreign Affairs;

Assistant to the Deputy Director for the Budget and Financial Affairs, French Ministry of External Relations. In this capacity he is responsible inter alia for the preparation, negotiation and management of the budget of the Ministry of External Relations and for the payment of France's international contributions;
