## PROVISIONAL AGENDA AND ANNOTATIONS

### Note by the Executive Secretary

#### Addendum

1. This addendum to the provisional agenda and annotations for the Conference of the Parties (COP) at its fourth session contains information on:
  - Documents that have been prepared for the session and documents from previous sessions that will be made available (annex I);
  - The proposed allocation of each item on the provisional agenda and the relevant documentation (annex II); and
  - A tentative schedule of meetings for the COP plenary, the Subsidiary Body for Scientific and Technological Advice (SBSTA) and the Subsidiary Body for Implementation (SBI) (annex III).
  
5. Parties are invited to note that there are some modifications in the proposed allocation of items as well as in the proposed schedule. The latter are designed to ensure that work is begun as early as possible, that some conclusions and/or decisions are recommended by the subsidiary bodies for adoption by the COP on Friday, 6 November 1998 and that the subsidiary bodies complete their work by the close of their sessions on 10 November 1998.

3. With regard to the provisional agenda for COP 4 (FCCC/CP/1998/1, pages 3-6), the attention of the secretariat has been drawn to the possibility of the words “international emissions trading” in item 5 (a) (iv) being understood as a reference to global trade in emissions, and not simply a way to distinguish Article 17 trading from domestic trading. To avoid further misunderstanding of this terminology, the deletion of the words in parentheses will be proposed when the agenda is presented for adoption. For the sake of consistency, the deletion of the words in parentheses after item 5 (a) (iii) of the provisional agenda for COP 4 will also be proposed.
