**ПЛАН ЮНКТАД В ОБЛАСТИ ТЕХНИЧЕСКОГО СОТРУДНИЧЕСТВА
НА 1999-2001 ГОДЫ**

Записка секретариата ЮНКТАД

1. В пункте 98 документа "Партнерство в целях роста и развития" (TD/378/Rev.1) ЮНКТАД IX предложила Совету ежегодно рассматривать "ориентировочный, составляемый по скользящей схеме трехгодичный план в области технического сотрудничества".
2. Составленный по скользящей схеме трехгодичный план технического сотрудничества на 1998-2000 годы (TD/B/EX(16)/2) был рассмотрен и одобрен шестнадцатой исполнительной сессией Совета по торговле и развитию 16 февраля 1998 года.
3. Рабочая группа на первой части своей тридцать второй сессии, проходившей с 21 по 28 сентября 1998 года, провела попрограммный обзор деятельности ЮНКТАД в области технического сотрудничества за 1997 год (TD/B/45/6 и Add.1 и 2). Рабочая группа представила Совету по торговле и развитию проект решения, который был принят Советом на его сорок пятой сессии в октябре 1997 года в качестве решения 455(XLV), где он обратился к секретариату с просьбой "подготовить по скользящей схеме трехгодичный план технического сотрудничества на 1999-2001 годы в упрощенной форме для рассмотрения Рабочей группой на второй части ее тридцать второй сессии в декабре 1998 года и затем Советом по торговле и развитию в 1999 году".

4. Представляемый в настоящем документе план был подготовлен во исполнение этой просьбы. Он основан на перечне проектов, представленном Рабочей группе в документе TD/B/45/6/Add.1. В нем в упрощенной форме изложена информация по вопросам существа и по финансовым аспектам.

5. План ЮНКТАД в области технического сотрудничества на 1999-2001 годы состоит из двух частей: часть I содержит сводную таблицу, а в части II приведены рабочие схемы, на которых основана эта таблица.

6. План сориентирован на осуществление стратегии ЮНКТАД в области технического сотрудничества, принятой Советом на его пятнадцатой исполнительной сессии в июне 1997 года.

7. Он призван также:

a) проинформировать делегации, сотрудничающие организации и другие заинтересованные стороны об оперативной деятельности ЮНКТАД в 1998 году, о деятельности, которая была одобрена на 1999 год и последующие годы, а также о деятельности, предлагаемой секретариатом на период 1999-2001 годов;

b) облегчить диалог с потенциальными донорами по вопросам мобилизации необходимых внебюджетных ресурсов для осуществления плана; и

c) служить контрольным механизмом для секретариата.

8. Приводимая здесь информация сгруппирована по следующим разделам:

a) фактические расходы, произведенные в 1998 году, по состоянию на 31 октября 1998 года;

b) одобренная/текущая деятельность, в рамках которой осуществляются проекты в соответствии с проектными документами, согласованными с донорами;

c) разрабатываемые проекты (выделенные **жирным шрифтом**), которые находятся практически на завершающей стадии обсуждения с донорами и, следовательно, имеют значительные шансы быть утвержденными;

d) новая или предлагаемая деятельность, которая выделяется в таблицах **жирным шрифтом**. Такие предложения включены в план исходя из следующих соображений (одного или более):

i) непосредственная просьба, поступившая от развивающейся страны или страны с переходной экономикой и нашедшая поддержку у секретариата, который готов принять ее к исполнению при условии мобилизации необходимых средств; или

- ii) осуществление мер, предложенных ЮНКТАД IX, Советом или одной из комиссий; или
- iii) осуществление программы работы, изложенной в описательной программной части бюджета по программам ЮНКТАД на 1999-2000 годы; или
- iv) попытка определить порядок приоритетности различных предложенных видов деятельности в области технического сотрудничества; в этот вариант плана были включены только те проекты, которые по тем или иным из приведенных выше причин были сочтены действительно приоритетными.

9. Поскольку реализация части этого плана находится в зависимости от мобилизации дополнительных ресурсов, это значит, что рассчитывать на осуществление всех этих предложений никак нельзя. Помимо этого будут поступать новые просьбы, а уже сформулированные предложения могут пересматриваться, порождая необходимость в постоянных изменениях и корректировках плана.

10. План был подготовлен одновременно с бюджетом по программам на двухгодичный период 2000-2001 годов, и процессы подготовки обоих документов были тесно связаны друг с другом.

11. В приложении даются пояснения к кодовым обозначениям стран, которые используются при перечислении проектов.
