INFORMATION CIRCULAR Nº 4254/Rev.23

Subject: Rates for short-term Professional staff and translators and revisers engaged for short-term service

- 1. The rates of short-term Professional staff and locally-recruited translators and revisers engaged for conference or other short-term service by the United Nations Office at Geneva have been revised, effective 1 November 1998, to reflect the application of a revised post adjustment multiplier of 66.7, effective as of the same date.
- 2. The rates for non-locally recruited short-term translators and revisers have also been revised, effective 1 November 1998 to reflect the application of revised cost of living supplements effective as of the same date.
- 3. The revised rates are reproduced in annexes I, II and III to the present circular.
