SUMMARY STATEMENT BY THE SECRETARY-GENERAL ON MATTERS
OF WHICH THE SECURITY COUNCIL IS SEIZED AND ON THE
STAGE REACHED IN THEIR CONSIDERATION

Addendum

Pursuant to rule 11 of the provisional rules of procedure of the Security Council, the Secretary-General is submitting the following summary statement.

The list of items of which the Security Council is seized is contained in documents S/1998/44 of 9 January 1998, S/1998/44/Add.13 of 9 April 1998, S/1998/44/Add.16 of 1 May 1998, S/1998/44/Add.19 of 22 May 1998, S/1998/44/Add.25 of 2 July 1998, S/1998/44/Add.26 of 10 July 1998, S/1998/44/Add.28 of 24 July 1998 and S/1988/44/Add.32 of 21 August 1998.

During the week ending 12 September 1998, the Security Council met at its 3923rd meeting, held on 9 September 1998, to consider its draft report to the General Assembly covering the period from 16 June 1997 to 15 June 1998.

The Security Council adopted the draft report without a vote and the decision was reflected in a note by the President of the Council (S/1998/843).

Also, during the week ending 12 September 1998, the Security Council took action on the following item:

The situation between Iraq and Kuwait (see S/21100/Add.30-33, 36-38, 42, 43 and 47; S/22110/Add.6-9, 13, 14, 17, 20, 24, 25, 32, 37 and 40; S/23370/Add.8, 11, 28, 34 and 39; S/25070/Add.1, 2, 5, 21, 24 and Corr.1, 26 and 47; S/1994/20/Add.8, 39-41 and 45; S/1995/40/Add.14; S/1996/15/Add.11, 12, 23 and 33; S/1997/40/Add.15, 22, 23, 24, 36, 42, 43, 45, 48 and 51; and S/1998/44/Add.2, 7, 9, 12, 19 and 24; see also S/23370/Add.10, 32, 35 and 47)

The Security Council resumed its consideration of the item at its 3924th meeting, held on 9 September 1998, in accordance with the understanding reached in its prior consultations.

The President drew attention to the text of a draft resolution (S/1998/841) which had been submitted by Costa Rica, the United Kingdom of Great Britain and Northern Ireland and the United States of America.

The Security Council proceeded to vote on draft resolution S/1998/841 and adopted it unanimously as resolution 1194 (1998) (for the text, see S/RES/1194 (1998); to be issued in Official Records of the Security Council, Fifty-third Year, Resolutions and Decisions of the Security Council, 1998).
