SUMMARY STATEMENT BY THE SECRETARY-GENERAL ON MATTERS OF
WHICH THE SECURITY COUNCIL IS SEIZED AND ON THE STAGE
REACHED IN THEIR CONSIDERATION

1. Pursuant to rule 11 of the provisional rules of procedure of the Security Council, the Secretary-General wishes to submit hereunder the list of items of which the Security Council is currently seized, with references in parentheses to the previous summary statements that have been issued covering consideration of each item.¹
2. It will be recalled that, in the interest of economy, the Secretary-General reproduces only once annually the full, up-to-date list of items of which the Security Council is seized. In fulfilment of his responsibility under rule 11, an addendum to the basic list is issued weekly, making reference to those items on which further action has been taken by the Council during the week covered or indicating that there has been no change during that period.
3. The last full summary statement (S/1998/44 and Corr.1) was issued on 9 January 1998. The last weekly addendum (S/1998/44/Add.52) covered developments up to 2 January 1999.
4. Also during this period, the Security Council included the following item on the agenda of its 3923rd meeting, held on 9 September 1998, and concluded its consideration of the item at the same meeting:

"Consideration of the draft report of the Security Council to the General Assembly" (see S/1998/44/Add.36).

5. Pursuant to the procedure set out in the note by the President of the Security Council of 29 August 1996 (S/1996/704), the Secretary-General, in his summary statement of 9 January 1998 on matters of which the Security Council is seized and on the stage reached in their consideration (S/1998/44 and Corr.1),

The Security Council resumed its consideration of the item at its 3963rd meeting, held on 7 January 1999 in accordance with the understanding reached in its prior consultations.

The President, with the consent of the Council, invited the representative of Sierra Leone, at his request, to participate in the discussion without the right to vote.

The President stated that, following consultations of the Council, he had been authorized to make a statement on behalf of the Council and read out the text of that statement (for the text, see S/PRST/1999/1; to be issued in Official Records of the Security Council, Fifty-fourth Year, Resolutions and Decisions of the Security Council, 1999).
