Annual note by the United Nations Administrative Tribunal

1. At its third plenary session, held in Paris on 20 December 1951, the Administrative Tribunal decided to submit a note each year to the President of the General Assembly. In accordance with that decision, the following note is submitted in respect of the year 1998.

A. Appointment of members of the Tribunal by the General Assembly

2. At its 76th plenary meeting, on 18 December 1997, the General Assembly, on the recommendation of the Fifth Committee (see A/52/674/Rev.1), appointed Mr. Chittharanjan Felix Amerasinghe, Mr. Victor Yenyi Olungu and Mr. Hubert Thierry as members of the United Nations Administrative Tribunal for a three-year term of office beginning on 1 January 1998. On 31 March 1998, the Assembly appointed Mr. Kevin Haugh to serve as a member of the Tribunal for the remainder of the term of the late Mr. Francis Spain.

E. Schedule for 1999 sessions

6. Taking into consideration the number of cases so far submitted to it, the Tribunal decided that the first ordinary session, referred to in article 6, paragraph 2, of its rules, would be held in Geneva beginning in June 1999, and that its second session would be held at Headquarters during the last quarter of 1999, pursuant to articles 5.1 and 6.2 of its rules.

F. Operational issues

7. In its annual note for the year 1991, the Tribunal requested the General Assembly to convert two of the posts in its four-member secretariat, one Professional and one General Service, into permanent posts. Those two posts had been allotted to the Tribunal on a temporary basis since 1989, after it had been recognized that the caseload of the Tribunal

required the additional posts. In its annual note for the year 1997, the Tribunal informed the General Assembly that those two posts, rather than being made permanent, had been abolished. The Tribunal's secretariat is now composed of only two staff posts and relies on temporary assistance funds to maintain two temporary positions. The Tribunal wishes to draw the attention of the General Assembly to the fact that in the years 1950-1984, when the Tribunal's secretariat consisted of two staff members, the Tribunal rendered 342 judgements, or approximately 10 per year. In the years 1985-1988, the Tribunal rendered 97 judgements, or approximately 24 per year. In 1989, when its secretariat was increased to four staff members, the Tribunal rendered 32 judgements. Over the next several years, as the Tribunal's jurisdiction was expanded by the General Assembly and its caseload grew, the number of judgements that the Tribunal rendered increased steadily until it had almost doubled. In 1996, for example, the Tribunal rendered 61 judgements, and in 1997, it rendered 60 judgements. Unless the two abolished posts are restored as staff posts, the Tribunal's ability to fulfil its mandate will be severely impaired.
