ANNOTATIONS TO THE PROVISIONAL AGENDA

1. Adoption of the agenda

Delegations will have the provisional agenda before them, for consideration and adoption with whatever modifications they may deem appropriate.

2. <u>Progress report by the Chairperson, in particular regarding the implementation of the</u> resolution adopted by the Regional Conference at its seventh session on activities in follow-up to the Regional Programme of Action for the Women of Latin America and the Caribbean

Pursuant to the resolution adopted by the Regional Conference at its seventh session on activities in follow-up to the Regional Programme of Action for the Women of Latin America and the Caribbean, 1995-2001, the Chairperson of the Presiding Officers participated, as a member of the delegation of Chile, at the twenty-seventh session of the Economic Commission for Latin America and the Caribbean (ECLAC) (Aruba, 11-16 May 1998). On that occasion, the Chairperson presented the Santiago Consensus and outlined the work of the Presiding Officers.

3. Follow-up to United Nations world conferences and summits and their provisions regarding the mainstreaming of the gender perspective

The secretariat will prepare a set of reference documents concerning agreements on gender and the advancement of women adopted at United Nations world conferences and summits, particularly at the United Nations Conference on Environment and Development, the World Conference on Human Rights, the International Conference on Population and Development, the World Summit for Social Development and the United Nations Conference on Human Settlements (Habitat II). The Government of Chile, through an official from the Ministry of Foreign Affairs, will present a document on follow-up to those agreements, prepared by the Director of the Office for Multilateral Policy of the Ministry. This input will serve as the basis for discussion.

4. <u>Review of the activities of the Presiding Officers and of the ECLAC secretariat since the twenty-fifth meeting of the Presiding Officers, including evaluation of the seventh session of the Regional Conference</u>

- (a) Evaluation of the seventh Regional Conference with reference to selected themes, the outlines of position papers prepared by the Presiding Officers, statements by the countries, the working methods used and the content of the Santiago Consensus;
- (b) Reports by the ECLAC member countries represented by the Presiding Officers on activities carried out since the election of the current Presiding Officers, pursuant to mandates contained in the Regional Programme of Action and the Santiago Consensus;
- (c) Analysis of the distribution of responsibility among the countries represented by the Presiding Officers and adoption of any necessary changes;¹

- (d) Presentation by the secretariat of "The fiscal covenant: strengths, weaknesses, challenges", a substantive document of the twenty-seventh session of ECLAC;
- (e) Report by the secretariat on activities carried out since the seventh Regional Conference, particularly those which led to the adoption of a proposal during the twenty-seventh session of ECLAC (Aruba, May 1998); to create a subprogramme to promote the mainstreaming of the gender perspective in the principal areas of regional development; measures already adopted to institutionalize the gender perspective; gender-related tasks under way within various divisions of ECLAC; implementation of the project on indicators currently being carried out jointly by ECLAC and the Latin American Faculty of Social Sciences (FLACSO); and updating of the directory of national organizations dealing with programmes and policies on women in Latin America and the Caribbean.

5. <u>Review of follow-up to the Regional Programme of Action, in particular in strategic areas</u> not considered at the seventh session of the Regional Conference

Since the debates at the seventh session of the Regional Conference focused on issues relating to power and decision-making and to poverty, the Presiding Officers will analyse the other six strategic areas of the Regional Programme of Action, namely:

Area I:	Gender equity
Area II:	Economic and social development with a gender perspective: women's equitable share in the decisions, responsibilities and benefits of development
Area V:	Human rights, peace and development
Area VI:	Shared family responsibilities
Area VII:	Recognition of cultural plurality in the region
Area VIII:	International support and cooperation
