# APPOINTMENTS TO FILL VACANCIES IN SUBSIDIARY ORGANS AND OTHER APPOINTMENTS <br> Appointment of five members of the International Civil Service Commission 

## Report of the Fifth Committee

Rapporteur: Mr. Mario MARTORELL (Peru)

1. At its 79th meeting, on 16 December 1981, the Fifth Committee considered a note by the Secretary-General (A/36/166) concerning the vacancies which would occur in the International Civil Service Commission as a result of the expiration on 31 December 1981 of the terms of office of five of its members.
2. The Fifth Committee also had before it a note by the Secretary-General (A/C.5/36/108), in his capacity as Chairman of the Administrative Committee on Co-ordination, suggesting the names of five persons for appointment to fill the vacancies that would arise on 1 January 1982.
3. At the same meeting, the representative of Finland proposed that the Fifth Committee should hold an election to decide on the persons to be recommended for appointment to the Commission with all five of the candidates submitted by the Group of Western European and Other States being considered; the Secretary-General had proposed the names of three persons from this Group.
4. By 78 votes to 8 , with 16 abstentions, the Fifth Committee decided that the nominees should be determined by an election.
5. Acting on a proposal by the Chairman, the Fifth Committee decided by acclamation to recommend the appointment of Mr. Akira Matsui (Japan) and Mr. Antonio Fonseca Pimentel (Brazil).

6. The Fifth Committee then proceeded to el ct by sccret ballot the three
remaining nominees from amone the five candidates subitted by the Group of
Wesiern European and Other States. The result of the voting was as follows:

Mr. Fielmut Kitschenberg (Federal Republic of Germany), having received the required majority, were declared recommended, together with Mr. Akira Matsui (Japan) and Mr. Antonio Fonseca Pimentel (Brazil), for appointment as members of the International Civil Service Coramission for a fourwyear term beginning on 1 January 1982.
