APPOINTMENTS TO FILL VACANCIES IN SUBSIDIARY ORGANS AND OTHER APPOINTMENTS

Appointment of six members of the Joint Inspection Unit

Note by the President of the General Assembly

1. By its resolution 31/192 of 22 December 1976, the General Assembly approved the statute of the Joint Inspection Unit. The relevant provisions of the statute regarding the composition of the Unit and the appointment of its members are the following:

### "Article 2

- "1. The Unit shall consist of not more than eleven Inspectors, chosen from among members of national supervision or inspection bodies, or from among persons of a similar competence on the basis of their special experience in national or international administrative and financial matters, including management questions. The Inspectors shall serve in their personal capacity.
  - "2. No two Inspectors shall be nationals of the same State.

### "Article 3

- "1. Starting from the thirty-second session of the General Assembly, in 1977, the President of the General Assembly shall consult with Member States to draw up, with due regard to the principle of equitable geographical distribution and of reasonable rotation, a list of countries which would be requested to propose candidates who meet the qualifications mentioned in article 2, paragraph 1, above.
- "2. The President of the General Assembly, through appropriate consultations, including consultations with the President of the Economic and Social Council and with the Chairman of the Administrative Committee on Co-ordination, shall review the qualifications of the proposed candidates. After further consultations, if necessary, with the States concerned, the President of the General Assembly shall submit the list of candidates to the Assembly for appointment.

### "Article 4

- "1. The duration of the appointments of the Inspectors shall be five years, renewable for one further term. ..."
- 2. At present, the Joint Inspection Unit is composed of the following members:
  - Mr. Mark Allen (United Kingdom of Great Britain and Northern Ireland)\*
  - Mr. Maurice Bertrand (France) \*\*
  - Mr. Alexander Sergeevich Bryntsev (Union of Soviet Socialist Republics)\*
  - Mr. Alfred Nathaniel Forde (Barbados) \*\*
  - Mr. Toman Hutagalung (Indonesia) \*
  - Mr. Moustapha Ould Khalifa (Mauritania) \*\*
  - Mr. Julio C. Rodríguez Arias (Argentina)\*
  - Mr. Joseph Adolph Sawe (United Republic of Tanzania)\*
  - Mr. Zakaria Sibahi (Syrian Arab Republic) \*
  - Mr. Earl D. Sohm (United States of America) \*\*
  - Mr. Miljenko Vukovic (Yugoslavia) \*\*

<sup>3.</sup> The General Assembly will therefore be called upon to appoint six members of the Joint Inspection Unit to fill the vacancies that will arise from the expiration of the terms of office of Mr. Allen, Mr. Bryntsev, Mr. Hutagalung, Mr. Rodríguez Arias, Mr. Sawe and Mr. Sibahi.

<sup>4.</sup> As a result of consultations and on the basis of nominations received from the regional groups (see annexes I to V), the President of th General Assembly has drawn up, in accordance with article 3, paragraph 1, of the statute, a list of Member States which have been requested to propose candidates who meet the

qualifications mentioned in article 2, paragraph 1. The list consists of the following Member States:

Egypt
Indonesia
Panama
Syrian Arab Republic
Union of Soviet Socialist Republics
United Kingdom of Great Britain and Northern Ireland.

5. After holding the consultations described in article 3, paragraph 2, of the statute, including consultations with the President of the Economic and Social Council and with the Secretary-General in his capacity as Chairman of the Administrative Committee on Co-ordination, the President of the General Assembly will submit the list of candidates to the Assembly for appointment.
