THIRD UNITED NATIONS CONFERENCE ON THE EXPLORATION AND PEACEFUL USES OF OUTER SPACE

Vienna 19-30 July 1999

Report of the pre-Conference consultations held in Vienna on 18 July 1999

I. Introduction

1. The pre-Conference consultations were held on 18 July 1999 at the Austria Center Vienna. Participation was open to representatives of all States Members of the United Nations.

2. The consultations were chaired by N. Jasentuliyana, the executive secretary of the Third United Nations Conference on the Exploration and Peaceful Uses of Outer Space (UNISPACE III). U. R. Rao, Chairman of the Preparatory Committee for UNISPACE III, reported on the work that the Preparatory Committee had conducted.

3. The following documents were before the pre-Conference consultations:

(a) Matters for consideration in the pre-Conference consultations to be held in Vienna on 18 July 1999 (A/CONF.184/PRE-CONF/L.1);

(b) Provisional agenda of the Third United Nations Conference on the Exploration and Peaceful Uses of Outer Space (A/CONF.184/1);

(c) Provisional rules of procedure of the Third United Nations Conference on the Exploration and Peaceful Uses of Outer Space (A/CONF.184/2);

(d) Final programme of the Conference;

(e) Programme of the opening ceremony.

4. The matters considered in the pre-Conference consultations and the recommendations agreed upon are set out below.

II. Recommendations agreed upon in the pre-Conference consultations

A. Opening of the Conference (item 1 of the provisional agenda of the Conference)

5. The executive secretary of the Conference provided, for the information of the representatives, details of the programme for the opening meeting and organizational arrangements made by the Secretariat at the Conference site. It was agreed to recommend the arrangements to the Conference.

B. Election of the President of the Conference (item 2)

6. It was recommended that the Conference should elect by acclamation U. R. Rao (India), Chairman of the Committee on the Peaceful Uses of Outer Space, as President of the Conference.

C. Adoption of the rules of procedure and the agenda (item 4)

7. It was recommended that the Conference should adopt the provisional rules of procedure (A/CONF.184/2, annex) with the following modifications to the texts of rules 7, 15 and 16 to reflect the recommendations of the Preparatory Committee:

(a) The text of rule 7 should be changed so that the Rapporteurs of Committee I and Committee II will serve as Vice-Chairmen of those bodies;

(b) Under rule 15, representatives of those space-related international organizations identified and called upon under item 7 of the provisional agenda of the Conference should be permitted to make statements on their reports in the Plenary, Committee I and Committee II;

(c) Rule 16 should be applied to the participation of national organizations.

8. It was recommended that the Conference should adopt the provisional agenda (A/CONF.184/1) as recommended by the Preparatory Committee.

D. Establishment of the committees and election of other officers (item 5)

1. Establishment of the committees and organization of work

9. It was recommended that, in accordance with rules 4 and 5 of the provisional rules of procedure, the Conference should establish two main committees, Committee I and Committee II, as well as a Technical Forum as a technical body of the Conference. With regard to the organization of the meetings of the Conference, the following arrangements were recommended:

(a) The Conference will commence with the Plenary and will break into Committee I and Committee II, which should consider substantive items of the provisional agenda (items 7-12), on the understanding that no more than two meetings of those bodies will be held simultaneously except where it is considered absolutely necessary and interpretation and other facilities can be provided. The items of the provisional agenda should be allocated as follows:

Plenary:items 1-6 and 13-15Committee I:items 7, 9, 10 and 12

Committee II: items 8 and 11

(b) Chapter IV of the draft report of the Conference (A/CONF.184/3 and Corr.1 and 2), covering the substantive agenda items, will be considered by Committee I and Committee II. Before commencing the consideration of each agenda item covered in each section in chapter IV, the Chairman of the appropriate main committee will provide representatives of Member States, at their request, with opportunities to make brief general remarks on the item, bearing in mind that a general exchange of views will take place in the Plenary. The other chapters of the draft report will be considered in the Plenary (see paragraph 16 below);

(c) The work of the Technical Forum will commence with a statement by its Chairman on the first day of the Plenary;

(d) Committee I, Committee II and the Technical Forum will report to the Plenary, which will reconvene to consider their reports and adopt the report of the Conference;

(e) During the first week of the Conference, meetings of the Plenary, Committee I and Committee II should be scheduled, in principle, from 9 a.m. to noon and from 3 p.m. to 6 p.m., except for the morning meeting on Monday, 19 July, which will begin at 10 a.m., and the afternoon meeting on Tuesday, 20 July, which will be scheduled from 2.30 p.m. to 5.30 p.m. During the second week of the Conference, meetings should be scheduled, in principle, from 9.30 a.m. to 12.30 p.m. and from 3 p.m. to 6 p.m., except for the morning meeting on Friday, 30 July, which will be scheduled from 10 a.m. to 1 p.m. (see annex I);

(f) Technical presentations by representatives of Member States and international organizations that indicated their intention of making presentations by the deadline agreed upon by the Advisory Committee for UNISPACE III should be scheduled from Monday, 26 July to Wednesday, 28 July, immediately following the morning meetings of Committee I and Committee II, from 12.30 p.m. to 13.30 p.m., without simultaneous interpretation;

(g) Presentations by representatives of space-related industries should be scheduled from Tuesday, 20 July, to Friday, 23 July, from 9 a.m. to 6 p.m., on a first-come first-served basis.

2. Election of other officers

10. It was recommended that, in accordance with rule 7 of the provisional rules of procedure and the recommendations of the Preparatory Committee, the Conference should elect the following officers, in addition to the President of the Conference, to constitute the General Committee: Vice-President and Rapporteur-General of the Plenary; the Chairman, Vice-Chairman and Vice-Chairman/Rapporteur of Committee I; the Chairman, Vice-Chairman and Vice-Chairman/Rapporteur of Committee II; and the Chairman of the Technical Forum.

11. In accordance with the recommendations of the Preparatory Committee, it was also recommended that the following individuals should be nominated as the candidates for the offices of the General Committee (see also paragraph 6 above):

3. Appointment of the members of the Credentials Committee

12. It was recommended that, in accordance with rule 3 of the provisional rules of procedure and the recommendations of the Preparatory Committee, the Conference should appoint China, Fiji, Jamaica, Mali, New Zealand, the Russian Federation, the United States of America, Venezuela and Zimbabwe as members of the Credentials Committee, on the understanding that, if a State is not present, the Conference should replace that State by another State from the same regional group, as designated by that group. The Credentials Committee should present its report to the Conference as soon as the report is available.

E. General exchange of views (item 6)

13. The following were recommended:

(a) The general exchange of views should be held in the Plenary starting on Monday, 19 July, and should be concluded by Thursday, 22 July, and there should be no general exchange of views in Committee I or Committee II;

(b) The list of speakers for the general exchange of views should be closed on Tuesday, 20 July;

(c) While it is desirable that statements by Member States during the general exchange of views not exceed 10 minutes, that time limit should be indicative and interpreted with flexibility. In accordance with rule 14 of the provisional rules of procedure, organizations of the United Nations system and international organizations having permanent observer status with the General Assembly or the Committee on the Peaceful Uses of Outer Space should be permitted to deliver general statements limited to 7 minutes. The full texts of such statements may be circulated in writing. International organizations not having permanent observer status with the General Assembly or the Committee on the Peaceful Uses of Outer Space should be permitted to submit general statements in writing to the Plenary.

F. Activities of the Technical Forum (item 13)

14. The following recommendations were made regarding the activities of the Technical Forum (see annex II):

(a) Results and proposals emanating from each activity of the Technical Forum should be reviewed and forwarded by the Chairman of the Technical Forum to the Plenary, Committee I or Committee II for consideration;

(b) The Space Generation Forum should present its report to Committee I under item 9 of the provisional agenda as soon as the report is available. Proposals of the Space Generation Forum should be submitted to the Chairman of the Technical Forum, who will forward them to Committee I or Committee II, as appropriate, for consideration.

G. Adoption of the report of the Conference (item 14)

15. It was recommended that the report of the Conference should consist of the decisions of the Conference, a brief account of the events leading to the convening of the Conference, the proceedings, including a summary of the general exchange of views in the Plenary, a narrative of the organization of work and procedures of the main committees and the Technical Forum, including the action taken in plenary meetings on the recommendations prepared by the main committees.

16. It was also recommended that, while the sections of chapter IV of the draft report should be considered by Committee I and Committee II, forming the basis for the work of those committees, chapters I-III and V and the summary of the draft report should be considered by the Plenary under item 14 of the provisional agenda, on the adoption of the report of the Conference (see also paragraph 9 (b) above).

17. It was further recommended that, in accordance with rule 6 of the provisional rules of procedure, the Conference should establish a Drafting Group, chaired by the Rapporteur-General of the Plenary and consisting of the two designated representatives from each of the five regional groups, together with any additional representatives of the Member States invited by the Rapporteur-General to assist in the preparation of the full draft report. The following individuals were recommended as candidates from the regional groups to be included in the Drafting Group: Dawlat Hassen (Egypt), Mongezi Tshongweni (South Africa), Sridhara Murthy (India), Mazlan Othman (Malaysia), Dumitru Dorin Prunariu (Romania), Arif Mehdiyev (Azerbaijan), Alejandra Bonilla (Colombia), Raúl Pelaez (Argentina), Gabriella Venturini (Italy) and Lynne F. H. Cline (United States). The Drafting Group may consider any matters referred to it by Committee I, Committee II or the Rapporteur-General.

H. Indicative schedule of work of the Conference
