Note by the Secretary-General

- 1. By a communication dated 18 December 1981, addressed to States Parties to the Statute of the International Court of Justice, the Secretary-General drew attention to the vacancy in the International Court of Justice caused by the death of Judge Abdullah El-Erian (Egypt) on 12 December 1981. In the same communication, the Secretary-General, in accordance with Article 5 of the Statute of the Court, invited national groups to undertake the nomination of persons in a position to accept the duties of a member of the Court. The Secretary-General further requested that nominations should be received by 18 February 1982.
- 2. On 4 March 1982, the Secretary-General transmitted to the General Assembly and to the Security Council, in accordance with Article 7 of the Statute of the Court, a list, in alphabetical order of all the persons thus nominated (A/36/862-S/14886 and Corr.1). The withdrawal of certain candidates, received after the issue of the list, was communicated to the Assembly and to the Council in addenda to the list (A/36/862/Add.1-4-S/14886/Add.1-4). Nominations received after 18 February 1982 were circulated in a separate document (A/36/864-S/14896 and Add.1).
- 3. The composition of the Court and the procedure in the General Assembly and the Security Council for filling the vacancy are given in a memorandum by the Secretary-General, issued as document A/36/861-S/14885 and Corr.l. The curricula vitae of the candidates appear in document A/36/863-S/14887.
- 4. At its 106th plenary meeting, on 16 March 1982, the General Assembly decided to request the Secretary-General to issue a revision of the list of candidates, so as to reflect all the latest information in a single document. In response to this request, the Secretary-General has the honour to submit the attached list.
