- 16. For the review of progress in the implementation of the Programme of Action, the Board will have before it the *Overview* of the *Least Developed Countries 1999 Report*. The main theme of the *Report* is improving productive capacity of LDCs and enhancing their competitiveness. The Board will also have available to it the report of the Secretary-General of the United Nations to the General Assembly on the implementation of the Programme of Action.
- 17. For the review of the status of the preparatory process for the Third UN Conference on LDCs, the Board will have available to it the report of the Secretary-General of the United Nations to the General Assembly being prepared in accordance with General Assembly resolution 53/182. The report will review the proposed preparatory process at the country regional and global level.
