STATEMENT BY THE CHAIRMAN OF THE COMMISSION ON THE LIMITS OF THE CONTINENTAL SHELF ON THE PROGRESS OF WORK IN THE COMMISSION

- 1. The sixth session of the Commission on the Limits of the Continental Shelf was held at United Nations Headquarters, New York, from 30 August to 3 September 1999. The Commission held a total of 10 meetings.
- 2. The following 19 members of the Commission attended the session:

 interest to which they had to attend.
- 3. The Commission had before it the following documents: provisional agenda (CLCS/L.8) which, after it was adopted with an amendment, was reissued (CLCS/17); Scientific and Technical Guidelines of the Commission on the Limits of the Continental Shelf (CLCS/11); Review of the existing training projects and capacities within the United Nations system (CLCS/15); Establishment of a trust fund to assist in financing the participation of members of the Commission on the Limits of the Continental Shelf from developing countries (CLCS/16); and Technical and logistical preparedness of the secretariat to provide assistance to the Commission on the Limits of the Continental Shelf in the consideration of submissions of coastal States (CLCS/INF/1), as well as documents of the Meeting of States Parties to the United Nations Convention on the Law of the Sea relevant to the issues before the Commission (SPLOS/38, SPLOS/48 and SPLOS/49).
- 4. The session was opened by the Chairman, Mr. Yuri B. Kazmin. In his opening statement, the Chairman outlined the programme of work for the sixth session of the Commission. He proposed to amend item 4 of the provisional agenda to read

as follows: "Consideration of the outstanding issues concerning the Scientific and Technical Guidelines of the Commission, including the annexes containing illustrations of its provisions and other material". The agenda was adopted as amended (CLCS/17).

- 5. The Chairman pointed out that the main task before the session was to discuss all outstanding issues concerning the Scientific and Technical Guidelines, including corrections to be made in their translation into other official languages of the United Nations, as well as the completion of the annexes. The Commission was also to elect its officers and to discuss issues of training and of a trust fund to assist in financing the participation of members of the Commission from developing countries.
- 6. Following a brief discussion on the organization of work, the Commission decided to begin its work with the deliberation of outstanding issues related to the Guidelines, in particular those concerning the annexes, and to reconvene for that purpose the Editorial Committee established at the third session (CLCS/7, para. 10), under the chairmanship of Mr. Carrera. It was also agreed that the Commission would proceed with the election of its officers on Wednesday, 1 September 1999. Furthermore, the Commission decided to discuss under the agenda item "Other matters" the issue of the technical preparedness of the Secretariat in the case of a submission.
- 7. In accordance with the decision adopted at the last (fifth) session (CLCS/12, paras. 15 and 16), the Editorial Committee resumed its work on the annexes to the Guidelines and, within that framework, the Working Group on Annex II to the Guidelines (under the chairmanship of Mr. Jaafar) continued its consideration of flowcharts and illustrations relating to several chapters of the Guidelines, which were to be included in that annex. The Editorial Committee also discussed the proposals for the inclusion of additional annexes.
- 8. The report of the Working Group on Annex II, as well as the proposals for the inclusion of other annexes to the Guidelines, were then considered by the Editorial Committee. As a result of its deliberations, the Editorial Committee approved the draft of annex II. It approved as well a new draft annex III, consisting of Part VI of the United Nations Convention on the Law of the Sea (Continental Shelf), Annex II to the Convention (Commission on the Limits of the Continental Shelf) and Annex II to the Final Act of the Third United Nations Conference on the Law of the Sea (Statement of Understanding concerning a specific method to be used in establishing the outer edge of the continental margin). It also decided to produce a draft annex IV to the Guidelines, containing the names, nationalities and current professional positions of the members of the Commission.
- 9. The Editorial Committee then submitted the draft annexes to the plenary of the Commission for its consideration. The Commission decided to adopt annexes II, III and IV, which would be published during the inter-sessional period.
- 10. The election of the officers of the Commission was held on 1 September 1999. The Commission elected by acclamation Mr. Yuri B. Kazmin as its Chairman for the second period of two and one half years beginning on

- 16 December 1999; this period would complete the five-year term of the current membership of the Commission. Following informal consultations among its members and taking into account the principle of equitable geographic representation, the Commission elected Mr. Osvaldo P. Astiz, Mr. Lawrence F. Awosika and Mr. Yong Ahn Park as Vice-Chairmen, and Mr. Peter F. Croker as Rapporteur, also by acclamation.
- 11. In view of the anticipated future needs of the Commission concerning the editorial review of its new documents, reports, etc., as well as possible amendments to the Scientific and Technical Guidelines, the Commission decided to convert the Editorial Committee from an ad hoc to a permanent subsidiary body of the Commission and elected Mr. Galo Carrera as its Chairman.
- 12. The Commission also decided to establish the Working Group on Training as a permanent subsidiary body and elected Mr. Lawrence F. Awosika as its Chairman.
- 13. The Commission continued its exchange of views on the issue of training, with a view to promoting a better understanding of article 76 of the Convention as well as of the Guidelines, in particular taking into account the needs of developing States.
- 14. An action plan for training was agreed upon. The first action to be taken was to send a letter from the Chairman to the President of the General Assembly, flagging the issues relevant to the need for training identified by the Commission and proposing draft provisions for inclusion in the annual resolution of the General Assembly on the item "Oceans and the law of the sea". It also called for letters to be written to the Intergovernmental Oceanographic Commission and the International Hydrographic Organization transmitting to them the basic documents of the Commission (Rules of Procedure, Modus Operandi and Scientific and Technical Guidelines) and requesting them to familiarize the Commission with their programmes as they concern article 76.
- 15. It was also decided to prepare a manual in the form of a flowchart to assist coastal States throughout the process of preparation of a submission to the Commission. The members of the working group who were requested to carry out inter-sessional work on the manual with a view to having a draft manual prepared for discussion at the next session were Messrs. Albuquerque, Awosika, Carrera, Hinz, Jaafar and Srinivasan.
- 16. Other training-related actions to be taken by the Commission included the convening of an open meeting of the Commission during its seventh session to familiarize representatives of coastal States with the necessity for implementing the provisions of article 76 relating to the establishment of the outer limits of the continental shelf beyond 200 nautical miles, bearing in mind the requirement of the Convention to submit particulars of such limits to the Commission "within ten years of the entry into force of the Convention for that State" (article 4 of Annex II to the Convention). It was also considered important for the Secretariat to increase its endeavours to disseminate the documents of the Commission in order to raise awareness among States of the Commission's activities, including the preparation of an information document on the functions and activities of the Commission, as well as on the need for coastal States to implement article 76.

- 17. After extensive discussion on the scope and target of possible training modules, the Working Group on Training also decided to undertake a draft outline for a proposed training course of approximately five days' duration aimed at practitioners who would take part in the preparation of the submission of a coastal State. The course would concentrate on the basic documents of the Commission, namely the Scientific and Technical Guidelines, the Rules of Procedure, and the Modus Operandi. It would also include the manual referred to in paragraph 15 describing the actions to be undertaken by a coastal State wishing to make a submission. The training module would be addressed by Messrs. Awosika, Betah, Carrera, Hinz, Jaafar and Srinivasan, with contributions from Messrs. Albuquerque, Croker, Lamont and other interested members of the working group who might wish to participate in designing the module.
- 18. In addition, it was also decided that several members of the working group should develop proposals for training modules suited to their own regions, including a regional assessment of capabilities and training needs, and to submit those proposals for discussion at the next session. Among those entrusted with the task of preparing these proposals were Messrs. Albuquerque, Astiz, Betah, Francis, Hinz, Jaafar, Mdala, Park and Srinivasan.
- 19. With respect to the creation of a trust fund to assist in financing the participation of members of the Commission from developing countries, the Chairman of the Commission provided information on the results of the deliberations at the Meeting of States Parties, as reflected in the report of the ninth Meeting of States Parties (SPLOS/48) and the Letter from the President of the ninth Meeting of States Parties addressed to the Chairman of the Commission on the Limits of the Continental Shelf (SPLOS/49). The Commission took note of the estimated costs for the establishment of a trust fund prepared by the Secretariat (CLCS/16) and requested that the relevant information be submitted to the President of the tenth Meeting of States Parties.
- 20. Regarding forthcoming international events related to the work of the Commission and to the issue of the establishment of the outer limits of the continental shelf by coastal States, the Commission reviewed presentations prepared by its members for the International Conference on Technical Aspects of Maritime Boundary Delineation and Delimitation, including issues related to article 76 of the Convention, to be held in Monaco on 9 and 10 September 1999, under the auspices of the Advisory Board on the Law of the Sea (ABLOS), a joint body composed of participants from the International Association of Geodesy, the International Hydrographic Organization and the Intergovernmental Oceanographic Commission, as well as the Division for Ocean Affairs and the Law of the Sea of the United Nations Office of Legal Affairs in an ex officio capacity. It was pointed out that the presentations did not represent views of the Commission as a whole but rather those of its members in their individual capacities.
- 21. The Commission also discussed in brief the information note by the Secretariat on technical and logistical preparedness of the Secretariat to provide assistance to the Commission on the Limits of the Continental Shelf in the consideration of submissions of coastal States (CLCS/INF/1). In that regard the Commission emphasized the importance of acquiring the most up-to-date software available on ocean information systems and the delineation of the outer limits of maritime spaces.

- 22. The Commission decided that its seventh session would be held for one week from 1 to 5 May 2000 to further discuss the matters of training and the establishment of a trust fund. It also decided to hold one open meeting of the Commission during that week, to which the representatives of interested States would be invited. It would also be decided at that session if it would be necessary to hold a second session in the same year in the absence of a submission from a coastal State. If the Commission were to decide in favour of holding another session that year, the tentative dates for its eighth session would be 28 August to 1 September 2000.
- 23. The Commission reiterated its appreciation to the staff of the Division for Ocean Affairs and the Law of the Sea as well as to the interpreters, translators and other staff for their able assistance during the session.
