12. Non-governmental organizations

At its substantive session of 1999, on 30 July 1999, the Council, having considered the report of the Committee on Non-Governmental Organizations on its 1999 session, adopted decision 1999/268 in response to the Committee's recommendation to the Council that it withdraw the consultative status of Christian Solidarity International. In the same decision, the Council decided that the Committee should complete its consideration, in full accordance with the process stipulated in Council resolution 1996/31 of 25 July 1996, of the question of the consultative status of Christian Solidarity International. The Committee met on 7 September 1999 and the report of that meeting and the Committee's recommendation to the Council are contained in document E/1999/109/Add.1.

At its 46th meeting, on 30 July 1999, the Council took note of the report of the Committee for Development Policy on its first session (decision 1999/286). The President of the Council subsequently received a letter from the President of Maldives regarding the recommendation of the Committee for Development Policy to graduate Maldives from the list of the least developed countries.

(g) Transport of dangerous goods

At its 46th meeting, on 30 July 1999, the Council decided to defer consideration of draft resolution II, entitled "Reconfiguration of the Committee of Experts on the Transport of Dangerous Goods into a Committee of Experts on the Transport of Dangerous Goods and on the Globally Harmonized System of Classification and Labelling of Chemicals", contained in the report of the Secretary-General on the work of the Committee of Experts on the Transport of Dangerous Goods at its twentieth session (E/1999/43), to a subsequent session of the Council (decision 1999/289).
