FINANCIAL MATTERS: USE OF EXTRABUDGETARY RESOURCES  
OF THE UNITED NATIONS CENTRE FOR HUMAN SETTLEMENTS  
(HABITAT)

Report of the Executive Director

SUMMARY

The purpose of this report is to provide the Commission with information on the use of extrabudgetary resources during the biennium 1980-1981 and projections for such use during the biennium 1982-1983.

Introduction

1. This report is submitted in response to the request made by the Commission in its decision 4/18 that the Executive Director should prepare for the fifth session of the Commission a report on the use of all extrabudgetary resources broken down by source.

2. As the Commission is aware, in addition to the funds available to the Centre from the regular budget and from the United Nations Habitat and Human Settlements Foundation (UNHHSF) for programme and programme support purposes, additional resources are made available to the Centre by a variety of sources. These funds, which constitute the extrabudgetary resources of the Centre, fall into two broad categories: programme and programme support funds; project funds.

Programme and programme support funds

3. These funds come primarily from three sources:

- (a) Programme support income derived from the execution of projects financed by the United Nations Development Programme (UNDP) and trust funds;
- (b) A subvention from the World Food Programme (WFP);
- (c) Programme support from the Fund of UNEP.

4. Each of the above-mentioned sources of extrabudgetary resources is dealt with below.

(a) Programme support income

5. These funds, formerly known as overhead funds, constitute a proportion of the project expenditures made by an executing agency. Until 1981, this proportion was generally established at 14 per cent. As a result of a recent decision of the UNDP Governing Council, it has been reduced to 13 per cent as from 1982.

6. During the biennium 1980-1981, the Centre executed projects financed from a variety of sources. Project expenditures amounting to \$US 27,834,500 were recorded as follows:

7. Thus, in accordance with the entitlement described in paragraph 5 above, the Centre derived an income of \$US 3,896,800 during the biennium. A major part of this amount, namely \$ 3,334,800, was utilized in providing substantive and administrative support to the field projects. Under decentralized procedures recently introduced by the Assistant Secretary-General for Financial Services, proposals for the utilization of programme support income are prepared by the Executive Director and submitted to the Budget Division at Headquarters for information and review. In preparing such proposals, the Centre is required to maintain a 20 per cent reserve on all programme support income. The Executive Director has requested the Assistant Secretary-General for Financial Services to authorize a smaller reserve, as the 20 per cent reserve requirement places excessive restrictions on the use of the limited extrabudgetary resources of a small agency such as UNCHS (Habitat). The request is under consideration by the Assistant Secretary-General.

8. It is estimated, on a conservative basis, that the Centre will incur the same level of project expenditures during the biennium 1982-1983 as it did during the biennium 1980-1981. This will therefore enable the Centre to earn the same level of support income.

(b) Subvention from the World Food Programme (WFP)

9. Under an existing trust-fund arrangement between the United Nations and WFP, the latter makes available to the United Nations funds which are distributed annually to various United Nations programmes and offices to finance activities undertaken by those units in support of WFP. In 1980-1981, the UNCHS (Habitat) share of these funds amounted to \$ 202,000, which was utilized to establish one post for a human settlements adviser, assisted by a local-level staff member, to undertake a substantive review of WFP field projects that have a human settlements component and to provide technical support in areas related to human settlements. A number of advisory missions were undertaken in this connection, and all expenses thus incurred were met out of the allocation in question. The yearly requirements of the Centre for this purpose are communicated annually to the Budget Division, which reviews them and issues the necessary allotment of funds to the Centre.

10. It is expected that an amount of \$ 258,800 will be made available to the Centre under this heading during the current biennium.

(c) Programme support from the Fund of UNEP

11. In pursuance of General Assembly resolution 32/162 and the decision of the General Assembly that UNEP resources directly concerned with human settlements should be transferred to the Centre, UNEP transferred one professional post to the Centre. As a result, expenditures amounting to \$ 80,700 associated with one P-3 post have been charged to the Fund of UNEP, and a similar amount will be made available during the biennium 1982-1983.

12. The distribution of the extrabudgetary programme and programme support funds as received in the biennium 1980-1981 and as projected for the biennium 1982-1983 are shown in the tables contained in annex I to this document.

Voluntary contributions in support of specific projects

13. In addition to the funds received for programme and programme support purposes, the Centre also received funds in support of specific projects. These funds were received under two different administrative categories. The first category consisted of the contributions received by the Centre under trust-fund arrangements established at Headquarters and administered by the Centre under authority delegated to it by Headquarters. The arrangements in question involve associate expert arrangements or individual trust funds. In 1980-1981, as shown in paragraph 6 above, these contributions amounted to \$ 2,709,200.

14. In the 1980-1981 biennium, the following countries participated in the associate expert scheme: Belgium, Denmark, France, Germany, Federal Republic of, Italy, Netherlands, Norway and Sweden. These countries provided funds enabling the recruitment of 32 associate experts in connection with various projects. It is expected that there will be a significant expansion of this scheme during the current biennium.

15. Only one project financed by the Government of Belgium to an amount of \$US 500,641 was funded under trust fund arrangements during the 1980-1981 biennium.

16. The second category of voluntary contributions in support of specific projects comprised all contributions by donor Governments to the Centre in support of specific projects. These contributions are made to UNHHSF in accordance with financial rule 307.5 (c) which states that "counterpart contributions in the form of agreed contributions in cash or in kind, which are made for the cost of specific services and facilities as set out in individual project documents, may be accepted by the Executive Director" (ST/SGB/UNHHSF Financial Rules/3 (1978)).

2/ The unspent balance of programme support income constitutes the reserve required by Headquarters.

17. In the biennium 1980-1981, pledges and contributions for projects were received from Denmark, the Netherlands and Sweden. Negotiations are currently under way for projects to be financed by Belgium, Finland and others.

18. Annex II to this document contains a listing of all projects approved for financing by UNHHSF during the biennium 1980-1981, including the projects referred to in paragraph 17 above.

Recommendation

19. The Executive Director recommends that the Commission take note of the present report.
