Implementation of the outcome of the United Nations Conference on Human Settlements (Habitat II)

The General Assembly,

Recalling its resolution 51/177 of 16 December 1996, in which it endorsed the Istanbul Declaration on Human Settlements¹ and the Habitat Agenda,² adopted by the United Nations Conference on Human Settlements (Habitat II) at Istanbul on 14 June 1996,

Further recalling its resolutions 52/190 of 18 December 1997 and 52/192 of 18 December 1997 on the follow-up to decisions of Habitat II and the future role of the Commission on Human Settlements,

Also recalling its resolution 53/242 of 28 July 1999 on environment and human settlements,

Having considered the report of the Secretary-General on environment and human settlements, 3

Having also considered the report of the Commission on Human Settlements on the work of its seventeenth session,⁴

1. *Takes notes* with appreciation of the report of the Commission on Human Settlements on the work of its seventeenth session;⁴

2. *Welcomes* the steps taken by the Acting Executive Director of the United Nations Centre for Human Settlements to strengthen the normative and operational activities of the Centre so as to enable it to effectively exercise its vital role as focal point for the implementation of the Habitat Agenda;

3. *Welcomes* the progress made by the Acting Executive Director in the revitalization of the Centre, and further welcomes the decision of the Commission on Human Settlements mandating the Executive Director to implement the Centre's new strategic vision comprehensively through the launching of the Global Campaign for Secure Tenure and the Global Campaign on Urban Governance;

4. *Requests* the Secretary-General to ensure that the staffing of the new organizational structure is completed as a matter of urgency in accordance with the principle of equitable geographical representation and gender balance, in accordance with the relevant United Nations rules and regulations;

5. *Also requests* the Secretary-General as a matter of urgency to appoint a fulltime Executive Director for the Centre in accordance with General Assembly resolution 53/242;

6. *Takes note* of the increased cooperation and collaboration between the United Nations Centre for Human Settlements and the United Nations Environment Programme within the framework of their respective mandates and separate programmatic, budgetary and organizational identities;

7. *Calls upon* Governments to ensure the provision of sufficient financial support to the Centre;

8. *Requests* the Secretary-General to provide additional resources from the regular budget to the United Nations Centre for Human Settlements in accordance with current budgetary practices and procedures;

9. Welcomes the decision by the Economic and Social Council to devote its coordination segment in the year 2000 to human settlements issues and the implementation of the Habitat Agenda, and requests the Secretary-General to ensure that the report submitted to the Council under the segment along with its recommendations be made available to the General Assembly for its consideration under the sub-item entitled "Implementation of the outcome of the United Nations Conference on Human Settlements (Habitat II)";

10. *Requests* the Secretary-General to submit to the General Assembly at its fifty-fifth session a report on the implementation of the present resolution;

11. *Decides* to include in the provisional agenda of its fifty-fifth session the sub-item entitled "Implementation of the outcome of the United Nations Conference on Human Settlements (Habitat II)".
