SUMMARY STATEMENT BY THE SECRETARY-GENERAL ON MATTERS OF WHICH THE SECURITY COUNCIL IS SEIZED AND ON THE STAGE REACHED IN THEIR CONSIDERATION

Addendum

Pursuant to rule 11 of the provisional rules of procedure of the Security Council, the Secretary-General is submitting the following summary statement.

The list of items of which the Security Council is seized is contained in document S/14840 of 19 January 1982, S/14840/Add.12 of 5 April 1982, S/14840/Add.13 of 12 April 1982 and S/14840/Add.17 of 6 May 1982.

During the week ending 22 May 1982, the Security Council took action on the following items:

Complaint by Seychelles (see S/14326/Add.50)

The Security Council resumed its consideration of the item at its 2359th meeting, held on 20 May 1982, having before it the report dated 15 March 1982 of the Security Council Commission of Inquiry established under resolution 496 (1981) (S/14905). The Council continued its discussion at its 2361st meeting, held on 21 May 1982.

In the course of the meetings, the President, with the consent of the Council, invited the representatives of Afghanistan, Algeria, Angola, Argentina, Barbados, Benin, Botswana, Bulgaria, Cuba, Czechoslovakia, Egypt, the German Democratic Republic, Grenada, Honduras, Hungary, India, the Lao People's Democratic Republic, Madagascar, Maldives, Mali, Malta, Mozambique, Nicaragua, Pakistan, Sao Tome and Principe, Seychelles, the United Republic of Tanzania, Viet Nam and Yugoslavia, at their request, to participate in the discussion without the right to vote.

Question concerning the situation in the region of the Falkland Islands (Islas Malvinas) 1/

In a letter dated 4 May 1982 addressed to the President of the Security Council (S/15037), the representative of Ireland stated that in view of the recent serious developments in the region of the Falkland Islands (Islas Malvinas), his Government requested a meeting of the Security Council to give further consideration to that matter.

In a letter dated 20 May 1982 addressed to the President of the Security Council (S/15099), the Secretary-General stated that, as he had informed the members of the Council on the previous day, he felt the time for reaching agreement through negotiations that would restore peace in the South Atlantic was extremely short, and he thought it essential to provide the President with that appraisal on a most urgent basis in the light of the urgent responsibilities which the Security Council bore under the Charter.

In a letter dated 21 May 1982 addressed to the President of the Security Council (S/15100), the representative of Panama requested a meeting of the Security Council in view of the serious situation which existed in the region of the Malvinas and of the letter (S/15099) by the Secretary-General.

The Security Council considered the item at its 2360th meeting, held on 21 May 1982, and continued its discussion at the 2362nd meeting, held on 22 May.

In the course of the meetings, the President, with the consent of the Council, invited the representatives of Antigua and Barbuda, Argentina, Australia, Bolivia, Brazil, Canada, Colombia, Cuba, Ecuador, El Salvador, Equatorial Guinea, Guatemala, Honduras, Mexico, New Zealand, Nicaragua, Paraguay, Peru, Uruguay and Venezuela, at their request, to participate in the discussion without the right to vote.
