Assistance to Cape Verde

Report of the Secretary-General

- 1. In its resolution 36/211 of 17 December 1981 on assistance to Cape Verde, the General Assembly, <u>inter alia</u>, requested the Secretary-General to continue his efforts to mobilize the necessary resources for implementing the programme of development assistance to Cape Verde, and to arrange for a review of the economic situation of the country and the progress made in organizing and implementing the special economic assistance programme and to report to the Assembly at its thirty-seventh session.
- 2. The Secretary-General arranged for a review mission to visit Cape Verde to consult with the Government on the economic situation in that country and on the progress made in implementing the special economic assistance programme. The report of the review mission, which is annexed hereto, describes the economic and financial situation of the country, provides an estimate of the critical need for food assistance and summarizes the progress which has been made in implementing the projects included in the special economic assistance programme.
- 3. In paragraph 9 of resolution 36/211, the General Assembly invited a number of specialized agencies and other organizations of the United Nations system to continue, through their governing bodies, to consider the special needs of Cape Verde and to report the decisions of those bodies to the Secretary-General by 15 July 1982. Furthermore, the appropriate specialized agencies and other organizations of the United Nations system were requested in paragraph 6 of the resolution to report periodically to the Secretary-General on the steps they had

taken and the resources they had made available to assist Cape Verde. The text of resolution 36/211 has been communicated to the specialized agencies and organizations concerned and their attention drawn to the specific requests addressed to them by the Assembly. Their replies will be reproduced in a report of the Secretary-General covering Cape Verde and other countries for which the Assembly has requested the Secretary-General to organize special economic assistance programmes.

I. INTRODUCTION

- 1. The report of the Secretary-General on assistance to Cape Verde (A/36/265) was considered by the General Assembly at its thirty-sixth session. On 17 December 1981, the General Assembly adopted resolution 36/211 in which, having examined the report of the Secretary-General to which was annexed the report of the review mission to Cape Verde (A/36/265), it expressed its appreciation to the Secretary-General for the efforts deployed in mobilizing resources for the implementation of the programme of assistance to Cape Verde and also expressed its gratitude to States and international organizations for their contribution to the programme. The Assembly called upon the international community to continue to provide financial, material and technical assistance to Cape Verde.
- 2. The General Assembly also requested the Secretary-General to arrange for a review of the economic situation of Cape Verde and the progress made in organizing and implementing the special economic assistance programme for that country and to report to the Assembly at its thirty-seventh session. Accordingly, arrangements were made for a United Nations mission to visit Cape Verde from 19 to 23 April 1982. The mission was led by the Joint Co-ordinator of Special Economic Assistance Programmes in the Office for Special Political Questions.
- 3. The head of the mission was received by the Secretary of State for Co-operation and Planning, His Excellency Mr. Jose Brito. The mission held meetings with senior officials from the State Secretariat for Co-operation and Planning. In addition, the head of the mission participated in a meeting organized by the Government of Cape Verde with representatives of the donor community in preparation for the Round Table of Development Partners scheduled to take place from 21 to 24 June 1982.
- 4. The mission wishes to place on record its appreciation of the assistance it received from the Government of Cape Verde. The Government had prepared relevant materials for the mission's visit and provided the information required for the review. The mission also wishes to acknowledge the very valuable support it received from the Resident Representative of the United Nations Development Programme (UNDP) in Cape Verde.

II. THE ECONOMIC SITUATION

A. General

- 5. The economy of Cape Verde was described in some detail in previous reports of the Secretary-General on assistance to Cape Verde (A/33/167 and Corr. 1, A/34/372 and Corr. 1, A/35/332 and Corr. 1 and A/36/265).
- 6. According to provisional data from the 1980 census, Cape Verde has 58,620 families, with an average of five members each, giving a total population of 296,093. Almost 50 per cent of the inhabitants live on the island of Santiago. Of the potential labour force, 40 to 45 per cent is under-employed and in the urban areas the unemployment level has reached 12 per cent. As a result of the

continuous drought conditions since 1968, the agricultural sector has been hard hit with crop failures and the loss of cattle (a drop of 37 per cent in the national herd over a 10-year period).

- 7. One of the outstanding structural features of Cape Verde's economy is that, in the past, foreign resources made available through international assistance and remittances from abroad have equalled domestically produced income. The trend of Cape Verde's balance of payments can be characterized by a large and growing trade deficit which is, however, almost completely offset by heavy inflows of foreign assistance and remittances from abroad.
- 8. The national public finances reflect a policy of providing for rapid growth of development expenditure financed largely from abroad while maintaining manageably low current-budget deficits. Since independence, public spending has increased at the rate of approximately 35 per cent per annum (in current terms). Domestic revenue has generally come close to covering current expenditure, with a modest current deficit equal to 11 per cent of current spending over the period 1975 to 1978. However, in 1980, actual figures showed a modest surplus resulting from receipts coming in at a higher level than had been projected.
- 9. In 1981, Cape Verde continued to face serious shortfalls in agricultural production resulting from inadequate rainfall. Projected budget deficits for both 1981 and 1982 suggest continued financial problems for the Government. Thus, international assistance remains essential to the survival of the country.
- 10. Since independence, Cape Verde has been face with the problems of drought and an unfavourable international economic climate. It has thus not been possible until now to prepare its Development Plan and the Government has tended to operate on annual investment programmes combined with selected development projects identified in previous reports of the Secretary-General on assistance to Cape Verde and on longer-term technical co-operation programmes with various donors operating in the country. However, preparation of the first National Development Plan to cover the years 1982 to 1985 is nearing completion. Its approval and publication is expected later in 1982 when the Government is in a better position to estimate the foreign assistance likely to be available. The mission was informed that land reform, soil conservation, reafforestation, desertification control, irrigation projects, livestock production, agricultural diversification, fisheries, stabilization of local industries, energy and desalination, transport and telecommunications to unify the national territory, additional facilities for tourism, consolidation of the educational sector, health, housing, urban growth, sanitation, trade, employment and human resource development are among the issues to be addressed in the three-year plan.
- 11. The Government has indicated that the salient features of the First National Development Plan have been incorporated into the documents prepared for the Round Table of Development Partners scheduled to take place from 21 to 24 June 1982. The preparations for this donors' conference are discussed in further detail under section IV of the present report.

B. Government finances

12. Only 1980 actual budget performance figures and the 1982 budget projections were available during the mission's visit. Provisional actual figures could not be provided for 1981. Although the Government of Cape Verde had an unexpected budget surplus in 1980, both 1981 and 1982 projections indicate a \$3.4 million annual deficit. Details are given in table 1.

14. The Government was unable to provide the mission with figures for the investment budget for 1982 to update the material contained in the previous report (A/36/265), nor were provisional balance-of-payments figures available for 1980 and 1981. The mission was informed that this information would be provided at the Round Table of Development Partners.

III. FOOD AID AND FOOD SECURITY

15. On the basis of its analysis of precipitation data for Cape Verde during the past year, a report by the Food and Agriculture Organization of the United Nations (FAO) and the World Food Programme (WFP), issued in January 1982, concluded that 1981 was among the driest years experienced by the country within the last decade. Thus Cape Verde, as an Atlantic extension of the Sahelian belt, still suffers from drought, which has continued virtually without interruption since 1968. As a consequence, agricultural production was seriously affected in 1981. Maize production fell 57 per cent from the 1980 level (7,000 to 3,000 tonnes) and the production of beans fell 74 per cent (from 1,900 to 500 tonnes). The magnitude of the devastation from the drought is apparent when these figures are compared to the optimal annual projections calculated by FAO and WFP, assuming the best climatic conditions and production practices (33,750 tonnes for maize and 4,500 tonnes for beans).

16. The Government's strategy with regard to food aid is to initiate discussions with individual donors in order to obtain multi-year commitments tied to carefully selected food security goals and the need to finance urgent development projects. These discussions will be prepared and conducted within the context of the National Development Plan and the Round Table of Development Partners.

B. Food needs: 1982

- 18. During 1981, continued drought conditions drastically reduced the production levels of both maize and beans. The estimated food deficit for 1982 is 40,435 tonnes. In its donor conference documents, the Government has projected annual food requirements and domestic production through 1985, showing an annual deficit of grain of at least 56,000 tonnes (35,000 tonnes of maize, 12,000 tonnes of wheat and 9,000 tonnes of rice).
- 19. The specific 1982 requirements, set out in table 4, were prepared by a joint Cape Verde/FAO/WFP study.

IV. PREPARATIONS FOR THE ROUND TABLE OF DEVELOPMENT PARTNERS

- 22. In preparation for the Round Table of Development Partners scheduled to take place from 21 to 24 June 1982, the Government has reviewed:
 - (a) The economic situation in Cape Verde: the constraints and assets;
- (b) The strategies, objectives, programmes and projects to be included in the First National Development Plan, 1982-1985;
- (c) Aid modalities, including future food aid and the establishment of a project preparation and planning fund.
- 23. The findings and recommendations of this review are presented in a three-volume report, entitled "Round Table of Development Partners, Praia, June 1982".

- 24. The Cape Verde Government has identified in volumes II and III of the report a number of specific projects requiring external aid for submission to potential donors in implementing the Government's urgent programme of rehabilitation, reconstruction and development. Table 6 provides a summary list of these projects, together with cost estimates where available. It should be noted that, in some cases, project estimates either are not available or only reflect the costs of studies where the final project requires further elaboration.
- 25. The Government of Cape Verde is seeking international assistance from bilateral and multilateral sources for the projects and programmes identified in table 6. It is hoped that an indication of the likely available international assistance will result from the Round Table conference. Thereafter, it will be possible to finalize the three-year development plan. As the list of projects in table 6 sets out the Government's priority needs for the next three years, it supercedes previous lists of projects included in the various reports of the Secretary-General on assistance to Cape Verde.

V. PROGRESS IN IMPLEMENTING THE SPECIAL ECONOMIC ASSISTANCE PROGRAMME

- 26. In resolution 36/211, the General Assembly requested the Secretary-General to review the progress made in implementing the special economic assistance programmes for Cape Verde and to report thereon to the General Assembly at its thirty-seventh session.
- 27. Of the 61 projects, apart from food assistance, contained in the report of the Secretary-General (A/36/265), 14 have been fully funded and partial funding has been secured for 18. No international support has been forthcoming for 25 projects. The Government has withdrawn 4 projects and 27 projects have been modified or elaborated in the context of preparations for the Round Table of Development Partners.
- 28. Table 7 provides a list of projects identified in previous reports that either have been completely funded or have been withdrawn by the Government and provides updated information where the source of funds differs from information provided in previous reports. Table 8 lists projects which have attracted no international funding. It should be noted that in some cases cost estimates are not available, as further studies and documentation are required. Under remarks, an attempt has been made to identify those projects which have been included in the programme to be presented to the Round Table conference.
