Letter dated 7 September 1982 from the Permanent Representative of Thailand to the United Nations addressed to the Secretary-General

Further to my letter of 16 August 1982 (A/37/391-S/15366) and upon the instructions of my Government, I have the honour to inform you of the lastest violations of Thailand's sovereignty and territorial integrity by Vietnamese occupation forces in Kampuchea as follows:

- 1. On 9 August 1982, at 12.40 a.m., Vietnamese forces fired 4 shells of 82 mm mortar into Thai territory at Ban-Mai-Rood and Ban-Khat-Larn, Klong-Yai District, Trat Province.
- 2. On 10 August 1982, at 4.00 a.m., three shells of 82 mm mortar fired by Vietnamese forces landed in Thai territory at Ban-Sao-Thong-Chai, Kantharalak District, Si-Sa-Ket Province, damaging school and houses.
- 3. On 11 August 1982, at 12.00 a.m., Vietnamese forces fired a RPG rocket into Thai territory, landing at Ban-Khao-Larn, Khlong-Yai District, Trat Province.
- 4. On 11 August 1982, at 2.10 p.m., Vietnamese forces fired 107 mm rockets and 120 mm mortars into Thai territory. Fifty shells landed in the area between Ban-Kok-Sabang and Ban-Nong-Ian, and 10 more shells landed in the area of Ban-Klong-Namsai, Aranyaprathet District, Prachinburi Province, damaging a number of houses.

- 5. On 12 August 1982, at 3.45 p.m., another 2 RPG rockets fired by Vietnamese forces landed in Thai territory at Ban-Mai-Rood, Khlong-Yai District, Trat Province.
- 6. On 13 August 1982, at 4.30 p.m., Vietnamese forces fired recoilless gun into Thai territory with 8 shells landing in the area north of Ban-Chananglang, Pong-Nam-Ron District, Chanthaburi Province.
- 7. On 17 August 1982, at 1.00 p.m., Vietnamese forces fired one 107 mm rocket landing in the area south of Ban-Sa-Ngae, Ta-Phraya District, Prachinburi Province.
- 8. On 18 August 1982, at 7.00 p.m., 8 shells of 107 mm rocket fired by Vietnamese forces landed in Thai territory at Ban-Sa-Ngae again, damaging a number of Thai villagers' houses.
- 9. On 21 August 1982, at 11.20 a.m. Vietnamese forces fired 107 mm rocket into Thai territory landing in the area east of Ban-Sa-Ngae, Ta-Phraya District, Prachinburi Province.
- 10. On 29 August 1982, at 3.05 p.m., 5 shells of heavy weapon fired by Vietnamese forces landed inside Thai territory at Ban-Mai-Pak-Hong and Khao-Noi-Srichimphu, Aranyaprathet District, Prachimburi Province.

These incidents constitute further evidence of blatant violations of Thai territory, contrary to Viet Nam's continued pronouncement that it would respect Thailand's sovereignty and territorial integrity.

The Royal Thai Government condemns these and other similar acts of hostility and calls upon Viet Nam to halt any further acts of such violation against the territory of Thailand. The Royal Thai Government also reaffirms its legitimate right to take all necessary measures to safeguard the sovereignty and territorial integrity of the Kingdom.

I have the honour to request that the text of this letter be circulated as an official document of the General Assembly, under items 20 and 35 of the provisional agenda, and of the Security Council.
