INTERNATIONAL COVENANTS ON HUMAN RIGHTS

Status of the International Covenant on Economic, Social and Cultural Rights, the International Covenant on Civil and Political Rights and the Optional Protocol to the International Covenant on Civil and Political Rights

Report of the Secretary-General

1. The General Assembly by its resolution 2200 A (XXI) of 16 December 1966 adopted and opened for signature, ratification or accession the International Covenant on Economic, Social and Cultural Rights, the International Covenant on Civil and Political Rights and the Optional Protocol to the International Covenant on Civil and Political Rights, and expressed the hope that the Covenants and the Optional Protocol would be signed, ratified or acceded to without delay and would come into force at an early date. The Assembly also requested the Secretary-General to submit to it at its future sessions reports concerning the status of ratifications of the Covenants and of the Optional Protocol. In response to that request, reports on the status of the International Covenants and the Optional Protocol have been submitted annually to the Assembly since its twenty-second session, in 1967.

2. Both Covenants and the Optional Protocol were opened for signature at New York on 19 December 1966. In accordance with their respective provisions, 1/ the International Covenant on Economic, Social and Cultural Rights entered into force on 3 January 1976, the International Covenant on Civil and Political Rights entered into force on 23 March 1976, and the Optional Protocol to the International Covenant on Civil and Political Rights, having received the required number of ratifications or accessions, entered into force simultaneously with that Covenant on 23 March 1976.

3. By its resolution 36/58 of 25 November 1981, the General Assembly again invited all States which had not yet done so to become parties to both Covenants and to consider acceding to the Optional Protocol to the International Covenant on Civil and Political Rights and invited the States parties to the International Covenant on Civil and Political Rights to consider making the declaration provided for in article 41 of that Covenant. The Assembly also requested the Secretary-General to submit to it at its thirty-seventh session a report on the status of the Covenants and the Optional Protocol.

4. As at 1 September 1982, the International Covenant on Economic, Social and Cultural Rights had been ratified or acceded to by 74 States, the International Covenant on Civil and Political Rights had been ratified or acceded to by 71 States and the Optional Protocol to the International Covenant on Civil and Political Rights had been ratified or acceded to by 28 States. In addition, 10 States had signed the International Covenant on Economic, Social and Cultural Rights, 11 States had signed the International Covenant on Civil and Political Rights and 7 States had signed the Optional Protocol. The list of States which have signed, ratified or acceded to the Covenants and the Optional Protocol and the dates of their signatures, ratifications or accessions appear in annexes I to III of the present report.

5. Upon ratification of the International Covenant on Civil and Political Rights, or subsequently, the Governments of Austria, Canada, Denmark, Finland, Germany, Federal Republic of, Iceland, Italy, the Netherlands, New Zealand, Norway, Senegal, Sri Lanka, Sweden and the United Kingdom of Great Britain and Northern Ireland have made the declaration provided for in article 41 of the Covenant, recognizing the competence of the Human Rights Committee established under article 28 of the Covenant to receive and consider communications to the effect that a State party claims that another State party is not fulfilling its obligations under the Covenant. The provisions of article 41 entered into force on 28 March 1979 in accordance with paragraph 2 of that article.

6. As regards the implementation of the International Covenant on Economic, Social and Cultural Rights, the Sessional Working Group of Governmental Experts on the implementation of that Covenant, established in accordance with Economic and Social Council decision 1978/10 of 3 May 1978, held its fourth session at United Nations Headquarters from 5 to 23 April 1982. The Group was composed of the following members of the Council which were also States parties to the Covenant: Bulgaria, Byelorussian Soviet Socialist Republic, France, Germany, Federal Republic of, Japan, Kenya, Libyan Arab Jamahiriya, Mexico, Norway, Peru, Tunisia, Union of Soviet Socialist Republics and Venezuela.

7. At its fourth session, the Sessional Working Group considered reports submitted by States parties under the first, second and third stages of the Programme established by Economic and Social Council resolution 1988 (LX) of 11 May 1976 concerning rights covered by articles 6 to 9, 10 to 12 and 13 to 15 of the Covenant. It also considered the question of the review of its future composition, organization and administrative arrangements and submitted a report to the Economic and Social Council at its first regular session of 1982 (E/1982/56 and Corr.1).

8. By its resolution 1982/33 of 6 May 1982, the Economic and Social Council took measures to review the composition, organization and administrative arrangements of the Sessional Working Group and decided, inter alia, that the Working Group should henceforth be known as "Sessional Working Group of Governmental Experts on the Implementation of the International Covenant on Economic, Social and Cultural Rights", to be referred to as the "Group of Experts"; that the 15 members of the Group of Experts should be elected by the Council from among the States parties to the Covenant, in accordance with the geographical distribution established by the Council in paragraph (a) of its decision 1978/10; that the members of the Group of Experts should be elected for a term of three years; and that one member from each regional group should be renewed each year. In the same resolution, the Council decided that the first elections for the membership of the Group of Experts would take place at the resumed second regular session of the Council in 1982 and subsequent elections would take place each year during the first regular session of the Council.

9. In the same resolution, it was also decided that each Member State elected to the Group of Experts should designate, in consultation with the Secretary-General and subject to confirmation by the Council, a qualified person to represent that Member State in the Group of Experts; that the persons so designated should be experts with recognized competence in the field of human rights; and that the confirmation of the experts so designated should take place at the organizational session for 1983 of the Council.

10. The Group of Experts is to meet annually for a period of three weeks, beginning two weeks before the first regular session of the Council, and the duration of each session may be extended by the Council at its organizational session, if required, taking into account the number of reports to be examined by the Group of Experts in the course of its following session. The Group of Experts will make suggestions and recommendations of a general nature based on its consideration of reports submitted by States parties to the Covenant and by the specialized agencies, in order to assist the Council to fulfil, in particular, its responsibilities under articles 21 and 22 of the Covenant.

11. The Council is to review the composition, organization and administrative arrangements of the Group of Experts at its first regular session of 1985, and subsequently every three years, taking into account the principle of equitable geographical distribution and the increase in the number of States parties to the Covenant. The procedures and methods of work established by Council resolutions 1988 (LX) and 1979/43, and decisions 1978/10 and 1981/158, will remain in force in so far as they are not modified by resolution 1982/33.

12. As regards the implementation of the International Covenant on Civil and Political Rights, the Human Rights Committee held its fourteenth session in Bonn at the invitation of the Government of the Federal Republic of Germany from 19 to 30 October 1981, its fifteenth session at United Nations Headquarters from 22 March to 9 April 1982 and its sixteenth session at the United Nations Office at Geneva from 12 to 30 July 1982. In accordance with article 45 of the Covenant and article 6 of the Optional Protocol, the Committee has submitted its annual report,

through the Economic and Social Council, to the General Assembly at its thirty-seventh session, 2/ which covers the activities of the Committee at its fourteenth, fifteenth and sixteenth sessions.

<u>b</u>/ Following on the adoption by the General Assembly of resolution 2758 (XXVI) of 25 October 1971 on the lawful rights of the People's Republic of China in the United Nations, the Minister for Foreign Affairs of the People's Republic of China, by a note addressed to the Secretary-General, received on 29 September 1972, stated:

"1. With regard to the multilateral treaties signed, ratified or acceded to by the defunct Chinese government before the establishment of the People's Republic of China, my Government will examine all their contents before making a decision in the light of the circumstances as to whether or not they should be recognized.

"2. As from 1 October 1949, the day of the founding of the People's Republic of China, the Chiang Kai-shek clique has no right at all to represent China. Its signature and ratification of, or accession to, any multilateral treaties by usurping the name of 'China' are all illegal and null and void. My Government will study these multilateral treaties before making a decision in the light of the circumstances as to whether or not they should be acceded to."

The lists in annexes I to III therefore do not include the signature of the two Covenants and the Optional Protocol on behalf of the "Republic of China" on 5 October 1967.
