Economic Commission for Africa

At its second regular session of 1982, the Economic and Social Council took note of the preliminary report of the Secretary-General on the expansion of the conference facilities of ECA at Addis Ababa; requested the Secretary-General to submit, as a matter of urgency, his final report to the Council at its resumed second regular session of 1982, and invited the General Assembly, at its thirty-seventh session, to consider the final report of the Secretary-General and the comments of the Council thereon and to take all appropriate action (resolution 1982/60). Transport and Communications Decade in Africa

Multinational programming and operational centres

At its second regular session of 1982, the Economic and Social Council, inter alia, took note with interest of the report of the Secretary-General on the financing, on an established basis, of the Multinational Programming and Operational Centres of the Economic Commission for Africa (E/1982/70 and Corr.1), which had been submitted to the Council pursuant to Assembly resolution 36/178; and invited the General Assembly, at its thirty-seventh session, to examine the proposals contained in paragraphs 47 to 49 of the above-mentioned report of the Secretary-General concerning regular budget financial resources, with a view to arriving at a decision on the funding of the Centres on an established basis, bearing in mind, inter alia, the action taken on this question by the Executive Secretary of ECA (resolution 1982/62).

At the thirty-seventh session, the General Assembly will have before it the report of the Secretary-General called for under resolution 36/178.

Special measures for the social and economic development of Africa in the 1980s

At the thirty-seventh session, the General Assembly will have before it the report of the Secretary-General called for under resolution 36/180.

At the thirty-seventh session, the General Assembly will have before it a note by the Secretary-General transmitting the report of the Special Rapporteur called for under resolution 36/157 (A/37/236).

At the thirty-seventh session, the General Assembly will have before it the report of the Secretary-General called for under resolutions 36/158 and 1982/1 (A/37/178 and Add.1).

At the thirty-seventh session, the General Assembly will have before it the report of the Working Group called for under resolution 36/160 (A/C.3/37/1).

Assistance to displaced persons in Ethiopia

At the thirty-seventh session, the General Assembly will have before it the report of the Secretary-General called for under resolution 36/161.

Measures to be taken against Nazi, Fascist and neo-Fascist activities and all other forms of totalitarian ideologies and practices based on racial intolerance, hatred and terror

At the thirty-seventh session, the General Assembly will have before it the report of the Secretary-General called for under resolution 36/162 (A/37/188 and Add.1).

Draft declaration on the rights of non-citizens

At the thirty-seventh session, the General Assembly will have before it the report of the Working Group established at the thirty-sixth session of the Assembly (A/C.3/36/11).

At the thirty-seventh session, the General Assembly will have before it the relevant chapter of the report of the Economic and Social Council (see also item 93).

Identification of the least developed among the developing countries

At its second regular session of 1982, the Economic and Social Council approved the recommendation made by the Committee for Development Planning at its eighteenth session regarding the inclusion of new countries in the list of the least developed countries and recommended that the General Assembly at its thirty-seventh session should approve the inclusion of Djibouti, Equatorial Guinea, Sao Tome and Principe, Sierra Leone and Togo in the list of the least developed countries (resolution 1982/41).

Convening of an International Conference on Population in 1984

At its resumed second regular session of 1981, the Economic and Social Council, decided to convene an International Conference on Population in 1984.

At its second regular session of 1982, the Economic and Social Council, *inter alia*, decided to accept with gratitude the offer of the Government of Mexico to act as host to the Conference and requested the Secretary-General of the Conference, after consultations with the Government of Mexico, to report to the Council, not later than at its first regular session of 1983, on the dates, site and other arrangements proposed for the Conference; welcomed the offers of the Governments of India and of the Federal Republic of Germany to hold expert group meetings late in 1982 and early in 1983, respectively; recommended that the General Assembly at its thirty-seventh session should approve the necessary expenses for the preparation of the Conference in 1983; requested the Secretary-General of the Conference to report to the Council at its resumed second regular session of 1982 on the status of his efforts to raise extrabudgetary resources for the Conference; decided to schedule the open-ended session of the Population Commission, which would serve as the Preparatory Committee for the Conference, in January 1984, immediately preceded by the twenty-second session of the Population Commission, and to consider the report of the Preparatory Committee at its first regular session of 1984; and invited the regional commissions to consider in 1984 the report of the Preparatory Committee with a view to formulating suggestions and recommendations for further implementation of the World Population Plan of Action at the regional level, and to transmit those suggestions and recommendations to the Conference for its consideration (resolution 1982/42).

Protection against harmful or potentially harmful products

At its second regular session of 1982, the Economic and Social Council decided to transmit to the General Assembly at its thirty-seventh session for consideration the text of a draft resolution entitled "Protection against harmful or potentially harmful products" (decision 1982/180).

Revitalization of the Economic and Social Council

At its second regular session of 1982, the Economic and Social Council, after expressing its full awareness of the urgent need to revitalize the Council in order to enable it, under the authority of the General Assembly, to exercise effectively its functions and powers as set out in the Charter of the United Nations, as well

as in relevant resolutions of the Assembly and the Council, and reaffirming its desire to continue the process of the restructuring of the economic and social sectors of the United Nations system, decided to adopt, without prejudice to future decisions which the Assembly or the Council might wish to take, certain measures concerning its programme and organization of work, as well as documentation and calendar of meetings; endorsed the recommendations of the Secretary-General concerning the revitalization of the Council annexed to its resolution 1982/50 and recommended to the Assembly that it should also endorse the recommendations; and decided to request the President of the Council to continue consultations with Member States on other questions relating to all aspects of the implementation of section II of the annex to Assembly resolution 32/197 and to report all results thereon to the Council in 1983 (resolution 1982/50).

13. Report of the International Court of Justice

At the thirty-seventh session, the report of the International Court of Justice, covering the period from 1 August 1981 to 31 July 1982, will appear as Supplement No. 4 (A/37/4).

14. Report of the International Atomic Energy Agency

At the thirty-seventh session, the General Assembly will have before it the report of the Agency for 1981 (A/37/382). In his statement to the Assembly, the Director-General of the Agency will give an account of any major developments since the date of issue of the report.

15. Elections to fill vacancies in principal organs

(a) Election of five non-permanent members of the Security Council

At the thirty-seventh session, the General Assembly will have to fill the seats being vacated by the following States: Ireland, Japan, Panama, Spain and Uganda. As stipulated in rule 144 of the rules of procedure, a retiring member is not eligible for immediate re-election.

(b) Election of eighteen members of the Economic and Social Council

At the thirty-seventh session, the General Assembly will have to fill the seats being vacated by the following States: Australia, Bahamas, Belgium, Bulgaria, Chile, Ethiopia, Iraq, Italy, Jordan, Libyan Arab Jamahiriya, Malawi, Mexico, Nepal, Nigeria, Thailand, United States of America, Yugoslavia and Zaire. As stipulated in rule 146 of the rules of procedure, a retiring member is eligible for immediate re-election.

16. Elections to fill vacancies in subsidiary organs and other elections

(a) Election of fifteen members of the Industrial Development Board

At the thirty-seventh session, the General Assembly will have to fill the seats being vacated by the following States: Argentina, Austria, Belgium, Central African Republic, Czechoslovakia, Gabon, Indonesia, Italy, Kenya, Madagascar,

Morocco, Sweden, Switzerland, Trinidad and Tobago and Union of Soviet Socialist Republics. Members of the Board are eligible for immediate re-election.

(b) Election of nineteen members of the Governing Council of the United Nations Environment Programme

At the thirty-seventh session, the General Assembly will have to fill the seats being vacated by the following States: Argentina, Bangladesh, Belgium, Bulgaria, Chile, China, Ethiopia, France, Gabon, Indonesia, Mauritania, New Zealand, Peru, Saudi Arabia, Sierra Leone, Sudan, Sweden, United Arab Emirates and Yugoslavia. Members of the Governing Council are eligible for immediate re-election.

(c) Election of twelve members of the World Food Council

At the thirty-seventh session, the General Assembly will have to fill the seats being vacated by the following States: Australia, Bangladesh, Barbados, Germany, Federal Republic of, Ghana, Honduras, Nicaragua, Philippines, Romania, Senegal, Sudan and Union of Soviet Socialist Republics. As stipulated in resolution 3348 (XXIX), paragraph 8, members of the Council are eligible for immediate re-election.

(d) Election of seven members of the Committee for Programme and Co-ordination

At the thirty-seventh session, the General Assembly will have to fill the seats being vacated by the following States: Argentina, Costa Rica, France, Sudan, Union of Soviet Socialist Republics, United Republic of Tanzania and United States of America. Members of the Committee are eligible for immediate re-election. The Assembly will have before it a note by the Secretary-General (A/37/229).

(e) Election of the members of the Board of Governors of the United Nations Special Fund for Land-locked Developing Countries

At the thirty-seventh session, the General Assembly will have to elect the entire membership of the Board of Governors. As stipulated in article 4, paragraph 2, of the statute of the Special Fund, retiring members of the Board of Governors are eligible for re-election.

(f) Election of seventeen members of the United Nations Commission on International Trade Law

At the thirty-seventh session, the General Assembly will have to fill the seats being vacated by the following States: Australia, Austria, Burundi, Chile, Colombia, Egypt, Finland, France, German Democratic Republic, Ghana, Indonesia, Japan, Nigeria, Singapore, Union of Soviet Socialist Republics, United Kingdom of Great Britain and Northern Ireland and United Republic of Tanzania. As stipulated in resolution 2205 (XXI), section II, paragraph 5, members of the Commission are eligible for immediate re-election.

(g) Election of the United Nations High Commissioner for Refugees

At the thirty-seventh session, the General Assembly will have before it a note by the Secretary-General.

17. Appointments to fill vacancies in subsidiary organs and other appointments

(a) Appointment of five members of the Advisory Committee on Administrative and Budgetary Questions

At the thirty-seventh session, the General Assembly will have to fill the vacancies that will arise upon the expiry of the terms of office of Mr. Abraszewski, Mr. Fall, Mr. Kemal, Mr. Mselle and Mr. Thomas. The Assembly will have before it a note by the Secretary-General (A/37/181).

(b) Appointment of six members of the Committee on Contributions

At the resumed seventh emergency special session, in June 1982, the General Assembly reaffirmed once again its conviction that the question of Palestine was the core of the Arab-Israeli conflict and that no comprehensive, just and lasting peace in the region would be achieved without the full exercise by the Palestinian people of its inalienable national rights and further reaffirmed that a just and comprehensive settlement of the situation in the Middle East could not be achieved without the participation on an equal footing of all the parties to the conflict, including the Palestine Liberation Organization as the representative of the Palestinian people; reaffirmed the fundamental principle of the inadmissibility of the acquisition of territory by force and demanded that all Member States and other parties should observe strict respect for Lebanon's sovereignty, territorial integrity, unity and political independence within its internationally recognized boundaries; decided to support fully the provisions of Security Council resolutions 508 (1982) and 509 (1982) in which the Council, *inter alia*, had demanded that Israel should withdraw all its military forces forthwith and unconditionally to the internationally recognized boundaries of Lebanon, and all parties to the conflict should cease immediately and simultaneously all military activities within Lebanon and across the Lebanese-Israeli border; condemned Israel for its non-compliance with resolutions 508 (1982) and 509 (1982) and demanded that Israel should comply with all the above provisions no later than 0600 hours, (Beirut time) on Sunday, 27 June 1982; called upon the Security Council to authorize the Secretary-General to undertake necessary endeavours and practical steps to implement the provisions of resolutions 508 (1982), 509 (1982) and 512 (1982) and urged the Council, in the event of continued failure by Israel to comply with the demands contained in resolution 508 (1982) and 509 (1982), to meet in order to consider practical ways and means in accordance with the Charter of the United Nations; called upon all States and international agencies and organizations to continue to provide the most extensive humanitarian aid possible to the victims of the Israeli invasion of Lebanon and requested the Secretary-General to delegate a high-level commission to investigate and assess the extent of the loss of human life and material damage and to report, as soon as possible, on the result of this investigation to the Assembly and the Council; and decided to adjourn the seventh emergency special session temporarily and to resume it upon request from Member States (resolution ES-7/5).

At its resumed seventh emergency special session, in August 1982, the General Assembly reiterated its affirmation of the fundamental principle of the inadmissibility of the acquisition of territory by force and called for the free exercise in Palestine of the inalienable rights of the Palestinian people to self-determination without external interference and to national independence; reaffirmed its rejection of all policies and plans aiming at the resettlement of

the Palestinians outside their homeland and demanded that Israel should respect and carry out the provisions of the previous resolutions of the Assembly relating to the occupied Palestinian and other Arab territories, including Jerusalem, as well as the provisions of Security Council resolution 465 (1980); demanded also that Israel should carry out the provisions of Council resolutions 509 (1982), 511 (1982), 512 (1982), 513 (1982), 515 (1982), 516 (1982), 517 (1982) and 518 (1982); condemned Israel for its non-compliance with resolutions of the Council, in defiance of Article 25 of the Charter, and urged once again the Council, in the event of continued failure by Israel to comply with the demands contained in its resolutions, to meet in order to consider practical ways and means in accordance with the relevant provisions of the Charter; requested once again the Secretary-General to delegate a high-level commission to investigate and make an up-to-date assessment of the extent of loss of human life and material damage and to report, as soon as possible, on the result of this investigation to the Assembly and the Council; called once again upon the Secretary-General to initiate contacts with all the parties to the Arab-Israeli conflict in the Middle East, including the Palestine Liberation Organization, the representative of the Palestinian people, with a view to convening an international conference, under the auspices of the United Nations, to find concrete ways and means of achieving a comprehensive, just and lasting solution, conducive to peace in conformity with the principles of the Charter and relevant resolutions; and decided to adjourn the seventh emergency session temporarily and to resume it upon request from Member States (resolution ES-7/6). The Assembly also decided to convene the International Conference on the Question of Palestine at the headquarters of the United Nations Educational, Scientific and Cultural Organization, in Paris, from 16 to 27 August 1983 (resolution ES-7/7) and decided to commemorate 4 June of each year as the International Day of Innocent Children Victims of Aggression (resolution ES-7/8).

At its resumed seventh emergency special session, in September 1982, the General Assembly condemned the criminal massacre of Palestinian and other civilians in Beirut on 17 September 1982 and urged the Security Council to investigate, through the means available to it, the circumstances and extent of that massacre and to make public the report of its findings as soon as possible; decided to support fully the provisions of Council resolutions 508 (1982) and 509 (1982) and demanded that all Member States and other parties should observe strict respect for the sovereignty, territorial integrity, unity and political independence of Lebanon within its internationally recognized boundaries; reaffirmed the fundamental principle of inadmissibility of the acquisition of territory by force and urged the Council, in the event of continued failure by Israel to comply with the demands contained in resolutions 508 (1982) and 509 (1982) and the present resolution, to meet in order to consider practical ways and means in accordance with the Charter of the United Nations; requested the Secretary-General to prepare a photographic exhibit of the massacre of 17 September 1982 and to display it in the United Nations Visitors' hall; and decided to adjourn the seventh emergency special session temporarily and to authorize the President of the latest regular session of the Assembly to resume its meetings upon request from Member States (resolution ES-7/9).

Following the outbreak of hostilities in Beirut and southern Lebanon, the Security Council, on 5 June 1982, called upon all the parties to the conflict to cease immediately and simultaneously all military activities within Lebanon and across the Lebanese-Israeli border (resolution 508 (1982)). The report of the Secretary-General called for under resolution 508 (1982) was circulated on 6 June 1982 (S/15174).

On 6 June 1982, the Security Council demanded that Israel should withdraw all its military forces forthwith and unconditionally to the internationally recognized boundaries of Lebanon and demanded that all parties should observe strictly the terms of paragraph 1 of resolution 508 (1982), which called on them to cease immediately and simultaneously all military activities within Lebanon and across the Lebanese-Israeli border (resolution 509 (1982)). A report of the Secretary-General relating to resolution 509 (1982) was circulated on 8 June 1982 (S/15178).

On 18 June, the Security Council decided, as an interim measure, to extend the mandate of the United Nations Interim Force in Lebanon (UNIFIL) for a period of two months, that is, until 19 August 1982 (resolution 511 (1982)).

On 19 June, the Security Council called upon all the parties to the conflict to respect the rights of the civilian populations, to refrain from all acts of violence against those populations and to take all appropriate measures to alleviate the suffering caused by the conflict, particularly by facilitating the dispatch and distribution of aid provided by United Nations agencies and by non-governmental organizations, in particular the International Committee of the Red Cross (ICRC); appealed to Member States to continue to provide the most extensive humanitarian aid possible; and stressed the particular humanitarian responsibilities of the United Nations and its agencies, including the United Nations Relief and Works Agency for Palestine Refugees in the Near East (UNRWA), towards civilian populations and called upon all the parties to the conflict not to hamper the exercise of those responsibilities and to assist in humanitarian efforts (resolution 512 (1982)). An interim report of the Secretary-General in pursuance of resolution 512 (1982) was issued on 30 June 1982 (S/15267).

On 4 July, the Security Council called for respect for the rights of the civilian populations without any discrimination and repudiated all acts of violence against those populations and called further for the restoration of the normal supply of vital facilities such as water, electricity, food and medical provisions,

particularly in Beirut (resolution 513 (1982)). On 29 July, the Council demanded that the Government of Israel should lift immediately the blockade of the city of Beirut in order to permit the dispatch of supplies to meet the urgent needs of the civilian population and allow the distribution of aid provided by United Nations agencies and by non-governmental organizations, particularly ICRC (resolution 515 (1982)). On 1 August, the Council confirmed its previous resolutions and demanded an immediate cease-fire and a cessation of all military activities within Lebanon and across the Lebanese-Israeli border and authorized the Secretary-General to deploy immediately, on the request of the Government of Lebanon, United Nations observers to monitor the situation in and around Beirut (resolution 516 (1982)). Reports of the Secretary-General in pursuance of resolution 516 (1982) were issued on 1 and 3 August (S/15334) and Add.1).

On 4 August, the Security Council reconfirmed its resolutions 508 (1982), 509 (1982), 512 (1982), 513 (1982), 515 (1982) and 516 (1982); confirmed once again its demand for an immediate cease-fire and withdrawal of Israeli forces from Lebanon; censured Israel for its failure to comply with the above resolutions; called for the prompt return of Israeli troops which had moved forward subsequent to 1325 EDT on 1 August; took note of the decision of the Palestine Liberation Organization to move the Palestinian armed forces from Beirut; and authorized the Secretary-General, as an immediate step, to increase the number of United Nations observers in and around Beirut (resolution 517 (1982)). The report of the Secretary-General called for under resolution 517 (1982) was issued on 5 August 1982 (S/15345 and Add.1 and 2).

On 12 August, the Security Council demanded that Israel and all parties to the conflict should observe strictly the terms of the resolutions of the Security Council relevant to the immediate cessation of all military activities within Lebanon, and particularly in and around Beirut; demanded the immediate lifting of all restrictions on the city of Beirut in order to permit the free entry of supplies to meet the urgent needs of the civilian population in Beirut; requested the United Nations observers in and in the vicinity of Beirut to report on the situation; and demanded that Israel should co-operate fully in the effort to secure the effective deployment of the United Nations observers, as requested by the Government of Lebanon, and in such a manner as to ensure their safety (resolution 518 (1982)). A report of the Secretary-General in pursuance of resolution 518 (1982) was issued on 13 August (S/15362). Also on 13 August, a further report of the Secretary-General on UNIFIL was issued (S/15357). On 17 August, the Council decided to prolong the present mandate of UNIFIL for a further interim period of two months and decided to consider the situation fully and in all its aspects before 19 October (resolution 519 (1982)).

A report of the Secretary-General on the situation in the Beirut area was issued on 2 September (S/15382).

At its thirty-fifth session, in 1980, the General Assembly adopted the Declaration of the 1980s as the Second Disarmament Decade (resolution 35/46).

At its twelfth special session, the General Assembly focused its attention on the consideration of initiatives and proposals of Member States submitted under the item and decided to inscribe those initiatives and proposals in a list for subsequent consideration (A/S-12/32, annex III).

(c) United Nations programme of fellowships on disarmament: report of the Secretary-General

At its thirty-sixth session, the General Assembly, on the basis of resolution 36/92 A, requested the Secretary-General to submit to the Assembly at its twelfth special session a report assessing the programme of fellowships on disarmament since its inception (resolution 36/92 A).

At its twelfth special session, the General Assembly considered the report of the Secretary-General and agreed on a text contained in the Concluding Document (A/S-12/32, annex IV) under which the Assembly decided, *inter alia*, to endorse the report of the Secretary-General on the programme (A/S-12/8 and Corr.1), to continue the programme and to increase the number of fellowships from 20 to 25 from 1983 onwards; and requested the Secretary-General to submit to the Assembly at its thirty-seventh session the financial implications of awarding 25 fellowships for inclusion in the regular budget of the United Nations.

136. Relationship between disarmament and development

In a letter dated 20 August 1982 (A/37/195), Sweden requested the inclusion of the above-mentioned supplementary item in the agenda of the thirty-seventh session.

On 24 September 1982 (see A/37/PV.4), the General Assembly decided, on the recommendation of the General Committee (A/37/250), to include this item in the agenda and to allocate it to the First Committee on the understanding that the development aspects of the question would be brought to the attention of the Second Committee in connection with its consideration of item 71 (Development and international economic co-operation).

137. Implementation of the collective security provisions of the Charter of the United Nations for the maintenance of international peace and security

In a letter dated 30 August 1982 (A/37/241), Sierra Leone requested the inclusion of the above-mentioned additional item in the agenda of the thirty-seventh session.

On 24 September 1982 (see A/37/PV.4), the General Assembly decided, on the recommendation of the General Committee (A/37/250), to include this item in the agenda and to allocate it to the First Committee.

138. Immediate cessation and prohibition of nuclear-weapon tests

In a letter dated 1 October 1982 (A/37/243), the Union of Soviet Socialist Republics requested the inclusion of the above-mentioned additional item in the agenda of the thirty-seventh session.

On 8 October 1982 (see A/37/PV.24), the General Assembly decided, on the recommendation of the General Committee (A/37/250/Add.1), to include this item in the agenda and to allocate it to the First Committee.

139. Intensification of efforts to remove the threat of nuclear war and ensure the safe development of nuclear energy

In a letter dated 1 October 1982 (A/37/242), the Union of Soviet Socialist Republics requested the inclusion of the above-mentioned additional item in the agenda of the thirty-seventh session.
