## ANNEX

## Note dated 21 April 1988 from the Minister for Foreign Affairs of Honduras addressed to the Minister for Foreign Affairs of Nicaragua

I am writing with reference to your note of 20 April 1988, in which our Government strongly protests against the fact that the Government of Hong ras has authorized the provision to Nicaraguan groups of the humanitarian aid ar roved by the United States Congress with the affirmative vote of representatives and senators belonging both to the Republican Party and to the Democratic Party.

I consider that your protest is totally unfounded, in view of the fact that the aid in question was approved, with the concurrence of the Government of Nicaragua, once a provisional cease-fire had been agreed upon, precisely in order to facilitate the Esquipulas II Agreement and the Sapoa negotiations, which were still under way.

What the Government of Honduras has permitted is that it should be made possible for the aid in question, under the supervision of the Agency for International Development, the Catholic Church and the private firm Price Waterhouse, to reach those groups of Nicaraguans who are in the country and who do not enjoy the protection of the Office of the United Nations High Commissioner for Refugees (UNHCR).

With regard to the action initiated by the Government of Nicaragua against the

Government of Honduras before the International Court of Justice, you are fully aware of my country's consistent position from the outset of the case, which is, in brief, that any negotiating forum, whether it be called Contadora or Esquipulas, is incompatible with the legal action brought before the Court. It would be closer to the truth to state that it is the obstinate attitude of the Government of Nicaragua in not desisting from the claim, even in the face of the concrete protests made by the Government of Honduras with a view to resolving the frontier questions, that has continually sabotaged the various efforts to arrive at a regional agreement. The purpose of Honduras' request for the setting of a date for the next hearing was to avoid having Nicaragua continue trying to manipulate this claim before the Court in order to achieve its own political ends. It is, then, on your Government that the advance or stagnation of the Guatemala Procedure and the San José Declaration depends.

The text of this note also will be transmitted to the International Court of Justice.
