Subject: STAFF RULES

1. In implementation of General Assembly resolutions 1658 (XVI) of 28 November 1961 and 1730 (XVI) of 20 December 1961, chapter III of the Staff Rules has been revised, with effect from 1 January 1962, to incorporate the amendments of Staff Regulations 3.2, 3.3 and 3.4, and of paragraphs 1, 3, 4, 5 and 9 of Annex I to the Regulations.

2. The Staff Rules affected by these changes are: 103.16, Pensionable Remuneration, which has been amended by substituting, in line 7 of its paragraph (c), "1962" for "1956" and by revising appendix B to the Rules to show the new pensionable remuneration established under that Rule; and 103.20, Education Grant, paragraph (d) of which has been amended to reflect the new formula for the payment of the grant.

3. Rule 103.11, Special Post Allowance, is amended to define the modified conditions under which such an allowance may be authorized.

4. Staff Rule 103.22, Assignment Allowance, is amended to reflect the policy recently agreed upon within the United Nations common system of salaries and allowances.

5. Rule 103.24, Definition of Dependency, is amended by deleting in line 8 of its paragraph (b) the words "or legal separation".

6. Rule 104.13, Permanent and Regular Appointments, paragraph (d) and Rule 104.14, Appointment and Promotion Board, paragraph (a) (i) are amended by the insertion of the words "the Special Fund" and "the Managing Director of the Special Fund" where appropriate. A similar change is made in Rule 109.1, paragraph (c) (ii) (b).

7. Rule 107.1, Official Travel of Staff Members, is amended to reflect the agreed policy within the United Nations common system that travel to visit dependants may be authorized as an alternative to official travel of dependants.

8. Rule 107.5, Eligible Dependants, is amended by the addition of paragraph (c) providing for the separate repatriation of a staff member's former spouse.

9. The following corrections are also made in the existing texts of the Regulations and Rules: In Rule 107.5, Eligible Dependants, paragraph (a) and Rule 109.5, Repatriation Grant, paragraph (g), a reference to the dependency allowances now in force is substituted for the reference to the former dependency credits. The text of Annex IV, paragraph 2 (b) to the Staff Regulations, which is incomplete, has also been corrected.

10. On page 3 of the Staff Rules, the first paragraph listing the resolutions by which the General Assembly adopted or amended the Staff Regulations has been brought up to date by the addition of resolutions adopted at the thirteenth and sixteenth sessions.
