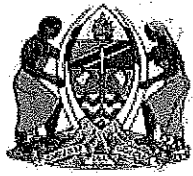

Desirous of promoting mutual understanding and strengthening the friendship and cooperation between the two countries;


