

Summary statement by the Secretary-General of matters of which the Security Council is seized and of the stage reached in their consideration

- 1. Pursuant to rule 11 of the provisional rules of procedure of the Security Council and in accordance with the note by the President dated 30 August 2017 (S/2017/507), the Secretary-General is submitting the following summary statement.
- 2. The present addendum contains a full, updated list of items of which the Security Council is seized. As it is the first addendum issued in March 2019, it reflects the outcome of the annual review of the summary statement by the Security Council pursuant to the procedure set out in document S/2017/507.
