Rule 103 of the rules of procedure of the General Assembly provides that committees other than Main Committees shall elect a Chair, one or more Vice-Chairs and a Rapporteur. These officers shall be elected on the basis of equitable geographical distribution, experience and personal competence. The Bureau of the Committee on Conferences comprises a Chair, three Vice-Chairs and a Rapporteur.

At its organizational session for 1989, held on 1 March 1989, the Committee agreed in principle that thenceforth the chairmanship would rotate annually among the regional groups. At its organizational session for 2018 (551st meeting), held on 23 April 2018, the Committee agreed in principle that the Chair would undertake informal consultations with a view to determining the composition of the Bureau for





2019 and that the Chair and the other members of the Bureau would continue in their capacities until the 2019 Bureau had been elected.

#### 4. Organization of work for 2019

At its organizational session for 2018, the Committee adopted the agenda for its substantive session of 2018 and requested the Secretariat to submit to it at its organizational session for 2019 a provisional agenda for its substantive session of 2019.

### (a) Intersessional departures and related matters

The Committee will consider requests for intersessional departures in accordance with paragraph 4 of General Assembly resolution 46/190, in which the Assembly took note of the guidelines adopted by the Committee (A/46/32, para. 77), and in accordance with the decisions taken by the Committee at its 373rd meeting, on 26 August 1994, at its 379th meeting, on 23 March 1995, and at its substantive session of 1995.

In accordance with legislative mandates, the Department for General Assembly and Conference Management will administer the programme of meetings as stated in the report of the Secretary-General on improving the performance of the Department (A/57/289, para. 15).

Moreover, meetings of the Committee may be required under the terms of paragraph 6 of General Assembly resolution 35/10 A, by which the Assembly decided that all proposals affecting the schedule of conferences and meetings made at sessions of the Assembly should be reviewed by the Committee when administrative implications were being considered under the requirements of rule 153 of the rules of procedure of the Assembly.

## (b) Provisional calendar of conferences and meetings in the economic, social and related fields for 2020 and 2021

In its decision 1988/103, the Economic and Social Council decided to invite the Committee to review the draft biennial calendar of conferences and meetings of the Council and to submit, as appropriate, its recommendations thereon to the Council.

The provisional calendar for the biennium 2020-2021 will be available for consideration by the Committee before the management segment, of the Council on 23 and 24 July 2019. The Committee may wish to review the provisional calendar during its organizational session and to submit its observations and recommendations to the Council for consideration at its substantive session of 2019. In this context, the Committee's attention is drawn to paragraph 10 of General Assembly resolution 73/270 on the pattern of conferences.

#### 5. Programme of work for 2019

The information requested by the General Assembly will be presented in a consolidated report of the Secretary-General on the pattern of conferences. Statistical and other relevant data will be presented as information supplementary to the report.
