Curricula vitae of the candidates for election to the Permanent Forum on Indigenous Issues*

Vital Bambanze (Burundi)

[Original: French]

Mr. Bambanze is a member of the Batwa community of Burundi. He was born on 21 July 1972 in Shore, Gitobe Commune, in Kirundo Province.

He is a former member of the Burundi Senate (2010–2015), where he represented the Batwa people, and a founding member and current Director of Unissons-nous pour la Promotion des Batwa (Unite for the Promotion of the Batwa people), an organization established in 1999 by the Batwa, for the Batwa.

He is also currently a member of the National Committee on Reducing Emissions from Forest Degradation and Conserving Carbon Stock (REDD+) established by Presidential Decree No. 100/233 of 25 November 2016.

Mr. Bambanze has held various positions both regionally and internationally as a representative of indigenous peoples, including:

From 2011 to 2012: Member and Chair of the United Nations Expert Mechanism on the Rights of Indigenous Peoples;

From 2006 to 2016: Chair of the Indigenous Peoples of Africa Coordinating Committee (IPACC). A participant in the sessions of the Permanent Forum on Indigenous Issues since its establishment (2002–2017);

From 2003 to 2006: Adviser to the World Bank on indigenous peoples in Africa, in connection with the Bank's small grants programme for indigenous organizations.

With respect to capacity building, Mr. Bambanze has been involved in training relating to land issues and was subsequently appointed by Presidential Decree to the Commission Nationale Terres et Autres Biens (National Commission on Land and Other Assets) (CNTB) which has been tasked with compensating people whose property and land were seized in the context of the upheavals which affected Burundi between independence and 2007.

His knowledge of indigenous issues was reinforced through the award of a fellowship through the Indigenous Fellowship Programme of the Office of the United Nations High Commissioner for Human Rights in Geneva (April 2003–October 2003).

He has also participated in sessions of the Working Group on Indigenous Populations and of the Working Group on the draft United Nations declaration on the rights of indigenous peoples.

Mr. Bambanze has been a member and Chair of the Expert Mechanism on the Rights of Indigenous Peoples and has taken part, and continues to take part as needed, in the sessions of the African Commission on Human and Peoples' Rights. He has also participated in a number of sessions of the Conference of the Parties to the United Nations Framework Convention on Climate Change.

Mr. Bambanze has published two works:

Alexis Nsabiyera (Burundi)

[Original: French]

Mr. Nsabiyera was born in 1989 in Runyunza, Kirundo Commune, Kirundo Province.

He is the coordinator of the Union for the Development of the Batwa people of Burundi (UDBB).

He attended primary school and community middle school in Rukuramigabo, followed by Lycée Kirundo and Lycée Jabe, graduating from the latter with a diploma in general humanities and a State diploma in 2015.

Since 2010, he has been involved in outreach efforts to promote school attendance by Batwa children. In 2018, he also led an outreach campaign to encourage young people in the Batwa community to enlist in national defence and security forces.

Mr. Nsabiyera oversaw training on combating malaria and tuberculosis for the Batwa people in Ruyigi Province and rural Bujumbura Province in 2018 and in Kirundo Province in 2017.

Mr. Nsabiyera served as a national observer for the 2018 referendum. Since the manipulation that took place in 2018, he has been very active in calling for compliance with the quota set for Batwa military recruits. He led outreach campaigns in Batwa communities to increase their participation in the 2015 presidential and legislative elections in Burundi.

In 2018, he attended a training course for lawyers and other civil society actors in Bujumbura on the protection of victims, witnesses and other persons at risk. In 2017, he attended a training course on human rights and peaceful conflict resolution in Ngozi Province.

Jean Baptiste Sindayigaya (Burundi)

[Original: French]

Born on 25 December 1982 in Kirundo Province, Mr. Sindayigaya is one of the leaders of the indigenous Batwa community in Burundi. He represents the Batwa people in the Commission Nationale Terres et Autres Biens (National Commission on Land and Other Assets) (CNTB). He is a founding member, director and legal representative of Union des Jeunes Autochtones pour le Développement Communautaire (UJEDECO), a non-governmental organization established in 2009 by indigenous young people to defend the interests of the Batwa. He has promoted legal marriage in the Batwa community in Burundi since 2007.

Mr. Sindayigaya is a contact point for the Global Fund to Fight AIDS, Tuberculosis and Malaria. In 2014, he was a member of a national committee tasked with drafting a concept note to request a grant from the Global Fund for the period 2018–2020.

He has served in various capacities in Burundi. He has been a member of CNTB since 2012. From June 2012 to February 2013, he was the Assistant to the CNTB Provincial Delegation in Ngozi. From February 2013 to April 2014, he was the Assistant to the CNTB Provincial Delegation in Makamba. From April 2014 to 2016, he was the Head of the CNTB Provincial Delegation in Bujumbura. From May 2016 to 2018, he was the Assistant to the Provincial Delegation in Muyinga, Cankuzo, Kayanza and Muramvya. He is a founding member and director of UJEDECO. In 2003, he was appointed Commissioner for the dissemination of legal texts relating to human rights and the rights of citizens. In 2012, he was a member of the technical committee established in connection with national civil society consultations in collaboration with the Government of Burundi.

Tarcila Rivera Zea (Peru)

[Original: Spanish]

Ms. Rivera Zea is one of the most well-known indigenous activists in Peru and around the world. For more than 30 years she has defended indigenous rights through her organization, Chirapaq, and through the networks and institutions to which it belongs.

She has received awards and honours from the United Nations Children's Fund (UNICEF), the Ford Foundation, the Fundación Fuego Sagrado and the Peruvian Ministry of Culture for her distinguished career and valuable contribution to the promotion and defence of indigenous cultures and peoples.

She has been appointed a member of the United Nations Permanent Forum on Indigenous Issues for the period 2017–2019.

Her life story: from the mountains of Peru to the United Nations

Born in Ayacucho, one of the poorest regions of Peru, Ms. Rivera Zea came to the country's capital at the age of 10 and worked as a domestic worker, experiencing first-hand the discrimination and deracination facing indigenous migrants.

In the 1970s, after completing her studies in the Vatican and in Argentina, she worked for the Ministry of Culture as an archives and library specialist. In the 1980s, she worked as a journalist for the magazine *Pueblo Indio*, for which she collected testimonies by indigenous women raped during the internal armed conflict. In recognition of her work, she was invited to attend specialization courses on human rights at the Institute of Social Studies (ISS) in The Hague, the Netherlands, and at Equitas, an international centre for human rights education in Charlottetown, Canada.

Since 1987, she has participated in the drafting of the United Nations Declaration on the Rights of Indigenous Peoples and in the establishment of the United Nations Permanent Forum on Indigenous Issues. She has also contributed to the creation of policies aimed at empowering and increasing the visibility of indigenous women through the United Nations World Conferences on Women and other forums.

In 2012, she was invited to become a member of the UN-Women Global Civil Society Advisory Group.

Chirapaq and its international role

She is the founder and executive director of Chirapaq Centre for Indigenous Cultures of Peru, an association that promotes the affirmation of cultural identity and provides leadership training for indigenous women and young people, many of whom now hold public offices in their communities and local governments. Chirapaq has had consultative status with the United Nations Economic and Social Council since 2014.

Ms. Rivera Zea is also the founder of the Continental Network of Indigenous Women of the Americas (ECMIA) and the International Indigenous Women's Forum (FIMI), which promote leadership and political participation by millions of indigenous women around the globe.
