Proposed amendments to the strategic framework and programme of work for the biennium 2018-2019

Summary

This document presents proposed amendments to the strategic framework and programme of work of the Economic and Social Commission for Western Asia (ESCWA) for the biennium 2018-2019. These amendments are based on the new mandates that emanated from the seventy-second session of the United Nations General Assembly, and on the global and regional needs and challenges that have emerged since the Commission adopted the revised draft strategic framework at its twenty-ninth session held in Doha in December 2016, and the proposed programme of work for 2018-2019 at the third meeting of the Executive Committee held in Rabat, in May 2017.

The Commission is invited to consider the proposed changes with a view to endorsing them for incorporation into the strategic framework and the programme of work for the biennium 2018-2019.

Introduction

1. This document presents amendments proposed by the secretariat of the Economic and Social Commission for Western Asia (ESCWA) to the strategic framework and the programme of work for the biennium 2018-2019. These amendments are based on the new mandates that emanated from the seventy-second session of the United Nations General Assembly, and on the global and regional needs and challenges that have emerged since the Commission adopted the revised draft strategic framework at its twenty-ninth session held in Doha in December 2016, and the proposed programme of work for 2018-2019 at the third meeting of the Executive Committee held in Rabat, in May 2017.
2. The secretariat is proposing these changes to better align the strategic framework and programme of work for the biennium 2018-2019 with the 2030 Agenda for Sustainable Development, and with ESCWA resolution 322 (EC.2) of 16 December 2015 on the Strategy and plan of action on the 2030 Agenda for Sustainable Development. The changes are also aimed at making optimal use of the resources available while enhancing the quality, relevance and impact of services provided to member States.
3. The Commission is invited to consider the proposed amendments with a view to endorsing them for incorporation into the strategic framework and programme of work for the biennium 2018-2019.

I. PROPOSED AMENDMENTS TO THE STRATEGIC FRAMEWORK FOR THE BIENNIUM 2018-2019

4. The amendments proposed by the secretariat to the strategic framework are intended to allow for more complete reporting of the activities implemented by the ESCWA Unit for the 2030 Agenda, created in the framework of the ESCWA strategy and plan of action on the Agenda adopted by the Commission in resolution 322 (EC.2) of 16 December 2015.
5. The below table provides the proposed amendments, all made under the strategic framework narrative for subprogramme 2 on social development, in the framework of which the Unit for the 2030 Agenda was established. One proposed expected accomplishment is added, labelled (d), along with three indicators of achievement. The proposed additions are featured in bold in the table.
