JOINT COMMUNIQUE OF THE GOVERNMENT OF THE REPUBLIC OF SURINAME AND THE GOVERNMENT OF THE PEOPLE'S DEMOCRATIC REPUBLIC OF ALGERIA ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS

Desiring to develop and to reaffirm the relations of friendship and cooperation between Suriname and Algeria, the Government of the Republic of Suriname and the Government of the People's Democratic Republic of Algeria have decided to establish diplomatic relations at the level of Ambassadors with immediate effect.

Both parties commit themselves to develop the relations between the two States on the basis of the International Legal Principles as embodied in the Charter of the United Nations, the authentic principles of the Non-Aligned Movement and in conformity of the Vienna Convention on diplomatic relations of April 18, 1961.
