PETITION FROM THE "UNION DES POPULATIONS DU CAMEROUN" CONCERNING THE CAMEROONS UNDER FRENCH ADMINISTRATION

Sir.

I have pleasure in acknowledging receipt of your letter T/PET.5/119 of 13 October and in thanking you for your promptness in replying to my letter of 4 October.

I wish to confirm that it is the desire of the <u>Union des Populations</u> <u>du Cameroun</u> to send a delegation to make an oral statement, or several oral statements if possible, on the points raised in my letter of 4 October and on any other points which the peoples of the Cameroons may wish to submit to the seventh session of the United Nations General Assembly. It is understood that the statement will refer solely to questions connected with the international trusteeship system, which includes the Cameroons under French administration.

As regards my petition of 14 August 1952, concerning, among other things, the Administering Authority's interference with private correspondence, I have to inform you that after a strong protest from our office to the Director of Posts and Telecommunications and after the public had been informed through the press of the failure to deliver your letter of 22 August, a scaled envelope with the United Nations heading, postmarked 22 August by the post office of origin and with no postmark of the post office of destination was found in our post office box on 11 October.

I requested a process-server to make the necessary affidavit and I shall transmit to you a supplementary report in confirmation of my protests of 14 Augustand 4 October 1952.
