

JOINT COMMUNIQUÉ

on the establishment of diplomatic relations between the Republic of Moldova and the Republic of Cameroon

The Republic of Moldova and the Republic of Cameroon,

Confirming the mutual recognition of the principles of equality among States, independence, sovereignty, territorial integrity and non-interference in their internal affairs.

With the purpose to promote mutual understanding, strengthen the existing friendship between the two countries and promote bilateral cooperation between the two States in political, economic, social and cultural fields.

Reaffirming their commitment to the principles and purposes of the Charter of the United Nations and international law.

Acting in accordance with the provisions of the Vienna Convention on Diplomatic Relations of 18 April 1961 and the Vienna Convention on the Consular Relations of 24 April 1963,

Have agreed to establish diplomatic relations between the two countries from the date of signature of this Joint communiqué.

In witness whereof, the undersigned representatives, duly authorized by their respective Governments, have signed this Joint communiqué in two originals in Romanian, French and English languages, all texts being equally authentic.



COMMUNIQUÉ CONJOINT

Portant établissement des relations diplomatiques entre la République de Moldova et la République du Cameroun

La République de Moldova et la République du Cameroun,

Confirmant la reconnaissance réciproque des principes d'égalité entre les Etats, d'indépendance, de souveraineté, d'intégrité territoriale et de non ingérence dans les affaires intérieures.

Désireuses de promouvoir la compréhension mutuelle, de renforcer les relations d'amitié existant entre les deux Etats et de promouvoir la coopération bilatérale sur les plans politique, économique, social et culturel.

Réaffirmant leur adhésion aux principes et aux buts de la Charte des Nations Unies et au droit international.

Agissant en conformité avec les dispositions de la Convention de Vienne sur les Relations Diplomatiques du 18 avril 1961 et de la Convention de Vienne sur les Relations Consulaires du 24 avril 1963.
